

Quarterly Issues 2014

1st Quarter

Jan 1 Reported on the growing relationship between the nation of Israel and the Christian Evangelical community. This is pertinent to our audience in that Israel is now experiencing a growing Christian population, partly due to the rise in persecution in the middle east. Israel has become a place of refuge, and the two communities are doing well together.

Jan 2 Carried the Citizen Link broadcast at 420 for 2 minutes. It discusses public policy changes and informs the listeners how to become involved.

Jan 3 Updated audience on first amendment issues and the How Biola University and Grace Seminary were granted exemption from Obamacare at 410 for 4minutes. We reported on the U.S. Court decision and discussed the two cases appearing before the Supreme Court in 2014.

Jan 6 Interviewed Dr. Funsch with the school who was denied by the Veterans Hospital in Augusta to sing Christmas Carols. We spoke for 8 minutes at 505pm about the constitutional rights of the school, the students and how those rights were violated by an errant policy.

Jan 7 At 405pm we reported on the shift in American culture towards pro-life. We cited the new analysis from the Guttmacher Institute that showed how more abortion restrictions were passed over the last two years than in the previous 10 combined. As more people are seeing the unborn baby as being a human baby, it is having a greater influence on legislation on the state level.

Jan 8 Discussed the newest study by a team of political scientists at the University of Notre Dame at 420 for 4 minutes. The research explored the power of political messages in popular films and found they possess the ability to change attitudes, especially on issues that are unframed by the media. It exposes that people are not prepared to encounter and evaluate political messages in films.

Jan 9 Reported on the South Carolina state representative, Bill Taylor's bill to call for article V Convention of the states, or constitutional convention at 405 for 3 minutes. We explained the provision in the constitution the founders placed to protect the states from federal overreach.

Jan 10 Discussed New Year's resolutions, diets and weight loss. We talked for 3 minutes at 420pm about various diets, but emphasized tried and true methods, encouraging those who are trying to lose weight.

Jan 13 Updated listeners on the topic of human trafficking at 410pm for 4 minutes. We discussed an open case in Egypt with sources from the Association for Victims of Abductions and Enforced Disappearances, vulnerabilities in refugee camps in Syria, and even the high rate in Myrtle Beach, South Carolina. We made awareness and solutions the focus of the report.

Jan 14 We reported on some new changes for the upcoming tax season and issued a warning from the IRS about identity theft and tax return theft. For 2 minutes at 510pm we gave a bullet list of ways to avoid theft.

Jan 15 At 510pm for 10 minutes, we interviewed a spokesman from the nursery about caring for plants, bushes and lawns during this cold snap. He made several recommendations, and answered questions from callers.

Jan 16 Promoted our event calendar, read PSA's and explained to listeners how to access our free public service announcements available on our website and our radio stations.

Jan 17 Interviewed World Magazine at 505 for 10minutes. They offered analysis of the week's biggest news story.

Jan20 Updated listeners on the human rights issue regarding Iranian prisoner and U.S. citizen Abedini. For 2 minutes at 405pm we related the wife's comments to the state department, and we admonished folks to stay aware and be involved in these issues.

Jan 21 Discussed the second amendment in context of the South Carolina Senate amending a House bill that allows permit holders to keep their weapons with them when they go to dinner, but it bans them from consuming alcohol. The measure also gives business owners the right to ban concealed weapons on their property by posting signs against it.

Jan 22 Explained how the White House, Federal Reserve and Treasury Department manipulate the data to come up with the unemployment numbers. We presented the raw data at 410 for five minutes and showed how they calculate the numbers. Their current number being 6.7%. Once we ran the numbers without the accounting tricks, the actual number of unemployed people in the country is 37.2%. We referenced Wall Street Analyst, David John Marotta, for sources.

Jan 23 Contrasted the issue of the right to life at 420 for 3minutes. Hundreds of thousands of young people came to Washington D.C. to pray for our country and show

they want Roe V Wade overturned. Meanwhile The President issued a statement saying “Abortion is an opportunity to fulfill dreams.” We discussed the founding of the nation and how dialogue must continue in order to defend the values of the people.

Jan 24 Broke the news story of the supreme court decision to temporarily block enforcement of the Affordable Care Act on behalf of the Little Sisters of the Poor. World Magazine was there at the time and called us at 5pm for 10 minutes. We analyzed how this would impact other non-profits and religious organizations.

Jan 27 We have a Winter Storm Watch in effect for the entire southeast. We spent 5 minutes every hour at the top of each our giving updates to the weather, its projections, and safety measures.

Jan 28 Today, the southeast is under a Winter Storm Warning. We are giving four minute updates twice an hour with the latest conditions and closings as well as preparedness.

Jan 29 We continued our coverage of the Winter Storm throughout the day. We addressed issues each hour for at least five minutes. We provided safety tips from driving, to supplemental heaters. We told listeners who to contact in the event of emergencies and power outages.

Jan 30 At 420 for 4 minutes, we reported on Professor Emmitt Evans, a political science professor at Cal Poly in San Luis Obispo who requires students to read his textbook. He says Al Qaeda is an attempt to free Saudi Arabia from a corrupt and repressive regime propped up by a neocolonial United States. We talked about the real value of education, and steps to take when college classrooms have political agendas and encourage activism.

Jan 31 Played the :90 program by Howard Dayton encouraging folks how to budget money and develop a spending plan for this new year.

February 3 Reported on a constitutional concern regarding freedom of religion. A Football coach who attends the same church as some of his players has been ordered to stop baptizing and leading in prayer. 3minutes at 520pm

Feb 4 Updated audience at 515 for four minutes about new regulations regarding filing income taxes for this year. We also discussed steps to take for safety from identity theft.

Feb 5 Interviewed Caroliniana Nursery about winter lawn and tree care and how to protect them during these snowy and icy days. Also, at 505, we discussed how to prepare lawns over the next few weeks for spring as well as pruning.

Feb 6 At 405 for 4 minutes, we discussed the growing awareness of human trafficking. We talked about some of the influence in our geographical coverage area, and the success of the FBI rescuing 16 girls during super bowl week last week.

Feb 7 Promoted how to utilize our free public service announcements a 420 for 3 minutes. We explained how to access and submit information for broadcast and netcast.

Feb 10 Carried a broadcast at 505 for five minutes about tips for a healthy marriage. Dr. Erwin Lutzer shared how to improve communication and resolve conflict.

Feb 11 Our entire area is under a Winter Storm Warning. We have spent most breaks explaining the weather patterns and offering suggestions on how to cope with power outages in extreme weather.

Feb 12 The snow and ice has begun all across the southeast. We have spent the day discouraging listeners from being on the roads. We have talked about safety with downed power lines and warnings against kerosene heaters and carbon monoxide.

Feb 13 The conditions have worsened, and this storm system has paralyzed the southeast. We have been in contact with agencies to offer assistance and help for those in need. Many are without power in the cold.

Feb 14 We have discussed throughout the day how to contact power companies and insurance companies. We have told people where warming centers are in various cities, and continue to work with law enforcement and others about keeping people safe.

Feb 17 Damage and power outages continue across the southeast. We have dedicated most of our stop breaks to helping people find help removing trees and hotline numbers for insurance claims and questions. There had also been a 4.2 earthquake. We discussed insurance.

Feb 18 We promoted our event calendar at 4:40 for four minutes. We shared several events, and we explained to listeners how to submit information to the calendar to gain access to the airwaves.

Feb 19 Interviewed Gerald Stephens with the Nursery about how to care for trees and shrubs that were damaged by the ice. We spoke at 505pm for 9 minutes.

Feb 20 Discussed Immigration and Freedom of Religion while updated the listeners to the German family that was granted asylum in 2008, but the U.S. Justice Department is wanted to sent back to Germany because the DOJ believes homeschooling teaches intolerance. This break was at 410 for 3 minutes.

Feb 21 Reported on the op-ed piece by Ajit Pai, the FCC Commissioner who is alarmed that the executive branch wants to place monitors in news rooms, under the guise of academic inquiry. He is sounding the alarm of the loss of Freedom of the Press. We spoke at 505 for 4 minutes discussing how through regulation and license, the FCC could intimidate broadcasters.

Feb 24 Cited a recent study that explains the best determinations to improve economic and educational opportunities. We spoke at 420 for 4 minutes listing the five characteristics necessary for the optimum potential for moving a child or family in the bottom fifth of the population to the top fifth.

Feb 25 Revisited the Supreme Court order's list regarding religious freedom and the German Homeschooling case. We spoke at 405 for 3 minutes. The update served to explain educational rights and purposes.

Feb 26 Reported on a press conference by the CAAP in which Black ministers are concerned about protecting traditional marriage and why that is important in today's culture. 515 for 4 minutes.

Feb 27 Reported on the Attorney General's taking a lawless attitude by telling state Attorneys general they don't have to enforce laws they don't agree with. We discussed the concern of lawlessness and tyranny, and how this constitutional republic is a land of laws. We reported at 440 for five minutes.

Feb 28 Discussed Alzheimers and care giving at 520 for 4minutes. We used a real life story of an author, Elizabeth Elliot and made applications from her story.

March 3 Talked about a skier who lost his cell phone in the snow for a week before he found it and the steps he took to restore it. We shared those actions with the audience at 440 for 3 minutes.

March 4 Reported about the SC employment and Workforce report that outlined the steps South Carolina has taken to provide jobs at 410 for four minutes. SC employment level has exceeded the highest number of jobs in the history of the state. We shared some of the new industries in the state that those looking for jobs could make inquiry about.

March 5 We have some inclement weather; so at 405 for 4 minutes, we gave reports on the weather and gave announcements on what steps to take for this evening.

March 6 Discussed the challenges of parenting , and the legal responsibilities at 420 for four minutes. We reported on the judicial case where an 18 year old child was suing her parents for tuition and living expenses (Rachel Canning) The judge ruled against her and for the parents.

March 7 Promoted our events calendar and told the audience how to access the available air time. We talked about specific events this weekend at 440 for 3 minutes.

March 10 Shared from a number of studies that reveal that sitting at work for hours can be unhealthy. At 440 for 3 minutes we showed the link between heart disease, obesity, diabetes and cancer with prolonged sitting. We gave several suggestions of how to break up the day and acquire more movement and exercise.

March 11 Eric Metaxes, author and founder of Socrates in the City, spoke at the CPAC. We shared his three points at 520 for 3 minutes. He addressed the connection between debt and liberty, Religious freedom and liberty, and our moral heritage and liberty.

March 12 Read excerpts from a letter from one of our listeners at 410 for 3 minutes. He is an immigrant from Guatemala, and is incarcerated in our area. He listens to us a lot, and has greatly benefitted from our broadcasts. He says we have been a great blessing to him and he has learned a lot.

March 13 Interviewed a Samuel Menyongar from Liberia. He told how he was in med school when the civil war broke out in his country. He now has started a church and two schools in his country. They are educating the people, they have brought healing to the community, and they have implemented clean water facilities and waste treatment. He addressed what we could do to assist the refugees of Syria who are displaced by the war.

March 14 Reported on the four abortion bills up for debate in the South Carolina Senate. They passed committee but were going to full senate for vote. We discussed the pros and cons of the legislation and the odds of it passing.

March 17 Interviewed John Gilmore, a sponsor for a children's reading program. We discussed the need to help children read and the methods available to do it. We spoke for 8 minutes at 505.

March 18 We reported at 410 for three minutes about the Commerce Department's decision to relinquish the control over the database of names and addresses that allows computers around the world to connect to each other. We discussed the pro's and con's as well as the global possibilities of a loss of freedom of speech, once The US is no longer in central control.

March 19 Interviewed Gerald Stephens' nursery about how to strengthen trees after all the ice damage from a month ago. We discussed fertilizers and lime at 505 for 6 minutes.

March 20 Discussed freedom of speech in the context of a court case in our listening area of a professor who was denied promotions after he converted to Christianity. The

case closed today, and he won. The judge will rule on the penalty in a few weeks. 420 for 4 minutes.

March 21 Reported on the impact of civil war on persecuted minorities in the nation of Nigeria. The violence has escalated over the past two weeks with hundreds of Christians being killed by Muslims. We reported at 520 for 2 minutes.

March 24 Discussed points from a new Heritage Foundation book that reinforces the facts that churches and families, not the government, make the country strong. Recalling Alexis de Tocqueville's observation about little platoons who solve problems government can't. We spoke about how to strengthen and support our families and churches at 420 for four minutes.

March 25 Reported on World Vision, a major Christian organization, decision to change their policy to recognize homosexual "marriage" at 410 for five minutes. This has caused a huge, negative reaction from the Christian community, and we cited several spokespeople who reaffirmed the biblical definition of marriage.

March 26 Reported on World Vision at 410 for five minutes as they reversed their decision and offered an apology. We talked about the cultural influences and the bullying tactics so prevalent in politics today.

March 27 We reported on the Supreme Court hearing over whether employers' religious beliefs can free them from part of the health care mandate that many argue is a violation of conscience and religion. We summarized the arguments and offered brief commentary at 520 for 4 minutes.

March 28 We promoted our event calendar and announced several events for this weekend at 440 for 4 minutes. We also explained how listeners can use our free public service announcements and access our website.

March 31 Cited a New York Times piece about reverse mortgages at 420 for 3 minutes. We explained the benefits and pitfalls, as well as offering a warning from the newspaper now that there are many problems coming to light as the elderly who took out the reverse mortgages have passed away.

2nd Quarter

April 1 Reported on state laws that limit and prohibit cell phone use and texting at 520 for 3 minutes. New laws in upstate South Carolina are prohibiting the cell phone in the car. The problem stems from 25% of all accidents are cell phone related, and it seems because of the distraction. Laws are trying to catch up to the technology.

April 2 Interviewed Dr. Samir Khleif, the head of the cancer research center of Georgia Regent University. He explained the new approach to fighting cancer, the successes that we are experiencing, how to prevent cancer, and how to get screened to detect it early.

April 3 Discussed freedom of religion and the constitutional rights of students in school while covering a story of a kindergarten girl who was told by the lunch monitor she could not pray over her meal. 3 minutes at 440pm

April 4 Explained the latest in the Affordable Care Act. We covered the latest updates on extensions and deadlines, specifically the closed window to purchasing private insurance and the fees and taxes due next year. We spoke at 440 for 3 minutes.

April 7 Reported on the firing of Mozilla chief executive Brendan Eich. He was forced out of the company due to pressure from folks online who threatened his company if he was not removed, because he made a \$1000 donation to the campaign for California's Proposition 8 in 2008. The public is very concerned about what is bullying and intolerance. Some have labeled it facism. We discussed these cultural implications and how it impacts our work places at 520 for 3 minutes.

April 8 In context of the Healthcare Mandate, we explained the Christian Health Sharing ministries that are exempt. They have all doubled or tripled in enrollment, and are available to those who meet the requirements. Their unique structure, allows medical cost sharing to avoid government regulations so people can pay the doctors in cash. 4:10 for 4 minutes.

April 9 Interviewed the Nursery about planting trees and bushes. Spent most of the time discussing Pecan trees and how markets and weather affect the crop and how listeners can enjoy growing them. 505 for 5 minutes.

April 10 Updated a story from last week about freedom of religion, where a kindergarten girl was told she couldn't pray before her meal. The school dismissed it, but the parents came with an attorney, and the girl identified the lunch monitor. We discussed constitutional rights and the presence to pursue them or lose them.

April 11 Reported on piece from the LA Times about higher meat prices. The authors blamed it on climate change. We expanded the argument to include the shortage of corn due to diverting it to ethanol, the Fed's policy of quantitative easing, and the mounting debt our government is ensuing. Unlike the climate, we suggested ways we can make changes to the other three that would slow down the 20% food increase this year. Part of our discussion was to discern how to read a news article.

April 14 Carried the show Probe at 550 for 3 minutes. They are discussing today, and all week, poverty and wealth. They are conducting a comparison/contrast of the economic theories of socialism and capitalism.

April 15 Discussed the constitutional grounds of a standoff between Feds and a Rancher in Nevada. Fascinating story of government overreach and intimidation and the citizens' response to them. It is reminiscent of our forefathers confronting England. We discussed this at 410 for 4 minutes and talked about resolution when laws seem unjust.

April 16 Carried a 25 minute family show at 8am discussing aging. They discussed health, financial, and relational concerns and how to plan on growing older as well as how to interact with and care for aging loved ones.

April 17 Reported a story about Common Core education and testing. Discussed the pros and cons, and that South Carolina Education Superintendant cancelled its usage in the state. 440 for 4 minutes.

April 18 Broadcast Money Wise, a 25 minute call in show dealing with money issues. It gives listeners the opportunity to call and ask questions from financial experts regarding money, debt, investments, taxes and other daily concerns. We carried the show from 6-6:25

April 21 Discussed the trend for credit cards to increase their interest rates again. This is a warning for listeners who carry a balance that the banks are increasing rates to over 20%. We gave tips to paying of credit quickly at 520 for 3 minutes.

April 22 Carried the Family Talk commentary at 540 for 2 minutes. They discussed how families can do simple things to improve a student's grades and help them through adolescence.

April 23 At 440 for 2minutes, we reported on Governor Deal's signing into law changes about where people can carry a concealed weapon. One aspect of the law permits churches to determine if constituents can carry weapons at church. This is seen as a huge positive for many who believe churches are vulnerable to criminals.

April 24 Played the Family Talk program. They discussed the moral issues of our day and how each individual family can make decisions that make an overall decision in our free society. 930 am for 25 minutes.

April 25 Promoted the Student Mind Games conference at 550pm for 3 minutes. This conference equips young people how to formulate an overall mindset or worldview to help them throughout life. We also promoted our event calendar and how listeners can access our free public service announcements.

April 28 There was tornadic weather across our area over the weekend. We discussed alerts, warnings and watches. We also talked about safety actions and plans in the event of a natural disaster at 404 for 4 minutes.

April 29 Because of continued inclement weather, we continued our coverage of the severe weather. We referenced "Ready Georgia" for how to prepare for a possible tornado, how to plan for imminent danger...where to go, and how to stay informed and contact local emergency management agencies. At 405pm for 4 minutes.

April 30 Reported on a family in our listening area who went for an outing on Saturday, got lost, and was not found until Wednesday morning (today). We discussed outdoor activities, safety steps, contact lists, and other ways to keep oneself safe over the summer months. At 520 for 3 minutes.

May 1 Reported on a house bill that was introduced in regards to the armed agents that surrounded Nevada rancher, Cliven Bundy. The bill is intended to cut funding for any paramilitary units that work for the Bureau of Land Management, the Internal Revenue Service, and other Federal regulatory agencies. States are very concerned about the strong armed tactics of the federal government, as well as the land grab from the states. 420 for 3 minutes.

May 2 Carried the Family Talk Commentary at 5:30 for 2 minutes. They gave four specific things a family can do to improve the health of the family and its unity. One step was how to improve communication.

May 5 Shared about a new report in the research stage that indicates if younger blood donations are given to older patients, their physical health as well as mental health improves drastically. It has a rejuvenating affect. We spoke about the medical and ethical ramifications of this outcome at 440 for 3 minutes.

May 6 Numbers were just released by the House Energy and Commerce Committee regarding the nationalized health care. Apparently, 1/3 of the people have not followed through and paid, dropping the enrollment by millions. Many of our listeners have lost their plans and have seen rates and deductibles increase. This is a major concern for our audience. We updated folks at 410 for five minutes, giving them other medical plan alternatives.

May 7 Reported on a Freedom of religion issue at 520 for 3 minutes. The supreme court issued a ruling maintaining the legality of invocation at public /government meetings, and added the approval of specific prayers in Jesus name as constitutional.

May 8 Interviewed the nurseryman at 505 for 10 minutes about lawncare in the south. He advised our listeners about everything from watering, seeding, sodding, mowing, fertilizing and types of grass.

May 9 Updated the audience of a news story we reported on in January at 410 for 4 minutes. The VA in Augusta has issued a formal apology for denying a school the

opportunity to sing Christmas Carols at the VA this past Christmas. They have invited them to return next Christmas.

May 12 Updated the audience on a developing story that the South Carolina Education Oversight Committee has approved new standards which would allow public school students to learn arguments both for and against evolution. We reported this at 420 for 3 minutes.

May 13 Reported on the court ruling from the EU that said search engines must comply when an individual requests they remove them from search results. This is different from in the US, and we discussed the tension between privacy and freedom of information at 410 for 4 minutes.

May 14 Shared a study from economist Dr. Douglas Allen on the family makeup's effect on children, the economy and culture. All things being equal, children with married parents consistently do better in every measure of wellbeing than their peers. 440 for 3 minutes.

May 15 Carried the broadcast Money Wise at 6pm for 20 minutes. It is a live call in show for our listeners questions regarding finances, debt, investments, wills, and other financial matters.

May 16 Carried the broadcast Family Talk at 930 for 30 minutes. They discussed the value of humility in relationships and how to better interact with friends, co-workers and family members.

May 19 Carried the broadcast Family Life Today at 830 for 30 minutes. They discussed ways to make blended families work well together.

May 20 A candidate for the U.S. Senate called, and wanted an interview. We granted him a ten minute interview at 505pm

May 21 We discussed bullying with young people. Citing the HSLDA, many parents are choosing to pull their children out of public school because of bullying and abuse to homeschool them. Private school is often not affordable.

May 22 Reported on a new fashion line of clothing that blocks electromagnetic and radio waves. This is Focus Life Gear with the idea that garments can protect us from both the storm of information as well as invasion of privacy. The clothing will disrupt the cellphone's connection whenever it is worn.

May 23 Carried Family Life Today at 830 for 30 minutes. They discussed how to help children enter into dating and how to assist when a problem arises.

May 26 Cited a story at 4:20 for 4 minutes of 7 things happy people often do. We covered each point and made application for the listeners.

May 27 Reported on the Palestinian Authority and Hamas calling for the ethnic cleansing of Israel. This report focused on our national security and how our current foreign policy impacts the lives of Americans. Spoke for 2 minutes at 4:05pm

May 28 Carried Mark Gregston's 2 minute feature at 220pm. He spoke about how to deal with behavior problems with children to help them and build family harmony.

May 29 Reported on the tidal wave of illegal immigrants flooding across the border looking for the promised amnesty. We discussed the increase at 440pm for 3 minutes, the financial, and health concerns that are challenging the nation's law.

May 30 Listed 8 numbers identity thieves want to steal from our listeners. At 520pm, for four minutes, we discussed the most vulnerable numbers and how listeners could strengthen security for their money and identity.

June 2 Promoted the upcoming South Carolina Primary at 410 for 3 minutes. We encouraged everyone to participate, discussed some of the candidates and the major issues.

June 3 Discussed the report that 30 percent of the world is overweight. We talked at 520 for 3 minutes about the Institute for Health Metrics and Evaluation at the University of Washington study, and how over the past 40 years it has improved from the starvation that was due to socialists and dictatorial governments, and poverty.

June 4 Reported on the Common Core, evolution versus Creationism divide for the candidates running for S.C. education superintendent. At 510 we updated the candidates positions on the issues.

June 5 Updated the audience at 405pm for 3 minutes of the status of Pastor Abedini. The Iranians have threatened him with more jail time unless he ceases to witness to the other inmates. We discussed Freedom of Religion and Human rights, and our ability to influence the government.

June 6 Today is the 70th anniversary of D-Day. We discussed the sacrifice, courage, and values of the young men who stormed the beaches of Normandy. We made application to today's culture at 510pm.

June 9 Reported on the S.C. House and Senate lawmakers agreed to a compromise bill that bans texting while driving, making S.C. the last state in the south to penalize the practice. We discussed the law, and good driving habits.

June 10 Discussed Medicare and the most profitable time to sign up, the window to get the best coverage, and how to reduce premiums for medi-gap. Spoke at 520 for 3 minutes.

June 11 Reported on the Southern Baptist Convention vote to affirm God's design that gender identity is determined by biological sex and not by one's self-perception. We discussed how the culture, and the courts influence the denomination to pass the resolution and how churches can love their neighbors. 420 for four minutes.

June 12 Promoted several events and explained how listeners and organizations can submit information to our event calendar and access the free public service announcements we make available at 540 for 3 minutes.

June 13 Updated the audience on the chaotic conditions in Iraq. It is a political catastrophe, a foreign policy disaster, and a desperate humanitarian crisis. Islamic militants are executing citizens by the thousands and people are fleeing for safety. America announced two hours ago, that we will not help. 505 for 4 minutes.

June 16 Carried the broadcast Insight for Living from 10am to 10:30. He discussed Crime, 12 ways to raise a delinquent, how to correctly discipline and train children.

June 17 Broadcast a 25 minute interview at 830am that discussed how to forgive, the benefits of forgiveness, and problems associated with unforgiveness.

June 18 Reported on the news that Google is cracking down on sexually graphic content with two policy changes at 420 for three minutes. We discussed the revision in light of the scientific data that shows the harm done to people and especially children.

June 19 Issued a Consumer Affairs Alert at 515 for 3 minutes. We explained how scammers are calling homes and using false names and numbers on caller id to get through. We gave the report number 1-800-922-1594 and also encouraged folks to contact the Federal Trade Commission if needed.

June 20 Updated the audience about Georgia abortion doctor Charles Rossman at 440 for 3 minutes. We reminded the audience how he broke the law and fled the country 11 years ago, but was now caught by Interpol this week and returned to Lowndes County. We covered some of the law that protects mothers as well as unborn babies.

June 23 Interviewed Attorney David Gibbs regarding what states can do against the increased federalism, and we also discussed how churches can protect themselves in light of rogue judges. Interview was 10 minutes at 505pm

June 24 Gave out information at 420 for five minutes about the runoff elections today. Updated listeners on the candidates and encouraged listeners to vote before 7.

June 25 Updated the audience on a Freedom of Religion issue at 405 for 3 minutes. We showed how Sudan had released a death row Christian from jail but was detaining the entire family under house arrest.

June 26 Reported on the Supreme Court decision that prohibits police from snooping through a person's cell phone without a warrant. We discussed the fourth amendment, and how listeners' privacy rights are upheld at 520 for 3 minutes.

June 27 Reported on the Bureau of Economic Analysis report that announced this week that the U.S. economy shrank at 2.9 percent. This level of contraction has not occurred since the great depression. At 520 we covered several elements: The broadcast networks seem to be ignoring the news, The IBD connects the drop to the Obama economic policies, and how does our economy shrinking impact our listeners' lives.

June 30 Broadcast 25 minute show at 10am about the difference between discipline and abuse, when it comes to child-rearing.

3rd Quarter

July 1 Reported on yesterday's Supreme Court ruling in favor of corporations that are owned by families. We discussed at 510 for 4 minutes the significance for religious freedom and how the 1990's Religious Freedom Restoration Act factored into the ruling.

July 2 Carried a story at 410 for 3 minutes on the Israeli military response to Hamas' kidnapping and murder of 3 seminary students. We discussed the peace process and Hamas' intent to see Israel dissolved.

July 3 We discussed the misinformation reported by the media outlets regarding the recent Supreme Court ruling. The reports skew the reality into false ideas that polarize people. We discussed responsibility in reporting and how we approach news features and public interests.

July 4 Gave a list of 10 ways to remain safe over the long holiday weekend. We covered everything from automobiles, boating, barbequing, and fireworks.

July 7 Updated listeners on the situation in Nigeria where Boko Haram is kidnapping women and girls (63 escaped this weekend). We discussed human trafficking and what we can do to end it. 410 for 4 minutes.

July 8 Discussed the illegal immigration issue going on at the border. It is a huge debacle as our laws are not being upheld, the borders are not secure, and politicians use it for personal gain. We covered what is causing the influx, and possible reasons why for 4 minutes at 510pm

July 9 Interviewed the Nursery about lawn and gardens. We fielded questions from the audience and discussed those concerns, like how to control sand spurs and bahia grass. 505pm for 7 minutes.

July 10 Updated story from November 2012 where there was suspicion of voter fraud. We used the story to help listeners identify issues and exercise their right to vote. The FBI has just arrested James Webb Baker Jr, a Democrat from Seattle who attempted to intimidate Republican voters from voting in the swing state of Florida. He has been fined \$350,000 and will be sentenced in September.

July 11 We reported on a student who kept her disposable contact lenses in her eyes for six months, and has been left blind. We discussed health care and lens care for contacts and how listeners should protect their vision and get adequate care.

July 14 Reported on the Religious Freedom debate where the Pentecostal Holiness College expelled a student/woman who "married" another woman. They have a lifestyle covenant that gives the school the provision to discontinue any enrollment if there is a violation.

July 15 Carried the 20 minute broadcast/call in show about money, Money-wise, from 6-620. Our listeners were able to discuss financial matters with three financial experts regarding budgets, debt, and investing.

July 16 Discussed privacy issues, and how Germany is considering the use of manual typewriters for sensitive documents as a way to counter spying. Old Fashioned typewriters, not even electric are more suitable to security. We encouraged listeners to look at encryption and other means of securing data.

July 17 We discussed the rise of judicial activism and the increased power of the executive branch. The most common theory is that elected officials, feel the pressure of re-election so they pass power to the other branches for their own protection. Of course the concern is they become non-necessary, and the state becomes tyrannical. We cited information from Professor Jonathan Turley.

July 18 We discussed family finances in light of this week's CBO Report. Taxes will steadily increase over the next 25 years, the mortgage deduction will be cut in half, social security will be taxed, and Obamacare will increase income tax by 11% We discussed strategies for families to manage the coming decades.

July 21 Announced the coming state tax free days in just two weeks. We compiled a list of available purchases that would save our listeners 6-7% just on taxes alone.

July 22 Talked about the benefits of adoption. We used a real story of a lady who gave up her baby 77 years earlier, and how they were recently reunited. We shared on the ethics and benefits of keeping and preserving life.

July 23 Carried the 30 minute show Family Life at 830am. They discussed divorce, and ways to navigate the pain and loss for each spouse and for the children.

July 24 Updated the story of the IRS hearings. Now that new judges have been named, and they require statements under oath, the IRS has amended its story. They claim the lost hard drive did not crash but was scratched, others' in the same investigation had similar mysterious problems, there now are some back up tapes. This is a huge concern for our audience and the country. If the IRS can be politicized to target citizens, then we have lost liberty. Secondly, we must be able to hold our government accountable.

July 25 Interviewed World Magazine at 505 for 10 minutes about this week's news. They provided analysis of the situation in Iraq and Israel with commentary on how this impacts that region as well as the impact on the U.S.

July 28 At 4:05pm and 505pm for 2 minutes each, we issued a heat advisory for across our listening area in cooperation with the National Weather Service. The heat indices are exceeding 100 degrees, and we are advising listeners to stay indoors in air conditioning, but if that is not possible, to take action to not become overheated in outdoors.

July 29 We reported on the AAA report for substandard bridges at 420 for 4 minutes. Certain politicians have been attempting to raise SC gas taxes to pay for repairs, but the report indicates SC is better than the national average, as well as NC and Mississippi. GA is ahead by a couple of percentage points. The report explained where the most vulnerable bridges were, how they were categorized, and what is being done to correct it.

July 30 At 440 for 3 minutes we recapped the Fourth Circuit ruling against Virginia's Marriage Protection Amendment, and we explained how SC will continue to defend the amendment and force a Supreme Court ruling.

July 31 The Urban Institute released its findings that 35% of US households (77 million people) are facing debt collections. The South is the second highest region, and we shared resources of how to get out of debt and how to handle collection agencies.

August 1 Promoted our event calendar at 540 for 4 minutes. We highlighted several events and explained how listeners can submit material that can access our free public airwaves.

August 4 Reported on the International outbreak of Ebola, and what it means to our listeners. At 410 for four minutes we discussed the Americans returning to Georgia, the health risks and precautions.

August 5 Followed up on a report from last week regarding our area's marriage law amendments. With The Fourth Circuit ruling, it is impacting how each state is responding. We covered the various replies and how the actions would impact the citizens, our listeners.

August 6 Some of our listeners were forced to quit praying in the Dublin Mall in Georgia. We discussed freedom of religion, but we also discussed the law that the mall is private property, and therefore a clash of rights. This is important as people are trying to figure out how to live their faith in a growing religiously hostile environment.

August 7 The latest Federal Reserve Survey of consumers has been released, and we discussed the numbers and meaning at 420 for four minutes. 40% of households in the United States are living from paycheck to paycheck, and their condition has worsened over the previous five years. Fewer Americans are able to purchase a home because they could not save up a down payment, or because they could not qualify for credit.

August 8 Interviewed World Magazine at 505pm for 10 minutes. We discussed the terrorist activity in Iraq and how Christians are fleeing to the mountains. Thousands have been killed in the past couple of weeks. We discussed religious freedom and America's moral responsibility to help the refugees.

August 11 Carried Money Wise at 6pm for 20 minutes. It is a call in show for our listeners where they can ask questions about money, budgets, debt, credit, and investing.

August 12 Discussed the Report from the United States Conference of Mayors that came out yesterday. Our listeners have seen a 23% pay decrease over the past five years. Inflation is causing the cost of living to increase, and 40% of households are living paycheck to paycheck. We addressed strategies and resources to help our listeners. At 520 for 5 minutes.

August 13 As school is starting back up, we noticed where home schooling has increased 27% over the past two years, now surpassing private school attendance. At 440 for 3 minutes we discussed the fact that common core was given as the number one reason parents are pulling their children out of public education. We discussed common core and its purpose and its shortcomings.

August 14 Carried the Family Talk commentary at 530pm for 2 minutes. Today's topic was how to resolve conflict in the home.

August 15 Interviewed World magazine for 10 minutes at 505. They offered analysis on the Ferguson riots, racial disparity, militarized police, and community involvement as well as what churches can do to bring healing and blessing to a community.

August 18 Updated the audience on the Ebola outbreak at 405 for 3 minutes, including the ongoing treatment of Nancy Writebol at Emory University.

August 19 At 420pm for 5 minutes, we reported on how a group from China has hacked into the national hospital system, stealing personal information from millions of Americans, including our area. We discussed safety procedures our listeners need to take to protect their identity and accounts.

August 20 We discussed the importance of national security by having secure borders. The U.S. Department of State just purchased 2500 spools of razor wire to secure the border between Ukraine and the Crimean Peninsula, yet laws enacted in 2006 are yet to be enforced on our southern borders, while streams of people swarm into our country illegally. We discussed how Great Britain has permitted this over the past two decades, and now has 25% Islamic population, and is now exporting and funding terrorism in Iraq. The concern is our misguided policies are creating the same error.

August 21 Following up on yesterday's report on border security , we cited the latest polling data at 440 for 3 minutes stating the overwhelming percentage of voters who want the illegal immigrant children returned to their countries of origin.

August 22 With school having been in session for only two weeks, we covered several stories where political correctness resulted in the arrest of a student, a teacher violated a student's constitutional rights, and another teacher was suspended for infusing race into her classroom setting. We discussed the importance of parental involvement and accountability of our school boards.

August 25 Interviewed World Magazine for analysis on this week's news at 505 for 10 minutes. Two topics were the current state of racial relations in the country and how churches can work to provide healing, and secondly, why pro-life groups are rejecting the ALS fundraiser.

August 26 Now that school is back in session, we discussed a study and recommendation by the Pediatrics Association at 420 for 3 minutes about delaying the start of school until 830, especially for middle and High School. Sleep loss related issues are a huge problem for teenagers.

August 27 Carried a health report that debunked myths of the use of vinegar, but also supported the scientifically proven benefits of vinegar. We discussed the various kinds of vinegar and how to incorporate vinegar into a diet for health benefits. 440 for 4 minutes.

August 28 Reported on the National Highway Traffic Safety Administration advance notice of proposed rulemaking in reference to vehicle to vehicle communications. We discussed the safety pros and privacy cons and how all this regulation could change the capability to drive a car.

August 29 Explained how to use our free public service announcements, and we highlighted several submissions, including the Battle of the Bulge 70th anniversary and national convention at the South Carolina state museum in Columbia. 5:10 for 3 minutes.

September 1 Being Labor Day, we discussed the origins of the holiday, the workers movement and workers rights. We also discussed the riots and rise of unions at the time, but how today unions are in decline, and according to the latest PEW research, workers are logging in 50-60 hours a week again.

September 2 At 420 for 3 minutes, we updated our listeners on the doctors who recovered from Ebola. We discussed the latest findings of the WHO, and the human testing of MZAPP, as we are facing the largest outbreak of Ebola to date.

September 3 Reported at 505pm for five minutes on the courtroom of Judge John Bryant as he schedules illegal immigrant children for a court date four years away. We discussed the 2012 executive order DACA that gave us the open borders.

September 4 Covered a health report regarding the value of standing over sitting at 440 for three minutes. Karolinska Hospital in Stockholm has studied the impact of standing on DNA. They determined it is an anti-aging affect to stand because it protects the telomeres, the protective caps at the end of chromosomes. We encouraged folks to not sit all day.

September 5 Updated the audience on the decision handed down Wednesday at 505 for 4 minutes. A Louisiana federal judge upheld the state's right to define marriage as the union of a man and a woman, and that the Constitution grants no right to same sex marriage. This is a huge social issue for many of our listeners.

September 8 We had a weather front move through much of our area, and many places have weather alerts and flood watches in effect. We spoke at 405 and 505 about updates and how to use the information for safety and preparedness.

September 9 Interviewed Frank Ulle regarding a show he has produced that we will carry on Saturday. The topic has to deal with how to treat people merciful, and how to find mercy.

September 10 We discussed at 520 for five minutes a program called Paws for Life that pairs inmates with shelter dogs in order to train the dogs so they can be adopted. It is a

12 week program and is having huge success, both for the dogs and for the inmates who have responded incredibly well to the dogs.

September 11 We reported on the President's speech last night at 405 for five minutes. His comments are not being well received by the world as we face a hostile Islamic group in Iraq. All of the coalition has abandoned him even before we were able to run the report. So the topic becomes what is the best way to address national security?

September 12 Covered the return of congress after their month long break. Many lawmakers were confronted at town hall meetings against illegal immigration. It has become a huge problem from disease to terrorism, and has been politicized to the point it has become polarizing. We suggested enforcing the existing laws and secure the border before any more work is done.

Sep 15 Carried an op-ed piece by Eric Metaxes tracing the eugenics movement of the 19th and 20th centuries to the abortion industry of today. We discussed how science has enabled people to abort 90% of children diagnosed with Down Syndrome. We discussed the morality and solution to this issue.

Sep 16 Reported on the significance of freedom of Religion at 420 for 3 minutes. We discussed separation of church and state, and how that is not for secularization but to prevent government from overstepping its limits to infringe upon the conscience of the people.

Sep 17 Announced a press release from the Social Security Office about their changed policy to mail statements to workers and the availability to access the information online, anytime.

Sep 18 Announced several PSA's and explained how listeners could access our free airtime at 540 for 3 minutes.

Sep 19 Played FOTF at 8am for 30 minutes. They discussed how to approach mental health issues and provide understanding and care for those suffering from acute mental illnesses. Two doctors were part of the panel of discussion, and the last 10 minutes dealt with bi-polar issues specifically.

Sep22 Carried a short feature, Probe, for 3 minutes at 550pm. They discussed the importance of and how to find purpose and meaning at the various stages of life.

Sep 23 Reported on a church/state issue at 505 for 3 minutes. A U.S. District Judge upheld the right for a monument of the 10 commandments to stay on the grounds of the Oklahoma state Capital.

Sep 24 Today is the anniversary of the Judiciary Act, establishing the Supreme Court. We discussed how some of the process has changed over the past 200 years and how the justices' view of the constitution affect our laws and our lives.

Sep 25 Reported on the impact GPS systems are having on car loans and subprime loans. Lenders have increased their chances of receiving payment, but at a high cost of privacy, and perhaps safety. At 520pm we spoke for five minutes on how this technology is changing loans and how it is expected to influence taxes and insurance.

Sep 26 At 505pm for four minutes we spoke of Religious Liberty as the first freedom in the first amendment, and how this freedom allows us to live according to conscience. We spoke of the attack on that liberty, what are the limits, and what are legitimate objections to national, state, and local laws.

Sep 29 Covered the process churches and non-profits can follow if they are sued. We provided legal resources and anecdotal illustrations to help them understand what their rights are.

Sep 30 Carried Point of View with Kerby Anderson for 2 hours. He covered the topic of terrorism and radicalization that is occurring in the United States, and measures we can take for safety. He kept phone lines open so our listeners could call with questions.

4th Quarter

Oct 1 Updated listeners who may have filed state taxes between 1998 and 2012 that today was the final day to sign up for free credit monitoring. We gave the phone number and the website to help folks get signed up.

Oct 2 Reported on the first cases of Ebola to be diagnosed in the U.S. We gave out public service announcements from the CDCP, and updated folks on what they are doing to contain the disease. Many of our listeners wondered why there could not be travel restrictions placed on anyone coming from or through that area to here.

Oct 3 We continued our reporting on the Ebola Pandemic. Congressmen are asking the President to prohibit non-essential travel to and from these areas of West Africa. It is legal and possible, but some in charge of the CDC are saying that kind of action would be discriminatory. Many of our listeners are concerned as well as outraged at the foolish actions of those in charge.

Oct 6 Carried the 30 minute broadcast of Family Talk at 930. They discussed family issues, specifically, how to care for aging parents and maintain strength and health for the care giver as well. Often the care giver is overwhelmed.

Oct 7 We discussed the Supreme Court's decision to not review appeals court decisions on the issue of same-sex marriage at 520 for 4 minutes. By failing to take up these

marriage cases, the High Court will allow rogue lower court judges to silence the elected representatives and the voice of the people themselves.

Oct 8 Carried the 20 minute call in show, Money Wise at 6pm. They discuss money, debt, investments, and other practical topics, allowing our listeners to call in and ask questions.

Oct 9 Discussed the upcoming elections and some of the close races in our coverage area. We announced the date for early voting, and covered some of the key issues at 540 for 3 minutes.

Oct 10 Explained to the listeners how to access our free airtime and our event calendar. We encouraged the audience to utilize this public service, and we announced several events that are coming up over the next couple of weeks. 505 for four minutes.

Oct 13 Carried a thirty minute talk show "Family Life Today" at 830. They discussed how to improve communication within the family. They dealt with the various relationships and how to overcome barriers and poor skills.

Oct 14 We spoke at 440 for 4 minutes about how to protect your home internet from hackers. We covered various aspects of home security and gave the audience references for obtaining more specific information on protecting their home network .

Oct 15 Reported on a story out of Houston, TX where the mayor has sued five pastors, demanding copies of their sermons and personal correspondence. This is a huge first amendment issue, and we are following it. Alliance Defending Freedom is representing the Pastors and the churches.

Oct 16 Carried the 2 minute Family Help Tip at 530. Today, they discussed how to set boundaries for your children that will not stifle them but rather make them feel secure.

Oct 17 We advised our listeners how to use the free air time we provide. At 440, we spoke for 3 minutes about submitting information, and we announced several of the events coming up this weekend.

Oct 20 Updated some changes in the upcoming election. Millions of dollars have been pulled by the Democrat Party out of the Kentucky senate race to bolster Democrat candidate Michelle Nunn in Georgia. This is a huge race for our audience and has significant impact on the balance of power in Washington.

Oct 21 Reported on this freedom of religion issue, where in Idaho, a minister is being forced by the state to perform a same sex wedding or be fined and jailed. We discussed freedom and government coercion, and how this may have impact in other communities throughout the country.

Oct 22 Reported on the equal protection clause of the 14th amendment as justification for redefining marriage at 510 for 4 minutes. The President insists there is a constitutional right, but constitutional scholars from the Ruth Institute strongly disagree. We fought the bloodiest, longest, most deadly war in our history in order to establish the proposition that all men are created equal, and that race is not a constitutionally permissible basis for government to discriminate. To say that the 14th amendment also mandates the legalization of same sex marriages is to denigrate the purpose of that amendment.

Oct 23 Carried the newscast covering the terrorist attack in Canada at 5pm for 2 minutes. After the details, the news covered the current strategy from Islamic Terrorists which is to radicalize and motivate followers to strike independently in the countries they live, specifically, members of the military and their families. The coverage also gave tips for safety and alertness for those members of our citizenry.

Oct 24 Promoted an organization: "Enough is Enough" whose mission is to educate folks about the pandemic, global threats of internet pornography. It harms children, families, and nations. It leads to divorces, violence and fuels the sex trafficking industry. We shared scientific studies and spoke for five minutes at 440pm.

Oct 27 Discussed the shooting at the school in Washington State from Friday at 520 for 3 minutes. We highlighted how a teacher attempted to intervene and the steps she took to protect students, including the shooter. We shifted how teachers and workers can simulate and prepare for potential workplace situations so they too can be prepared to minimize casualties.

Oct 28 October is National Cyber Security Month. We partnered with the Better Business Bureau to encourage our listeners to protect themselves against identity theft and cybercrime. We offered several security measures people can take, as well as who to contact if identity has been stolen or compromised. 440 for 5 minutes.

Oct 29 Reported on the speech the President gave to a Hispanic audience, promising executive action after the election to grant amnesty to illegal aliens. It is estimated that 9 million will be made legal in the next few weeks. This has huge ramifications for our country, each state, businesses, and national security.

Oct 30 Updated listeners on the latest on the Benghazi hearings. Deputy Assistant Secretary Raymond Maxwell had been scapegoated, but now cleared for revealing confidants destroyed documents before turning files over to the Accountability Review Board investigating the security lapses surrounding the terrorist attacks.

Oct 31 Carried the daily five minute show with Kerby Anderson at 5:50. He has discussed the definition of Truth and how it has changed through various philosophical

stages and how the new understanding affects our lives, our relationships, and our world.

Nov 3 Reported on the five year study on the benefits of the Mediterranean Diet, specifically adding Extra Virgin Olive Oil. It appears to prevent fat from accumulating around the waist, which directly improves the fight against diabetes.

Nov 4 Today is election day. We have encouraged our listeners throughout the day to go to the polls and vote. We have reminded them about some of the important issues that are on the ballots in each state we broadcast in.

Nov 5 Reported on the Press Release that the Social Security Statements will resume periodic mailings. We explained how this information can be used for financial planning and how listeners can set up an online account.

Nov 6 Promoted several non-profit legal ministries, and explained how with the rapid deterioration of our religious freedoms, listeners and churches needed to know some of the advocates available to them. We carry several programs, and regularly interview these attorneys to acquaint our audience with legal help that is available to them.

Nov 7 Promoted local events going on this weekend at 409 for 4 minutes. Additionally, we explained how listeners can utilize our free public service announcements. We always get good response from interested parties.

Nov 10 Discussed freedom of Religion, and how our rights may not be recognized in other countries at 410 for 4 minutes. We discussed how many in our audience either goes on or supports someone else for mission trips or relief efforts through our churches and how we may encounter problems like the folks who were just released from a North Korea prison.

Nov 11 Carried Family Talk at 930am, a thirty minute family show. The speaker related how he rebelled and failed but how his family loved and supported him, restoring him and helping him to rise to the place of leadership he holds today.

Nov 12 Cited an election day poll that indicated Americans are opposed to amnesty due to the poor job market at 440 for 3 minutes. Now that the election is over, the President wants to use an Executive Order to proclaim amnesty, and congress says it is against the law. This is a huge domestic issue for the American people.

Nov 13 At 440 for 3 minutes, shared a study on the benefits of quitting smoking. What happens to the body within 30minutes, all the way to 15 years. Added anecdotal elements to strengthen the discussion.

Nov 14 At 502pm we interviewed Drew Read from the Paul Anderson Youth Home for sixteen minutes about how to prevent problems for teens and how their home helps get

troubled youth back on track. We discussed various approaches, the history, case studies, and gave out contact information including links on our website.

Nov 17 At 505 we carried a five minute interview with newly elected Tim Scott from South Carolina. He is the first black Senator in the state, and he is the first black Senator elected in the south since reconstruction.

Nov 18 In light of next week being the busiest travel day of the year, we discussed at 420 for 3 minutes the cleanest areas and dirtiest/germiest areas of hotel rooms. We cited experts of how to sanitize and protect themselves against colds, viruses, bacteria, and the flu.

Nov 19 Received a news release and relayed it to our listeners about the U.S. Supreme Court denying a stay on same-sex “marriages” in South Carolina. Our listeners are value voters and these are great political concerns, but also, a religious entity, listeners want to know the implications of biblical commands in regards to behavior and ethics. We addressed the issue at 410 for four minutes.

Nov 20 Carried an educational piece that explained how the media reports using headlines and ledes in both active and passive voice/ with and without any attribution of responsibility. We discussed how the byte can be used to soften or influence an attitude or even the truth about an event. We cited several examples of one story, the killing of the Jewish worshipers in a synagogue in Jerusalem, using various news sources to show where there was bias against the Jews and favor for the Palestinians, who did the killing. At 405 for 5 minutes.

Nov 21 Promoted several events that are happening this weekend and explained how listeners can submit information for our free public service announcements. We make announcements as well as place the information on our event calendar, on our website. 520 for 3 minutes.

Nov 24 Covered the severe weather that is going on throughout the Southeast, and impacting our entire coverage area. We are experiencing severe thunderstorms, flash flooding, and even tornadoes. We are issuing the warnings and discussing how to prepare for conditions.

Nov 25 Carried a program at 450pm about the philosophy and theory of Eugenics and how the organization, Planned Parenthood, and its founder, have been some of the primary proponents of that movement since it inception.

Nov 26 Discussed safety with turkey frying at 510pm for three minutes. We gave national data on risks and how to avoid injury and fires.

Nov 27 Carried a public service announcement by AAA travel about road conditions, driving apps, peak travel times, and safety travel tips.

Nov 28 Shared a story about a 103 year old lady in Texas who has a reverse mortgage, and through an administrative error, she missed a one month payment in insurance, which she made up the next month at 440 for four minutes. The mortgage company is now trying to take her house for breach of contract. We discussed the pros and cons of reverse mortgages.

Dec 1 Carried Focus on the Family for 30 minutes at 8am. They had a panel of experts on who discussed ways to improve a marriage, specifically how to heal a damaged or broken marriage.

Dec 2 Ran a PSA about another scam that is running in our area at 410 for four minutes. A person posing as law enforcement calls and tells the person they failed to report for jury duty. The only way to avoid jail time is to pay a fine, by credit, debit or pre-paid debit card. We gave six points to help folks understand this was a scam, and who to call if they received this call.

Dec 3 Reported on an update from Bagdad, Iraq, where ISIS is demanding people convert to Islam or be killed. We carried a report at 410 for 3 minutes of 4 teenagers who refused to “convert”, and they were beheaded for their conviction. We discussed the importance of Religious Freedom and our need to stay engaged.

Dec 4 At 520 for 4 minutes we covered a story on how many people/businesses have your social security number. We gave some suggestions on how to limit the access and protect identity, especially during Christmas. One example was to not fill out a store credit card form at the cash register during shopping, even if it means a discount.

Dec 5 Shared the story out of Columbia, SC how the police are responding to all these abuses of power. They have acquired the money to purchase cameras for every officer, and they are hiring civilians to examine training and protocol.

Dec 8 Reported on the story of World Magazine’s Person of the year, Frank Wolf. He is a retiring congressman who used his influence to direct U.S. Funding to war torn and oppressed nations such as the famine in Ethiopia. He said to whom much is given, much is required. We discussed how everyone can do the same thing in whatever sphere of influence they are in.

Dec 9 Carried an update on the Obamacare numbers at 505pm for 4minutes, that according to HHS, they mistakingly counted 1.3 million extra people as enrolled in the program. This comes on the heels of the architect of Obamacare, Jonathan Gruber, calling the American voter stupid, and using deceit to get it passed.

Dec 10 Interviewed Gerald Stephens at 505 for 10 minutes. We discussed how to care for trees and plants during these colder months. He advised listeners based on feedback he had received from the audience.

Dec 11 We updated listeners on the latest for the current enrollment period for Obamacare at 420 for 3 minutes. We cautioned that customers will face higher premiums and higher deductibles in addition to higher taxes. The lowest cost plan will increase from 5-10% in expenses.

Dec 12 Updated the listeners on the ongoing hearings for the IRS. New documents and emails reveal that the IRS and Department of Justice colluded together to harass conservative groups and threaten them with possible prosecution for “lying” about political activities.

Dec 15 Reported on the debate in Texas lifting the ban on open carry of handguns. They allow the public display of long guns, but insist handguns be concealed. That is under debate and will have influence on South Carolina and our listeners as upcoming legislative sessions are about to open up in the coming weeks.

Dec 16 Broadcast the thirty minute show Family Life at 830am. They discussed depression, mental health, and the holiday blues. They went over various treatment and referral options and addressed ways to identify any concerns.

Dec 17 We shared a report about the South Carolina law that requires state universities to teach the U.S. Constitution and the Federalist Papers at 520 for 2 minutes. Nearly none of the public colleges have complied with the law. We referenced the team that is going to address this concern and push for enforcement in 2015.

Dec 18 Reported on the federal judge’s ruling that parts of the President’s amnesty to be unconstitutional. It violates the separation of powers, the Take Care Clause, and the constitution. We discussed how amnesty is a political movement and how it may affect jobs in our area and the burden on our states.

Dec 19 Shared a study published in the Journal of Investigative Dermatology at 440 for 3 minutes that appears to support that Ibuprofen as well as Aspirin combat chronic inflammation and may cut the risk of various forms of cancer as well as heart disease.

Dec 22 Relayed an investigative piece on the politically correct/tolerance at 520 for four minutes how a blogger, Theodore Shoebat asked 13 bakeries owned by homosexuals to bake a pro-traditional cake for him that would read: “gay marriage is wrong”. He wanted to see if the same level of tolerance that Christian business owners are required to abide by is also being upheld for others. All 13 bakeries he approached refused to make him a cake, and he even received much verbal abuse.

Dec 23 With two days left for Christmas shopping, we conveyed information from public safety about protecting gifts from theft. They stressed the importance of locking the car doors, and storing packages and personal items out of sight in the trunk.

Dec 24 Explained how Obamacare has increased taxes by \$250 billion, costs were shifted to consumers in higher premiums and larger deductibles, and how the Cadillac tax hits all the plans, not just the smaller ones for 3 minutes at 410pm.

Dec 26 Updated listeners on the Fourth Circuit Court of Appeals as they struck down North Carolina legislation that required abortionists to perform an ultrasound, describe the features, listen to the heartbeat, require a 24 hour waiting period, and provide alternatives. Pro life groups anticipate an appeal.

Dec 29 Broadcast How to Manage Your Money at 6pm for 25 minutes. It is a call in show for our listeners to ask a panel of financial advisors various questions about money: budgets, investments, annuities, real estate, taxes, etc.

Dec 30 Interviewed Wayne Crenshaw from the Macon Telegraph about how Airmen stay on track to pass the required fitness test. Coming up on New Year's resolutions, we knew diet and exercise were the top resolutions. He spoke with several men who shared how they disciplined themselves to stick with a routine throughout the year.

Dec 31 Reported on the upcoming healthcare hearings with Jonathan Gruber. He has already gone on record saying they believed the American democrat voter was too stupid to be trusted with the truth. He will be asked about control costs next. He has said the only way to keep costs down is to deny treatment.
