On behalf of AMFM Radio Licenses, LLC, as debtor in possession, licensee of WKQI(FM), Detroit, MI (Fac ID# 6592) (the "Station"), I am writing to request an exemption from the requirements outlined in your February 14, 2019 letter based on the recent audit of the Station's EEO program. The Station is part of larger employment unit based in Detroit, Michigan, which also includes WDTW-FM, Detroit, Michigan (Fac ID# 59952), WDFN(AM), Detroit, Michigan (Fac ID# 59969), WMXD(FM), Detroit, Michigan (Fac ID# 59596), WJLB (FM), Detroit, Michigan (Fac ID# 59592), and WNIC(FM), Dearborn, Michigan (Fac ID# 6594) (the "SEU"). The SEU submitted an audit response on September 20, 2018, which included its 2017 and 2018 EEO Public File Reports, both ending May 31. The Commission responded favorably to the SEU's audit response on October 3, 2018.
