The Investigations and Hearings Division of the Federal Communications Commission (FCC) has completed its review of the response of WZXQ(FM), Chambersburg, PA (Fac ID No. 93044) and the other above-mentioned stations, (the "Station Employment Unit"), to the March 21, 2022 random audit issued in accordance with the provisions of 47 C.F.R. § 73.2080(f)(4) of the FCC's Equal Employment Opportunity (EEO) rules.
