FIRST AMENDMENT TO PROGRAMMING AGREEMENT

This First Amendment to the Programming Agreement (this "Amendment"), dated as of March 22, 2023, is by and between Cumulus Broadcasting LLC ("Operator"), and Life Church Wichita Falls, Inc. ("Programmer").

WHEREAS, Company and Programmer are parties to that certain Programming Agreement dated July 1, 2022 (the "Agreement") pursuant to which Programmer provides certain programming to the Operator's radio station KQXC-FM in Wichita Falls, TX ("Station");

WHEREAS, it is the parties' intention to amend certain terms contained within the Agreement;

NOW, THEREFORE, in consideration of the above recitals and the mutual promises and covenants contained herein, the parties, intending to be legally bound, hereby agree as follows:

1. Section 2.1 of the Agreement is hereby deleted in its entirety, and the following shall be inserted in lieu thereof:

2.1 The term ("<u>Term</u>") of this Agreement shall commence on July 1, 2022 and shall terminate on the earlier of (a) June 30, 2024 or (b) such time as this Agreement is terminated in accordance with Section 13 hereof.

- 1. This Amendment represents the complete and total understanding of the parties with respect to the content thereof and cannot be modified or altered except if done so in writing, executed by all parties.
- 1. This Amendment shall in no way modify, alter, change or otherwise delete any provision of the Agreement unless specifically done so by the terms of this Amendment, and all the remaining provisions of the Agreement shall remain in full force and effect.
- 1. The construction and performance of this Amendment will be governed by the laws of the State of Texas without regard to conflict of law principles.
