Quarterly Issues Program List for Station –KSIR October - December 2023

Assessment of Issues for this quarter: Issues important to our community are gleaned from Federal agencies, ag organizations and local Chambers of Commerce, law enforcement, business owners, city/county/state employees, politicians, other media, Facebook and Twitter postings, conversations with community members at community concerts, special events and other functions in the communities of our listening area.

Section I. Issues.

A. Education: Discussions with organization leaders, water educators, and Colorado State University Extension especially as it relates to the region's agriculture industry.

B. Government: The general discussion of policies related to our government both statewide and local issues. Government programs, state ballot initiatives, and bills.

Section II. Responsive Programs

The station has broadcast programming dealing with each of the above-referenced issues. Programming dealing with each issue is set out below.

<u>A. Education</u>: Discussions with organization leaders, water educators, and Colorado State University Extension especially as it relates to the region's agriculture industry.

Daily Ag Interview. Broadcast on October 6. Duration: 12 minutes. Discussion with Kit Carson County CSU Extension Specialist, Ron Meyer. He recommended perennial weed control efforts be talen now, and gave a wheat planting and corn harvesting update. He also talked about millet, rye, and an upcoming crop clinic. Interview conducted by Lorrie Boyer.

Daily Ag Interview. Broadcast on October 18, 2023. Duration: 11 minutes. Discussion with Morgan County CSU Extension and Livestock Specialist, Marlin Eisenach. He talked about the fair board meeting to review the fair and take in comments and suggestions then make changes as they deem fit, end-of-year programs, including the carcass contest, corn harvest, and livestock care heading into winter. Interview conducted by Lorrie Boyer.

Daily Ag Interview. Broadcast October 27. Duration: 12 minutes. Discussion with Golden Plains Area CSU Extension Specialist, Travis Taylor. He talked about winter cattle feeding, corn stalk care, hay values, and cattle size. Interview conducted by Lorrie Boyer.

Daily Ag Interview. Broadcast November 6. Duration: 8 minutes. Discussion with Kit Carson County CSU Extension Specialist, Ron Meyer. He talked about corn harvest and storage, sunflower harvest and storage, and winter program meetings coming up. Interview conducted by Lorrie Boyer.

Daily Ag Interview. Broadcast on October 9, 2023. Duration: 11 minutes. Discussion with R-CALF United Stock Growers of America, Bill Bullard. He talked about anti-trust issues in the cattle industry and gave an RFID tags update. Interview conducted by Lorrie Boyer.

Daily Ag Interview. Broadcast on October 13, 2023. Duration: 9 minutes. Discussion with National Farmers Union Education Coordinator, Lisa Buckner. She talked about the recent Beginning Farmers Institute and an upcoming women's conference. Interview conducted by Lorrie Boyer.

He talked about their annual meeting next week, gave a farm bill, and gave a federal milk marketing order hearing update.

Daily Ag Interview. Broadcast on December 4, 2023. Duration:11 minutes. Discussion with Mountain Region Field Director of the National Agriculture Statistics Service, USDA, Rodger Ott. He reviewed the latest and last monthly Colorado Crop Progress

and Condition report, went over the November Crop Production Report, the latest Cattle on Feed Report, the latest Chicken and Eggs Report, and reviewed the latest Ag Labor Report. He then talked about upcoming surveys and the Census Report. Interview conducted by Lorrie Boyer.

Daily Ag Interview. Broadcast on December 7, 2023. Duration: 9 minutes. Discussion with Colorado Colorado Farm Bureau Vice President of Strategy and Advocacy, Ashley House. She talked about the need for the next Farm Bill to be passed early in 2024, Lands Bills in Colorado in the 2024 legislative session. Interview conducted by Lorrie Boyer.

Daily Ag Interview. Broadcast on December 8, 2023. Duration: 9 minutes. Discussion with National Farmers Union Vice President of Government Advocacy, Mike Stranz. He talked about state Farmers Union meetings that he attended, the Farm Bill Process, and the 2024 legislative session. Interview conducted by Lorrie Boyer.

Daily Ag Interview. Broadcast on December 11, 2023. Duration: 10 minutes. Discussion with R-CALF United Stock Growers of America CEO, Bill Bullard. He talked about the new USDA rules that require purchasing US-born, raised, and slaughtered beef for school lunch programs, he talked about what is going on with Paraguay beef imports, the sheep industry issues that could filter in the beef industry on imports, and the cattle markets. Daily Ag Interview. Broadcast on December 26, 2023. Duration: 12 minutes. Discussion with Nikki Jones, with IDEag, a branch of the American Farm Bureau Federation that is in charge of event planning. She talked about the Colorado River Drought Task Force, Colorado Ag legislation to watch for in 2024, and their upcoming annual meeting. Interview conducted by Lorrie Boyer.

Daily Ag Interview. Broadcast on October 9, 2023. Duration: 8 minutes. Discussion with State Specialist in Specialty Crops and Colorado Fruit and Vegetable Growers

Association working board member, Adrian Card. He talked about upcoming meetings and issues this past summer in the state's specialty crop industry. Interview conducted by Lorrie Boyer.

Daily Ag Interview. Broadcast on December 28, 2023. Duration: 10 minutes. Discussion with the General Manager of the North Sterling and Prewitt Reservoirs, Jim Yahn. He gave a reservoir storage update, talked about the South Platte being a "free river" right now, the recent South Platte River Forum, and gave an update on what is going on between Colorado and Nebraska regarding the Perkins Canal.
