This letter is an access request to the CEO managers and / or presidents and / or the legal counsels representing the following broadcast networks and stations:

ABC, NBC, CBS, CNN, PBS, FOX, in Florida, WEDU-TV, Tampa; in the state of New Hampshire, NHPTV, WMUR-TV, WBIN-TV, and in Iowa, Iowa PBS.

Dear Sir or Madam,

This is a reasonable request for access, under 47 U.S.C. Section 312(a)(7) to deliver a live broadcast speech, before the 2012 vote for president, and this is Michael Stephen Levinson's final request to your station or network for access.

The evening I seek, is from 8:00 P.M. to 10:00 P.M. on November 1, 2012, live, from one of your studios.

Please be advised, the 11th Circuit Court of Appeals, reversed its dismissal of my case against [some of] you and has agreed to hear the case, on appeal from Middle District of Florida, Tampa Division where I originally called for an **ORDER TO SHOW CAUSE** why your broadcast licenses should not be **REVOKED** for your willful and repeated failure to allow access to me, the appellant.

I realize, relative to 11th Circuit Court of Appeals, you were never served in the lower court, because the Magistrate judge challenged my petition and refused to grant in forma pauperis status and I could not afford the postage or the printing to send you the notice, at least not until the threshold case issue of my First Amendment right was decided in the lower court.

Now that IFP status has been granted in the Appellate court, and the case may be heard or remanded to the lower court, this request for access may very well become part of the skin in the 11th Circuit Appellate Court.

In the event you honor this access request **I will allow that you have fulfilled your lawful obligation to my First Amendment right as a candidate for president in this election.** Good for you, as your entities are worth a great deal of money, and you could lose all. I believe you will.

Let me explain to you why I say that: In my original request I submitted my **Exit Strategy out of Iraq**, which is on my website and in the book I also submitted to you: *New World Hors D'oeuvres*. While you are not permitted to judge the merits of my ideas, you are obligated to at least look at them in order to make a reasonable judgment on my request. When something is frivolous it is like pornography—you know it when you see it.

My plan was to invite 40,000 American citizens to go to Iraq, using retrofitted four wheel drive quad cab vehicles from truck dealerships that would include dealership installed truck body armor, extra drums of gasoline, freeze dried foods, and police radar guns with CB radios dash installed.

The idea was for the ten thousand retrofitted quad cab trucks to travel in groups of forty, seal all the borders, visit every town, pass out copies of our constitution translated into Arabic, grant Iraq favored nation status and purchase with cash all their dates, figs, and nuts for export, and invite 50,000 of their children to come and live with an American family for a few years until it was safe to be in Iraq.

The parents and their children would have state of the art cell phones so they could see and talk to each other every day, and the whole of Iraq would be our second strongest Middle East friend.

Had we sealed the borders between Iraq and Iran, all of the remote detonated bombs would not have been smuggled in. Thousands of lives would not have been lost. All of the oil and gasoline would not have been smuggled out of Iraq to Syria, as is happening every day, today, enabling the Syrian government to make war against its own unarmed citizens.

Had you not suppressed my First Amendment right to deliver a broadcast speech our country would have adopted this non-partisan volunteer citizen strategy and the whole complexion of the Middle East would be safer, and better today.

My willingness to grant your fulfillment of my constitutional right to speech would moot the issue of your earlier willful and repeated failures to allow access, but you have to grant my request.

Otherwise we shall proceed into the federal court(s) after complaint and hearing with Federal Communications Commission.

The ten states where I am qualified to be voted for as a candidate for president of United States are New Hampshire, Iowa, Alabama, Nebraska, New Jersey, Oregon, Pennsylvania, Rhode Island, Vermont, and Washington.

I will articulate during my live televised political speech an explicit program to provide medical coverage for the 47 million people living in America without coverage, carefully explaining the short and long term cost, and how as president I propose that we, the American people will pay for my innovative program that eliminates both government and insurance bureaucracies.

I will carefully explain how, within six weeks of enactment, all the American people will have access to medical coverage at a projected half the cost of the Affordable Care Act, passed by Congress two years ago.

Regardless who is elected next president, I hold the view it is my non-partisan Lev program, The Lev Health Care Plan that will readily be adopted to solve our medical inequities as a nation, and upon solving this issue, put our nation in a better economic position, relative to world commerce.

It is not unreasonable to use **30 minutes of airtime** specifically for just this issue to show how, without an Act of Congress we can provide medical access for our whole nation, at the same time lowering the rising costs of medical delivery.

This also relates to foreign affairs because world wide, people will want to come to USA for our medical services.

In the marketplace of ideas it is important that I, Michael Stephen Levinson show you ideas. Here is a further explanation of a non-partisan medical program that affects the economic health of our whole nation:

My solution simplifies this issue: We voluntarily charge ourselves **two cents gratuity** on everything we purchase at all our fast food chains, also Wal-Mart, K-Mart, Target and every supermarket nationwide.

40 items in a supermarket easily rings up \$150. Would another eighty cents, tip for the lowliest workers matter? At the week's end we divide the pennies in tips by the hours that were worked so cashiers,

burger flippers and baggers each gets a dollar an hour raise with the overage dollars in tip money going to their **Medical Assurance Savings** account.

Your account goes with you when you move on to another job. 12 million people will have Medical Assurance accounts to share with their spouse and family.

At year's end the 12 million healthy will have medically banked easily a quarter billion dollars in case they get sick, and 24-30 million loved ones will be sharing the same health care blanket, because of our voluntary pennies.

\$5 a week is earmarked for the **Catastrophic Illness Pool**. After six weeks, 360 million will be in that account to cover every potential surgery. People suffering with pre-existing conditions will be invited to join.

Car dealerships and other companies that provide health insurance will migrate to **Medical Assurance Savings** accounts. With my Loose Penny program funding our non-profit-motivated Medical Assurance Pool, everyone will be covered, living longer, healthier lives.

For success we need a one-line change in our tax code. Medical professionals must be allowed to do \$50,000 a year in charity that is deducted off the top of their income – then, after all their deductions an additional \$25,000 off their bottom line, so the Dr.'s and Dentists can look forward to **Freedom of Income Tax**.

Every doctor will have a sign outside: "No insurance? I'm here." The loss of tax dollars is off set by the savings in Emergency Rooms. Unless there is an actual emergency people will be given a list of charity professionals who will treat them.

The two-penny gratuity doesn't come out of management's pocket, but **work place production will increase because of it**. When someone quits, the crew might ask management to let the crew pick up the slack. One less hire means more money for everybody working.

Dr.'s will compete to treat you. You agree to their fee, the Dr. swipes your Assurance card to secure the money, fulfills the treatment and collects, without insurance people compromising his treatment.

I also plan a doctor-supported Malpractice Pool to further lower medical professional's costs.

The long-term solution is free medical education for all related medical personal, our goal 100,000 doctors graduating every year until there is one family doctor per thousand people. Presidential leadership prevails, not Congress or lobbyists.

During my proposed 120 minutes speech I will also delineate my **Exit Strategy out of Iraq and Afghanistan**, both of which differ from the administration's policy and candidate Romney's policy.

I am not leaving anything to guess about my candidacy. My Exit Strategy even today allows us to exit Iraq with honor, and all the Iraqi people our allies in the Middle East, as firm as our alliance with Israel.

The Exit Strategy out of Iraq is also on my campaign web site: <http://www.michaelslevinson.com>.

The American people, en masse are entitled to this Exit Strategy, to determine the soundness of my Exit Strategy upon hearing it in a live, uncensored political speech, and to decide for themselves whether my plan gets us out of Iraq, and also Afghanistan, with honor to the memory of those who gave their lives defending our First Amendment way of life.

My strategy for Afghanistan will behead both the remaining al Qaeda and the Taliban! The American people are entitled to hear what I have to say about this issue as I seek the office of president to lead the nation. My approach to this key issue, as our commander-in-chief is important. We cannot plan on leaving Afghanistan until al Qaeda is decapitated and the Taliban disbanded, whereupon, based on the murder of four Americans, one an ambassador, in Benghazi, Libya, clearly al Qaeda is again on the rise.

I will explain during my speech how we are going to take them down, and I am more than willing to explain this to you in a telephone conference call so you understand my candidacy and my programs.

The administration had planned to negotiate peace with the Taliban and that is a giant mistake. I will explain why this is a crucial mistake to the voters during my speech. I know exactly what we must do and I believe the American people will stand with me in agreement. My plan will save the lives of our troops and also the innocent people of Afghanistan.

I seek the time for my live political speech, a **First Amendment right, in the Public Interest**, for the express purpose of explaining the solutions to all the problems we face, both domestic and foreign, in advance of my election.

It is not unreasonable for me, the candidate for president to also devote ten or fifteen minutes to how I am going to settle the issues between the Palestinians and Israeli people, setting the stage for genuine peace in that part of the world with the American people first, as Peace in the Middle East is also a foreign affairs issue.

The American people are entitled under our law, to hear and see what I see in order to judge whether or not I should be their president to carry forth with my peace plan for the planet—our good ship mother earth.

Upon my giving an unencumbered live televised speech to the American people without collecting even one dime in advance from anybody, I will have delivered the most information of any candidate, and upon that, may be overwhelmingly elected, which is my purpose in seeking access from your network or station.

We find in the Communications Act of 1934 [as amended 47 U. S. C. A.] Section 312(a)(7) is the 'affirmative right of access for individual candidates for federal elective office.' The statute authorizes the Commission, in this matter, down a short road, a Federal Court, or the Supreme Court, to:

(R)evoke any station license or construction permit - for willful or repeated failure to allow reasonable access or to permit purchase of reasonable amounts of time for the use of a broadcast station by a legally qualified candidate for federal elective office on behalf of his candidacy.

I hold the view it is the obligation of the Federal Court to uphold and protect my affirmative Right of access to a broadcast network to make a political speech on behalf of my candidacy for the office of president of United States.

The FCC may be in charge of bandwidth issues, and auctioning licenses, but I believe, cannot constitutionally be in charge of our First Amendment rights to our own airwaves.

Therefore, your refusal to timely respond to this request for access may be construed before the court, as the, "willful and repeated failure to allow reasonable access or to permit purchase of reasonable amounts of time for the use of a broadcast station (or network) by a legally qualified candidate for federal elective office on behalf of his candidacy."

Let us be clear I see a way for me to pay for the time and that, to your satisfaction before the program airs, so the dollars involved in the cost of my exercising my Freedom of Speech right are not an issue.

I believe you don't want that to take place before FCC, or in a federal courtroom procedure. The federal government is obligated to remain neutral in the marketplace of ideas. In so doing a court is liable to at least examine the contents of the candidate's request, to judge your good faith.

I am legally qualified to be voted for, and to hold the office of United States president. I am actively seeking the office of president. I hold the view that giving a live broadcast speech on your network, or station is the key to my winning this election for the office of president.

This request for access is within the Public Interest, as it is the paramount Right of the electorate to be an informed electorate, as much as it is my First Amendment Right to deliver a live televised broadcast speech, as is my intent in filing this access request with you.

In the whole history of political broadcasting I am the only candidate for president to have exercised this right to broadcast political speech on a television network. I refer you to the live speech I gave before the New Hampshire primary, in the PBS NHPTV studio, during the primary campaign, 1988.

You should review that speech. You will see that I displayed a few pages from my Television Scripture describing the global warming and the arctic ice caps melting, c. 1971. Visit my web site, <http://michaelslevinson.com>, where you can view the speech divided in three parts.

You will also see tape of my unscripted press conference in the office of New Hampshire Secretary of State, William Gardner, in New Hampshire, October 15, 2007 where I publicly declared I was independently seeking the nomination of both political parties, to unite our country to set the stage for world peace.

A primary issue to be covered in my intended campaign speech includes, **The Vehicle for World Peace**, that being my **Television Scripture**, the prophetic magnum opus written in design to perform on world wide television, from dusk until dawn, for all the world's peoples to sea, listen to, and be a part of all at once. I believe each of you networks has a first edition copy of **The Book ov Lev It A Kiss**, in your files.

There are many prophetic passages from **The Book ov Lev It A Kiss**, my hand lettered Vehicle for World Peace, quoted in "New World Hors D'oeuvres, including a description of the global warming and arctic ice caps melting c.1971 that is on the tape of the 1988 speech delivered live in the NHPTV studio.

Every major political event in the Middle East, since 1971, was carefully described in advance, in **The Book ov Lev It A Kiss**. There are dozens of world events explicitly described in advance in the hand lettered **The Book ov Lev It A Kiss** that I call The Television Scripture. For example:

Nixon is described leaving the White House, in disgrace, Gerald Ford named to replace him, this written down before Gerald Ford was chosen to replace Spiro Agnew. The name of Pope John Paul I, the 33 day Pope was stated, along with a description of his dying. This was c. before there was a John Paul 1.

Governor Wallace gets a shot in the back. Richard Nixon's domestic adviser, John Erlichman grows a beard and disappears, behind bars. Spiro Agnew is a tragic hero over money. The Persian Gulf War is foretold, when it would happen, where it would happen, how it would be fought and who would do the fighting, and how it would turn out are carefully described. All of these events and more were all lettered, in advance, in **The Book ov Lev It A Kiss**, c. 1971.

The American people are entitled to this prophetic information, entitled to judge for themselves whether or not your applicant candidate is a prophetic man with prophetic words written down for all mankind, to be performed on world wide television, from dusk until dawn, like old blind Homer, with every line a delicate sensible rhyme, rivaling Dante, of Divine Comedic fame; and how as president I will be able to give this world wide performance and thus establish world peace, beginning with a peaceful night.

My proposed world wide Homeric, dusk until dawn performance, with every line a delicate sensible (multilingual) rhyme will suffice our first peaceful night in 5000 years of recorded history, a world event that I can only achieve as president of United States.

The electorate is entitled to determine this for themselves, during the political contest upon us, during my live broadcast televised speech on your station, channel, or network. Any attempt to suppress my request for access violates the access law, grounds to revoke your broadcast license.

I wait to hear from you, to read your press release, and my telephone to ring.

I have previously enclosed a copy of my home page, of my presidential web site. My presidential political campaign web site is getting thousands of hits every month. This is to show you that I am actively campaigning, via Internet in all fifty states for the office of president of United States.

Live televised speech is a privilege we give to candidates for president.

I bring to the table more than a prophetic Television Scripture, written down c. 1971, to perform live on world wide television, from dusk until dawn, for all the world's peoples to be a part of all at once.

With my total communication plan, the whole world will be doing the same thing at the same time: watching me Tell Lev Vision with my every line a delicate sensible rhyme. World Peace on good ship mother earth begins with a peaceful night.

Who could be against a cultural world peace event, apart from the ghosts of J. Edgar Hoover, and those who hallowed him?

This is the good ship Mother *Urf*. Whatever deck you live on, the cards are dealt out evenly. When it comes time to change the course of human history, on good ship Mother earth, all the world cries out for is a spokesman, a spokes person, to turn the wheel; iambic man I am!

Rhyme is my crime, word orders, and new world hors d' oeuvres; but I could be denied my *whirled* wide pizza delivery until Bank Mother Nature begins foreclosure, and from her climate calamities, our world commerce shrunk, her good life on this water planet, for centuries, totally crapped.

As our world's ecology simmers away, my Vehicle for World Peace is ready to go. The time approaches to unlock my mull tie work of art and roll, or pay the price. My Television Scripture deserves a Nobel Prize for Literature, waiting to happen; my night long twelve "our" video *trans crypt* to come, the Peace Prize.

Cap that with my inspired 3-D model that I will display for America's viewers and listeners from your studios, during my political broadcast, showing how we generate funds to clean the air and water, and raise living standards worldwide. With my *eggs pan ding* economic model, beer cost a nickel, and space travel free. Might that economic model qualify as hat trick: a 3rd Nobel Prize?

Today's moribund economy is an giant issue! Whoever can bring our nation back to prosperity should be president and will be elected. I will explain everything the American people need to know in order to decide during my initial speech. Overpriced fuel is crimping every dollar, pushing the cost of every commodity up, except for people's wages, which are stagnant.

My mortgage renewal plan saves every house and protects lender banks, with all homeowners gaining. That requires a full 15-30 minutes to do the mortgage renewal program justice.

I have a credit card reform plan that does the same for credit card holders, as for mortgage payers, and at the same time improves our homeland security. My credit card reform requires 15-30 minutes to show how the expansion of the country's credit worthiness will immediately begin to rejuvenate our economy.

My drug prohibition programs require a full half-hour as my drug reform program includes the war in Afghanistan—how we should be fighting that undeclared war. Illegal drugs involve billions of dollars in illegal commerce that feeds criminal cartels. We must as a nation get a handle on this activity. I intend on explaining how we can do that to the benefit of all.

Health care is an issue that has not gone away. As above, my Medical Assurance program covers the whole country within six weeks, without an Act of Congress, but for a one-line change in the tax code.

My program will enable all the states to expand their Medicaid coverage without busting their state budgets! Every company that provides shared health care coverage for its employees will save money and the employees' coverage will be increased.

To fully explain why and how my Medical Assurance works requires 15-30 minutes of careful explanation, which the electorate, entitled to health care, is entitled to. Thirty minutes for this issue is very reasonable.

I have four explicit jobs programs that we could start to be having tomorrow a.m. My programs will employ long-term 5-7 million people.

I propose we build ten thousand hybrid clipper ships to carry our imports and exports. The ships will be outfitted with solar voltaic sails to generate electricity, winch driven rotational masts to catch every gust, and electric winches to raise and lower sails.

We export and import more than any other country. Everything for sale in USA, whether Kool-Aid, soap, or toothpaste, is exported. All we take for granted: cooking oil, grains, whatever you see on our shelves, and more, we sell worldwide, including our technologies.

The ships will be powered by the sun and driven by the wind, crewed by college students paying reduced tuition, getting their lectures delivered over Internet, so with or without a cargo the ships are making money and pay for their building carrying cargo.

Shipyards connected to Universities and colleges will spring up wherever there is water and people need work, up and down the Great Lakes, the East, West, and Gulf Coasts. My clipper shipbuilding program is

major for U.S. to rejuvenate the world's economy besides a long-term solution for ending our jobless slump.

Building 10,000 clippers will create, within a few years, millions of semi-skilled jobs, leading to even better, fully skilled jobs! Not everyone dreams of operating a computer, writing software, or working on the Internet. For many people, a decent paying job, where they can train while working, and grow into skilled labor carpenter positions, or plumbers, and electricians, building ships with their hands, is a dream come true, trades they can use wherever they go.

As President I will use my influence to see university endowments invested in shipbuilding. Harvard might have forty ships in their fleet, freeing up 1600 seats for the freshman on land.

Companies, Apple is a good example, are sitting on hoards of cash with factories overseas producing products they sell in US. These companies, with tax incentives besides, will be encouraged to invest in clipper ships building. The clippers will carry their goods. We can say to any country we will import all of your goods as long as your export goods come on our ships. 30 minutes for this issue of three million jobs is reasonable.

Another of my proposals is to turn every residential house into an energy incubator. Every roof can be reroofed with solar voltaic shingles. Every roof can have passive solar panels to heat water, and every roof can have a residential wind turbine at the sidewall peak. Then when a terrible storm comes and knocks out the electrical grid, people will not be prisoners in their own homes, unable to keep their houses cool in brutal heat.

The utilities can underwrite the improvement loans and the loans can be repaid from the energy savings. Every home improvement company in the country will be hiring.

What is required of the President is an Executive Order suspending regulations that prohibit residential wind generators within city limits. 1-2 million jobs will be created from this energy money saving program.

A 3rd job creation act requires an Executive Order: All the paper used by the Federal Government and all clothing worn by our military shall be manufactured from the production of industrial hemp, grown by American farmers.

We need to plant every available inch of lawn in USA with hemp and harvest the plant using technology to keep the carbon dioxide trapped. In this manner we have a chance as a world to absorb all of the man made carbon dioxide corrupting the balance of life on our planet. Every country uses paper. Every person

wears clothing. We need to migrate from cotton to hemp! This hemp growing and plant maintenance will create an additional half million jobs.

The trees we don't cut down for paper products can be harvested to build the clipper ships.

As noted on CBS **60 Minutes**, Sunday October 21, 2012, there is the issue of ending the drug prohibitions and treating marijuana for what it is: a medicinal plant that should be available for all who use it without a dr.'s prescription. This change in the laws via Executive Order needs a half hour of broadcast time.

Those who support the criminalization of a medicinal plant that grows in the ground have done a tremendous job demonizing the plant and creating false realities about the plant's properties. It is not good enough in any political campaign to state a position about these issues without a careful explanation.

Another of my plans, **for national security purposes**, is to nationalize the Gulf of Mexico oil wells. The BP seam, the scene of the blowout tapped into a wealthy of under—the-sea oil that runs the girth of our whole planet. There is enough oil there to pump ten million barrels a day every day for the next hundred years. We will become the world's largest oil producer and with the control of that oil be in an economic position to lead the world to peace.

Those oil assets will go to cleaning the Gulf of Mexico ecology, paying all the residential real estate taxes nationwide, and providing free college education for all who qualify. The issue is national security!

We need economic rejuvenation. My mortgage plan calls for purchasing every bank held mortgage with an original financial instrument: **U.S. Mortgage Savings Bonds**. The Bonds, backed by the good faith of the American people cannot be redeemed until the mortgages are paid! They are also backed by private property on which the U.S. Bonds are written.

We pay 85 cents on the good, 65 cents for bad, and 49 cents for ugly; 52 million mortgages, refinanced with 15-30 year fixed rates, according to your credit: 4% for triple A up to 7% for late pay deadbeats.

Banks can go with us or slide down their own foreclosure drain. Regardless, we are purchasing all their mortgages, top shelf triple A or troubled. We are entitled to the fruits of our labors, **this repurchase by Executive Order**, my first day in our Oval office.

Retooling millions of mortgages can be accomplished with a fail-safe do-it-yourself, online program, or figured by neighborhood tax preparers. Every homeowner benefits from a restructured fixed mortgage. The world's *e con oh me* will settle into non-inflationary growth.

We tack on non-interest bearing 2nd mortgages to cover the upside-down money in homes that swapped and sold for twice their value before the bubble burst, toxic still, after our buy out whack, so people can remain in their dream house, draw down their debt, and eventually, as prices inch up, their mortgage paid down, see their liens paid off fair and square, with a reasonable portion of equity intact. This is a great way to stabilize sub-prime sub-divisions. Foreclosed houses devalue the whole artery.

After our repurchase, the renewed mortgages shall be divided amongst the bank branches in the same zip codes, for servicing.

We let the bank branches hold twelve payments of 'our' money. With a year of mortgage money, the branches are flush with capital to make loans in the neighborhoods where the mortgage money is paid; where jobs are created. Branches can provide operating capital to all the businesses in their zip codes the old fashioned way, after visiting the business.

There is *in tryst* on our Mortgage Savings Bonds with which all the home mortgages were purchased. There will be *in tryst* on our money, which we are letting bank branches use expressly for loaning out to neighborhood businesses hungry for capital.

Interest accrued from our trillion-dollar mortgage purchase will be washed, boxed and locked, sent to Washington every month! The spread on our 52 million home mortgages will go to lowering our national debt and after that, replacing our income tax!
