PRE-FILING ANNOUNCEMENT

On September 27, 2011 Radio Station WWZW was granted a license by the Federal Communications Commission to serve the public interest as public trustees until October 1, 2019.

Our license will expire on October 1, 2019. We must file an application for license renewal with the FCC by June 1, 2019. When filed, a copy of this application will be available for public inspection during our regular business hours. It will contain information concerning the Station's performance during the last renewal period.

Individuals who wish to advise the FCC of facts relating to our renewal application and to whether the Station has operated in the public interest should file comments and petitions with the Commission by September 1, 2019 by writing the Federal Communications Commission, Washington, D.C. 20554.
