#### Issues and Programs

WGLC covers a wide variety of subjects and issues that concern residents of the immediate and surrounding listening area. #### **Issue: Animal Welfare**

Program: Talked about adoptable pets available at local animal shelter, Illinois Valley Animal Rescue. Aired 1/8/24 at 6:40am for 30 seconds.

#### **Issue: Arts and Culture**

Program: The Starved Rock Foundation is inviting the community to the ribbon-cutting ceremony of its newly revitalized audio/visual theater at the Starved Rock State Park Visitor Center. The ceremony will be from 9:30 to 11:30 a.m. Sunday, Jan. 7, to celebrate the successful completion of this \$40,000 audio/visual theater upgrade. Aired 1/2/24 at 7am for one minute.

Program: Comedian Lee Hardin will be performing at Stage 212 in Lasalle this Sunday. News: The Knights of Columbus donated \$8,182 to Ottawa Friendship House to support individuals with intellectual and developmental disabilities. With this year's donation, the organization has donated \$100,000 in the past decade towards the fundraiser. Ottawa Friendship House provides comprehensive support through its range of programs for individuals with Intellectual and Developmental Disabilities in Ottawa and its surrounding suburbs. Aired 2/1/24 at 6am for 30 seconds.

Program: Ottawa Noon Rotary donated \$1,140 to the Ottawa Community Food Basket. With this, the Food Pantry can purchase over 2,300 pounds of food. This is in response to a Rotary district-wide challenge to donate food to those in need. Rotary is a global network of 1.4 million members with the goal of uniting people and creating lasting change. ### **Issue: Community**

Program: Layla S. Madrigal said hello to the world as La Salle County's first baby of 2024. Layla was born at OSF St. Elizabeth Medical Center in Ottawa on Jan. 1 to parents Yuridia Rivera and Miguel Madrigal Jr., of DePue. The bundle of joy weighed 7 pounds, 13 ounces and measured 20 inches long. Aired 1/3/24 at 6am for 30 seconds.

Program: OSF HealthCare announced the opening of a new OSF Medical Group – Obstetrics & Gynecology office in the Illinois Valley. The clinic, located at 920 West St, Suite 100, in Peru, is set to open on Tuesday, Jan. 9, offering women's services to the community. The Peru clinic will be open 8 a.m. to 5 p.m. Monday through Friday, except every other Wednesday, 8 a.m. to noon. Aired 1/8/24 at 8am for one minute.

News: Anthony Graham, of Ottawa, has qualified as a quarterfinalist in The Greatest Baker competition – a contest featuring the best bakers from across the United States. Graham took first place in his group. Graham said he has been baking for about eight years and started baking to unwind after a busy work week but became passionate about the baking process over time. He said if he wins the competition, he hopes to open a bakery selling everything from cheesecake to cupcakes, pies and cake. Aired 1/16/24 at 7am for 30 seconds.

News: The city of Oglesby is looking to create an emergency plan that includes temporary shelter for those in need. The Oglesby City Council discussed these plans in a meeting Monday, and there were talks of the shelter possibly assisting migrants. These conversations are on hold as the LaSalle County Board votes on a no-sanctuary resolution Thursday. City Officials say there have been plans for instances such as bomb threats all along and are hoping to make the shelter plans official soon. As far as migrants are concerned, officials say their shared consensus is for first responders to bring the migrants to common areas, supply them with food and water and then transport them to state welcome centers. **Issue: Economy**

News: A new downtown business group, Ottawa Downtown Association, kicked off late last year with the goal of supporting downtown Ottawa businesses as well as residents and tourists. To get their name out, the ODA started with a Christmas window decorating contest in December. The group is working on an event to fundraise for the ODA. They also hope to coordinate sidewalk days and other events. For more information, follow Ottawa Downtown Association on Facebook. Aired 1/31/24 at 7:02am for 35 seconds.

News: Peru library will undergo construction in about four weeks to begin on the youth services wing. During construction, the lower level of the library will not be accessible to the public. Morning programs, such as Books and Babies and Thursday Tots, will take place upstairs in the teen services area. Library officials say the library has been saving up funds for the project for “quite a while” and is expecting to spend a little more than \$100,000 on the project. **Issue: Education**

News: Waltham Elementary School in Utica has decided to bring in a therapy dog. On Wednesday, Superintendent Kristi Eager said the animal in question, a pet belonging to math teacher Dan Gustafson, was brought into the school on a trial basis. The dog, she said, is being trained and certified at Gustafson’s expense. She said the dog remains Gustafson’s pet, and the district won’t incur any costs for food, lodging or veterinary care. News: The Etzenbach family donated \$100,000 to establish a new scholarship for students at La Salle-Peru High School pursuing a college degree in engineering. This scholarship is established in honor of LPHS graduates William and Gerry Etzenbach. William was a long-time civil engineer and president of Chamlin and Associates in Peru. ### **Issue: Environmental Issues**

Program: Eagle Watch Weekend is around the corner at Starved Rock State Park, coming the weekend of Jan. 27 to 28, but residents don't have to wait to spot the majestic birds. Starved Rock Lodge has Bald Eagle Trolley Tours running throughout the month, including one at 11 a.m. today. The trolley will go to the Illinois Waterway Visitor Center on Dee Bennett Road, just outside Utica, for eagle viewing and an educational program. The lodge also provides guided winter hikes to Starved Rock's waterfalls and for views of the bald eagles from high spots in the park. Aired 1/4/24 at 7:15am for one minute.

News: La Salle County will be hosting free electronics recycling events April 20 and Oct. 5. Residents are limited to two televisions per vehicle and must register before the events. Registration information and a flyer with acceptable items will be posted at [www.lasallecountyil.gov](http://www.lasallecountyil.gov) about three weeks before each event. ### **Issue: Government**

News: Gov. J.B. Pritzker on Wednesday named his director of juvenile justice to take over the troubled Department of Children and Family Services. Heidi Mueller, 49, will replace Marc D. Smith, who has been at the helm since 2019 and has been held in contempt of court numerous times for improper housing of young people under the agency's care. Aired 1/3/24 at 5pm for 30 seconds.

News: A Lasalle County Board Member has filed an objection challenging the legality of President Biden's nomination papers in Illinois. Beth Findley-Smith joined Timothy Conrad in petition on reason of the president not using an Illinois notary on his statement of candidacy she says is required by Illinois Election Code. The objection claims Biden used David E. Kalbaugh, a notary commissioned in the District of Columbia. Findley-Smith and Conrad are requesting for President Biden's name to be removed in Illinois as the democratic nomination in the March 19 primary election. Aired 1/16/24 at 7:33am for one minute.

News: The city of Streator will receive \$750 thousand dollars in federal funds earmarked by U.S. Representative Darin LaHood. The funds are for reconstructing the Iowa Avenue truck route, a project a part of LaHood's Community Project Funding Grants. With the funds, the city plans to install curbs and gutters from the 100 to 900 block of Iowa Avenue. The city will also have to financially contribute to the project as well. Officials say the project will not begin until next year. Aired 3/22/24 at 10am for 30 seconds.

**Issue: Health/Wellness**

News: As a partner in the international DAISY award program that recognizes the extraordinary clinical skill and compassionate care of nurses, OSF Home Health recently presented its DAISY award to Tricia Kessel, RN. Kessel joined OSF HealthCare following the closure of Prairieland Home Care, where she had served the local community with home care for five years. Residing in Oglesby, Kessel's commitment to providing compassionate and high-quality care has now been acknowledged through the DAISY award. The nomination for Kessel highlighted her proactive approach to patient care. Aired 1/4/24 at 5pm for one minute.

News: Several northern Illinois counties are seeing an uptick in COVID-19 and now are newly listed at the high or medium level for hospitalizations. More than half of all Illinois counties have elevated levels of the coronavirus, IDPH officials announced Friday. Compounding the issue, the state overall has moved to high risk for respiratory illness levels, including the flu or RSV. The latest numbers show that Lee, Ogle, Boone and Winnebago counties are labeled high, meaning there were at least 20 COVID-19 patients hospitalized in the week per 100,000 people in the population. They are among 18 counties statewide now in that range, the IDPH said. Kane, Kendall, DeKalb, LaSalle, Bureau, Putnam and Grundy counties remain at low risk. Aired 1/8/24 at 6:32am for one minute.

News: OSF HealthCare announced the addition of Dr. Vijay Sharma, MD, to its team of dedicated healthcare providers in Ottawa. Sharma will be available to see patients at the OSF Medical Group – Primary Care office located at 1614 E. Norris Drive, Ottawa. Sharma earned his medical degree from the Windsor University School of Medicine and completed his residency at Southern Illinois University Decatur Program. **Issue: Home and Lifestyle**

News: A Boil order has been put in place for Peru residents following the repair of a water main break. The order applies to residents in the 600 and 700 blocks of Ninth Street and Prospect Avenue and is in effect until further notice. Officials recommend letting your water run if it appears initially rusty. Aired 1/25/24 at 7am for 30 seconds.

News: A La Salle business owner could face up to 15 years in prison if convicted of trying to evade paying state sales taxes for more than two years. Aired 2/1/24 at 9am for 30 seconds.

### **Issue: Tourism**

Program: Illinois Beach Hotel will reopen its doors next month. Located in Zion within Illinois Beach State Park, the hotel has 92 rooms, with many lakefront views to choose from. Guests also have access to a private beach and Lake Michigan. Those looking to host events such as weddings and receptions can also utilize the hotel's Grand Ballroom. ### **Issue: Traffic and Safety**

News: LaSalle County Sheriff's Office partnered with the Illinois Department of Transportation and law enforcement across the state for the holiday "Drive Sober or Get Pulled Over" drunk-driving enforcement campaign. From Dec. 15 through Jan. 2, the LaSalle County Sheriff's Office showed zero tolerance for impaired driving, arresting offenders for the deadly crime. Seat belt-18, Speeding-21, Distracted driving-5, No Insurance-10 and other traffic citations-24. Aired 1/2/24 at 7:30am for 30 seconds.

News: A winter storm warning was issued for Bureau, Putnam and Marshall counties until 6 p.m. Wednesday, according to the National Weather Service in the Quad Cities. A winter weather advisory, however, has been issued for La Salle County until 6 p.m. Tuesday. For Bureau, Putnam and Marshall counties, heavy snow is expected. Total snow accumulations could amount to 7 to 12 inches. Winds could gust as high as 40 mph Tuesday afternoon through Tuesday night leading to considerable blowing and drifting snow, according to the warning. Aired 1/8/24 at 5:03pm for 30 seconds.

Program: Construction on Route 6 in Lasalle and Peru is set to begin this summer. The approximately \$5.6 million project will stem from the Little Vermillion River to the Bureau County line and the work is expected to be spread out between the 2024 and 2025 construction season, according to officials. Citizens can expect resurfacing, traffic signal upgrades, and Americans with Disabilities Act ramp upgrades as a result. Officials say traffic will be impacted during construction. Aired 1/19/24 at 9am for one minute.

News: The Illinois Department of Transportation announced that construction on Interstate 80 in Grundy County will begin on Monday. The work will take place in both directions of travel on

the interstate between the Route 47 interchange, also called exit 112, and the Seneca interchange, also called exit 105. Workers will be patching and resurfacing the roads due to damage from the weather. One lane from each direction will be open and daily closures are expected. Aired 2/15/24 at 10am for 30 seconds.

### **Issue: Veterans**

News: World War II veteran Francis “Kay” Killelea turns 104 in June. He served in the 86th infantry in Europe, then was in the Philippines about to move into Tokyo Bay when the war ended.
