EEO Narrative Statement

The licensee, Iroquois County Broadcasting Company, has continued to achieve broad and inclusive outreach in the past two years. Given a fairly homogeneous labor force in the county in which the community of license is located (89% white/non-Hispanic, and 51% female, per the Illinois Department of Employment Security), all of the station's seven fulltime employees are white/non-Hispanic, and five are women. The station has recruited and hired one new employee in each of the past two years, in each case a white female for (the same) Account Executive position.

Station management regularly participates in annual job fairs hosted by Kankakee Community College (station management participated in the 2018 and 2019 events, but the 2020 job fair was cancelled due to COVID-19). In 2018, the stations' General Manager made a Rotary Club presentation at Kentland, Indiana (20 miles away from the station). In each of the past two years, station personnel have participated in Career Day programs at Watseka High School. The stations offers an internship to any interested Watseka High School student, but there have been no takers in the past two years.

As reflected in its annual EEO public file reports, recruiting announcements and information concerning station internships are regularly sent to the Illinois state broadcasters association, to four area colleges, and several online media job sites. The same information is broadcast over the facilities of WIBK(AM) and WGFA-FM themselves.

Despite its best efforts, the licensee has not been successful in recruiting a substantial pool of minority applicants for any advertised openings. A single minority applicant, who applied for a **part-time** position as a sports announcer, concluded that not enough hours were available to make it worth his while.
