

KJJC TV COMMERCIAL LIMITS
AND WEB SITE RULE COMPLIANCE CERTIFICATION.
FIRST QUARTER 2019

FOLLOWING IS A LIST OF ALL KJJC TV PROGRAMS DESIGNED TO MEET THE EDUCATIONAL / INFORMATIONAL REQUIREMENT FOR CHILDREN THIRTEEN TO SIXTEEN YEARS OLD DURING THE FIRST QUARTER OF 2019, JANUARY 1, 2019 THROUGH MARCH 31, 2019. BECAUSE THESE PROGRAMS ARE ORIGINALLY PRODUCED FOR AND DIRECTED AT CHILDREN THIRTEEN TO SIXTEEN YEARS OLD, NEITHER THE COMMERCIAL LIMITS NOR THE WEBSITE RULE APPLY (SEE 47 C.F.R. § 73.670 (Note 2)). THIS CERTIFIES THAT ALL OF THESE PROGRAMS WERE FORMATTED (IN THE ORDER AND AT THE TIMES INDICATED) WITH THE FOLLOWING COMMERCIAL LOADS.

ALTHOUGH THESE PROGRAMS ARE NOT SUBJECT TO THE WEBSITE RULE BECAUSE THEY ARE PRODUCED FOR AND AIMED AT CHILDREN 13-16, NONETHELESS KJJC TV HAS ENDEAVORED TO COMPLY WITH THE RESTRICTION ON URLS DISPLAYED WITHIN SHOWS (SEE SECTIONS 73.670(b), (c) AND (d) OF THE RULES OF THE FEDERAL COMMUNICATIONS COMMISSION, 47 C.F.R. § 73.670(b), (c) AND (d)).

NONE OF THESE PROGRAMS CONTAINED ANY URLS, WITH THE POSSIBLE EXCEPTION OF (a) FICTIONAL URLS IN PROGRAMMING, (b) URLS OF COMMERCIAL-FREE WEBSITES THAT SATISFY 47 C.F.R. § 73.670(b), OR (c) URLS, NOT UNDER THE CONTROL OF THE LICENSEE, OF NON-PROFIT OR GOVERNMENT ENTITIES WITHIN PUBLIC SERVICE ANNOUNCEMENTS AIRED ON BEHALF OF THOSE ENTITIES, OR MEDIA COMPANIES IN PARTNERSHIP WITH THOSE ENTITIES.

CHILDREN'S E/I AIRED ON DIGITAL SUBS:

In addition to its main program stream, KJJC airs 4 additional digital streams. Each stream airs 168 hours per week (total of 672 hours per week).

One of the additional streams airs Children's E/I programming 24 hours-per-day. Virtually all of the programming aired on this stream between 7:00am and 10:00pm qualifies as Core Programming, as defined in the Rules. As such, KJJC is providing more than 100 hours per week of commercial-free Children's E/I programming which qualifies as Core Programming under the Rules. In this Report we document at least the minimum required amount of Core Programming aired on KJJC's main stream, and digital subs.

KJJC has included the following programs on its quarterly Children's Reports in order to demonstrate compliance with its requirement to air the amount of programming designated in the Rules.

None of these programs, and no promotional or public service announcements scheduled by KJJC within or adjacent to those programs, contained any URL's, with the possible exception of (a) fictional URL's in programming, b) URL's of commercial-free websites that satisfy 47 CFR Section 73.670 (b) or (c) URL's not under the control of the Licensee, of non-profit or government entities, within public service announcements aired on behalf of those entities, or media companies in partnership with those entities.
