

WLS-TV LICENSE RENEWAL ANNOUNCEMENT CERTIFICATION

I, Ellen Crawley, hereby certify that WLS-TV broadcast pre-filing and post-filing announcements, using the texts attached hereto, on the dates and times listed below.

Due to an inadvertent administrative error, the post-filing announcement scheduled for September 1st did not air as originally scheduled. This error occurred due to the many last-minute changes caused by both network and local news coverage of Hurricane Katrina, which had preempted a number of regular programs and the commercial and promotional spots that would have been included in those programs. In the process of attempting to reschedule missed spots, the post-filing announcement scheduled for September 1, 2005 was mistaken on the log for a mere station promotional announcement, which the station would have had discretion to move, and was replaced with a different promotional announcement, which in turn was replaced with a commercial. As soon as the problem was discovered, WLS-TV ran a "make-up" post-filing announcement for the one missed post-filing announcement. This announcement aired on Thursday, September 8, 2005, the same day of the week and the same time of day as the September 1 announcement would have aired.

To compensate additionally for this unfortunate error, as well as an error in the text of the announcements that was discovered after the make-good announcement aired on September 8, 2005, additional "make-good" announcements were broadcast as listed below.

In all, WLS-TV ran four (4) pre-filing and eleven (11) post-filing announcements at the following dates and times.


