

Pursuant to the provisions of the District of Columbia Code, § 29-604, the undersigned adopts the following Article of Amendment to its Certificate of Incorporation:

The name of the corporation is Greater Washington Educational Television Association, Inc.

The following amendment to the Certificate of Incorporation was adopted by the corporation in the manner prescribed by the District of Columbia Code, § 29-604:

Add to Article III

"In the event of the dissolution or termination the remaining assets of the corporation will be distributed exclusively for the educational or exempt purposes specified in section 501(c)(3) of the Internal Revenue Code of 1954."

The above amendment was adopted by the consent in writing ~~thereto attached~~ of all members of the Board of Trustees of the corporation entitled to vote with respect thereto.
