CERTIFICATE OF INCORPORATION

The undersigned, for the purposes of creating a corporation, not organized for profit, pursuant to Chapter 6 of Title 29 of the District of Columbia Code, do hereby adopt the following Certificate of Incorporation:

ARTICLE I. - The name of this corporation shall be:
The Greater Washington Educational Television Association, Inc.

ARTICLE II. - The term for which the corporation is organized shall be perpetual.

ARTICLE III .- The purpose and object of this corporation shall be to furnish a non-profit and non-commercial educational television broadcast service to the Greater Washington Area and to make available to the educational and cultural institutions and organizations willing to provide suitable television programs the necessary physical facilities and operational staff. To that end, the corporation shall be empowered to obtain and to hold appropriate Authorizations from the Federal Communications Commission; to construct, operate and maintain a non-commercial educational television station used primarily for transmitting educational, cultural and entertainment programs and for serving the educational needs of the community. pursuant to the rules and regulations of the Federal Communications Commission governing non-commercial educational television stations; to obtain or to held by contribution, deed or lease real or personal property and funds to be used in connection with the operation of its television station; and to solicit and accept, in trust or otherwise, money and property to be used for these purposes. This corporation will not conduct business for profit. No part of the net carnings of this corporation will inure to the benefit of any private shareholder or individual, and no substantial part of the activities will be to carry on propaganda, or otherwise attempt, to influence legislation.
