Amendment for Multiple Ownership/Cross-Ownership Rules

Current radio license dispersal in our market area, as of 01-26-2022

Nielson only samples county by county here in Curry County New Mexico, making an accurate determining of signals difficult in the "local area".

Please be advised per your records the following exist in 3 tiers, City of License, 10 miles from City of License, and area stations at less than 25 miles from Clovis New Mexico.

In Clovis there are 6 High Power FM's, KRMQ at 101.5 and KSMX at 107.5, KELU 90.3 and KAQF 91.1. And (KCLV KTQM) 2 owned by Zia Broadcasting Company. Also, Zia owns 2 AM stations, KCLV and KWKA.

7 miles away over the West Texas Border sits Farwell Texas with High Power signals, KIJN 92.3, and KICA 98.3 Dark for 3 years but relicensed anyway?

Farwell also has KIJN AM at 1060.

Neighboring cities in Texas include Bovina with FM at 96.5 KKNM, and in Friona KGRW at 94.7.

Also, in the 20-25 miles ring around Clovis New Mexico is Portales New Mexico, with 2 High Power FM, KSEL at 105.9, and KENW at 89.5.

Lastly is KSEL AM 1450.

Summation:

Within 25 miles city of service we have a total of 12 High Power FM Stations, (again 2 owned by Zia Broadcasting) and part of this application.

Within the same 25 miles there are 4 AM stations of which 2 are owned by Zia Broadcasting Company. There is no issue with location and ownership diversity in our market. Every requirement has seemingly been met.
