Special operating conditions or restrictions:

- The permittee/licensee, in coordination with other users of the site, must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of the FCC guidelines.
- The licensee has demonstrated compliance with the FCC radiofrequency electromagnetic field exposure guidelines based upon the use of the antenna specified herein. If the licensee makes any changes in the facilities via a modification of license application in accordance with 47 C.F.R.
