Missy claims her nieces were severely neglected, alleging

neighbors often found them wandering around their apartment complex dirty and without shoes, inside a dumpster and playing by a busy freeway and vacant buildings. Chris and Katie insist that despite being drug addicts, they were and are great parents and never put their daughters in danger. They say Missy has taken their children from them, and that she is on a power trip, even asking for child support. See what happens when Dr. Phil shows Chris and Katie photos of the alleged living conditions of the apartment that they were raising their girls. Will Chris and Katie continue to insist their daughters were never in harm's way?

Michelle denies trying to hire a hitman but admits she has kept their children from Tom because she claims he is a “dangerous narcissist” who believes he is “90 percent smarter than the rest of the human race” and has physically attacked her and their children – an accusation Tom denies. She also claims that he tried to get her to believe that she was Mary Magdalene. She also claims he told her that he spoke regularly to the Archangel Michael and made her life a living hell. Jem claims that Joshua tried to brainwash her while they were together. Joshua, who is currently homeless, says he believes his contact with the *Dr. Phil* show has been divinely inspired to allow him to spread the word of God and heal his family.
