HE ALSO PLEADED GUILTY TO SEVERAL MISDEMEANOR COUNTS OF DOMESTIC ASSAULT.

HE WAS ARRESTED LAST DECEMBER FOR ASSAULTING HIS WIFE IN CORINTH.

DURING THE INVESTIGATION DETECTIVES LEARNED OF SEVERAL MORE ASSAULTS THAT HAD OCCURRED DURING THE SIX MONTHS PRIOR TO THAT ARREST.

CLAWSON WAS SENTENCED TO FOUR YEARS IN PRISON WITH ALL BUT SIX MONTHS SUSPENDED.

HE WILL SERVE A TOTAL OF FOUR YEARS OF PROBATION FOLLOWING HIS RELEASE.
