Discussion of issue: There were 565th mass shooting this year. Psychiatrist Jonathan Metzl discussed why red and yellow flag laws don't work. For instance, many laws and policies have been passed and more are being passed that protect gun ownership. 440 million guns are already in circulation. Background checks and red flag laws are not enough, according to Mr. Metzl. Unfortunately the US does not have the collective political will to take serious action on mental health and the easy access to weapons of mass destruction. Other groups are focusing on electing officials who will enact more serious gun safety laws. As a practicing psychiatrist, Mr Metzl can't predict which mentally ill person will use a gun and which one will not. In fact, most people with mental illness are victims of gun violence, not perpetrators of it. In fact, most people who commit gun violence are not mentally ill. There are 48,000 gun deaths a year from all causes, accident, suicide, partner violence, gang shootings, and mass shootings.

Rates are based on zip code in which you live. In setting up Medicare, Congress inadvertently created a dough-nut hole between benefits and age and income of the insured.
