Broadcast one time per day on the **1st and 16th days of June, July and August**. Stations broadcasting primarily in a foreign language should broadcast the announcements in that language.

Broadcast at least three of the six required announcements between 7 a.m. and 9 a.m. and/or 4 p.m. and 6 p.m., at least one announcement between 9 a.m. and noon, at least one announcement between noon and 4 p.m., and at least one announcement between 7 p.m. and midnight. For stations which do not operate between 7 a.m. and 9 a.m. or between 4 p.m. and 6 p.m., at least three of the required announcements shall be made during the first two hours of broadcast operation.
