Section 3: WADL-TV continues to have a stable work force. WADL does not experience a great amount of turnover in full time employees, with the exception of Account Executives, Master Control Operators, Accounting Assistant, and Traffic assistant within this past year. However, WADL-TV has taken steps over the last year to achieve a broad and inclusive outreach in the community for actual vacancies and positions that have opened up for full time employment.
