### **KENTUCKY NEWSMAKERS (Local Public Affairs Program)**

Host – Bill Bryant. 30-minute programs with various community leaders and politicians discussing issues facing our city and state during July, August & September 2006.

GUEST: Caleb O. Brown, KentuckyVotes.Org  
DATE: Saturday, July 1, 2006  
TIME: 7:00-7:15 pm  
TOPIC: Caleb Brown's organization tracks Legislation and the voting record of all Kentucky Lawmakers. He got busy again last week when the Legislation came to town for a lightning fast special session. They discussed what the Legislature did in its 5 days in Frankfort, the constitutionality of parts of the state budget with some financial institutions filing suit, and the controversy in recent weeks about state government employees being able to read blogs and access certain websites.

GUEST: Stan Cave, Governor's Chief of Staff  
DATE: Saturday, July 1, 2006  
TIME: 7:15-7:30 pm  
TOPIC: Governor Fletcher lost his running mate a month ago when Lt. Governor Steve Pence decided not to seek re-election, and then refused to step down when the Governor asked him to resign. Now Senate President David Williams declines to endorse the Governor and says he and other leading Republicans have "serious doubts" about whether Ernie Fletcher can be re-elected. Still, the Governor's loyal Chief of Staff says things are going well and he believes Governor Fletcher can be re-elected.

GUEST: Bob Babbage, Kentucky Political Observer  
DATE: Saturday, July 8, 2006  
TIME: 7:00-7:15 pm  
TOPIC: Bob Babbage, a former statewide office holder who began his career in Lexington politics. Babbage also ran for Governor for the Democratic Party, but has openly endorsed Republicans. Bob Babbage says Governor Fletcher is unopposed right now. They discussed how the resignation of Lt. Governor Steve Pence will hurt the Governor's chances of re-election,

and who will likely be running against Governor Fletcher – former Governor Brereton Jones, Auditor Crit Luallen, former Lt. Governor Steve Henry, or Congressman Ben Chandler?

GUEST: Larry Forgy, Kentucky Republican Activist  
DATE: Saturday, July 8, 2006  
TIME: 7:15-7:30 pm  
TOPIC: Larry Forgy worked for a Governor in the 1960s and 1970s, he ran for Governor in the 80s and 90s, and now Larry Forgy is defending Governor Fletcher against criticism from within his own party. Forgy says Republicans are making a mistake to pick apart one of their own party in the year leading up to statewide elections. They also discussed if the Governor would have to stand trial on the misdemeanor charges.

GUEST: Mark Nickolas, BluegrassReport.Org  
DATE: Saturday, July 15, 2006  
TIME: 7:00-7:15 pm  
TOPIC: Mark Nickolas is used to stirring up hornet's nest, but this time Mark Nickolas has kicked it up a notch, suing the Governor for blocking state employee's access to his website. The blogsite "Bluegrass Report.Org is often critical of the Fletcher administration. In fact, on first reference, it usually calls Ernie Fletcher "Indicted Governor Fletcher." But the administration says it's just trying to keep state employees from wasting taxpayer's money by surfing the web during work time. Nickolas has sued and was present when Representative Kathy Stein announced legislation to restrict restrictions on web surfing.

GUEST: Bill Farmer, Endorsing Teresa Isaac for Mayor  
DATE: Saturday, July 15, 2006  
TIME: 7:15-7:30 pm  
TOPIC: The old saying goes politics make strange bedfellows and so it struck some as odd when Councilman Bill Farmer endorsed incumbent Teresa Isaac's re-election bid. After all, Farmer had run against Isaac in the May primary and a few weeks ago he gave the Mayor an "F" for the way she's conducted herself in office. Now he's on her team, Councilman Bill Farmer is here to explain and to talk about where his own future goes from here.

GUEST: John Stempel, PhD/UK Patterson School  
DATE: Saturday, July 22, 2006  
TIME: 7:00-7:15 pm  
TOPIC: What are we to make of the escalating hostilities in the Middle East. It's difficult for the average person to understand the historic and continuing violence. In Kentucky, students study world situations at the UK Patterson School of Diplomacy and International Commerce. Faculty members are not only scholars, but in many cases they have also been in the Diplomatic services themselves. Dr. Stempel explained why there has been a sudden spike in violence in the continuing conflict between

Lebanon and Israel.

GUEST: Representative Lonnie Napier, Republican – Lancaster  
DATE: Saturday, July 22, 2006  
TIME: 7:15-7:30 pm  
TOPIC: There are a lot of people who are trying to draft State Representative Lonnie Napier into the 2007 Governor's race. A couple of websites popped up last week touting two Republican potential candidates for Governor – one for Congressman Hal Rogers has since been taken down. But another is an attempt to draft Lonnie Napier who has served in the legislature from Garrard County for more than 20 years. Napier has said that effort is snowballing. Discussed was his interest in running.

GUEST: Ron Crouch, Kentucky State Data Center  
DATE: Saturday, July 29, 2006  
TIME: 7:00-7:15 pm  
TOPIC: Kentucky is growing and becoming better educated. What areas are seeing the strongest growth? What's the future look like? Ron Crouch is a nationally recognized expert on population trends calls Kentucky home. He explained the new numbers that are encouraging for the commonwealth.

GUEST: James Carvelle and Mary Matalin  
DATE: Saturday, July 29, 2006  
TIME: 7:15-7:30 pm  
TOPIC: James Carvelle is a Democratic strategist who first came to fame helping Wallace Wilkinson win the Kentucky Governorship, then he helped Bill Clinton win the White House. Mary Matalin is a Republican Consultant who has worked in numerous campaigns and has been a key political advisor to both George Bush's. They shared thoughts on various topics.

GUEST: Bill Nighbert, Kentucky Transportation Secretary  
DATE: Saturday, August 5, 2006  
TIME: 7:00-7:30 pm  
TOPIC: A summer of major construction and repairs and new rules on the road. Workers are racing to get Lexington ready for the World Equestrian Games, plans continue for I-66, the new interstate across Southern Kentucky. The Kennedy Bridge that spans the Ohio from Louisville needs to be painted by so far the state hasn't found a painter. Charges of intimidation against Secretary Nighbert were recently dismissed by a Judge, the Secretary has always maintained innocence in the merit hiring investigation.

GUEST: U.S. Representative Ben Chandler, Kentucky 6<sup>th</sup> District (Democrat)  
DATE: Saturday, August 12, 2006  
TIME: 7:00-7:30 pm  
TOPIC: Terrorism grabs worldwide attention again, gas prices climb, violence

continues in the Middle East, a minimum wage increase fails, and many are pressuring today's guest to leave it all in Washington and run for Governor. Stem cell research passes Congress and is then vetoed by the President. Congressman Chandler is the only member of Kentucky's delegation who voted for it. Many Kentucky Democrats are urging today's guest to return to his home state and run for Governor again.

GUEST: Michael Gobb, Bluegrass Airport  
DATE: Saturday, August 19, 2006  
TIME: 7:00-7:15 pm  
TOPIC: A huge project at Blue Grass Airport this weekend – the facility is shut down for repaving – no flights in or out of Lexington. Michael talked about the massive project and how often it has to happen. They also talked about changes in service coming on in the following months.

GUEST: Darrell Brock, Jr., Kentucky Republican Chairman  
DATE: Saturday, August 19, 2006  
TIME: 7:15-7:30 pm  
TOPIC: Dissension within the Kentucky Republic Party, Governor Fletcher is now saying "bring it on" to those who say he should abandon his race for re-election. The latest round has Secretary of State Trey Grayson urging Governor Fletcher to abandon his bid. Lt. Governor Steve Pence who took himself off the ticket for next year, also says the Governor should re-evaluate the future. So far Ernie Fletcher is not budging.

GUEST: Kentucky Governor Ernie Fletcher  
DATE: Saturday, August 26, 2006  
TIME: 7:00-7:30 pm  
TOPIC: Charges are dropped against Governor Fletcher. Is it a good day for the Governor? Can he win re-election? Or is too much damage done? An agreed order this week allowed the Governor to acknowledge that mistakes were made in the way his administration hired people. The Governor was able to stop short of saying he did anything criminal. The Governor learned that it's OK if he sets up a defense fund where contributors could help pay his legal costs.

GUEST: Greg Stumbo, Kentucky Attorney General  
DATE: Saturday, September 2, 2006  
TIME: 7:00-7:15 pm  
TOPIC: He admonishes about preying on plane crash victims, agrees to dismiss charges against the Governor, and cracks down on internet pharmacies. In recent weeks, he put gasoline stations on notice about price gouging, he signed an agreed order that ended his office's 15 month probe of hiring within the Fletcher Administration and he quickly let other lawyers know that they approach victims of the Comair Crash at their own peril. In fact, Stumbo says those lawyer may be violating a Federal Law if they try to take advantage of families who lost loved ones in the crash.

GUEST: Karen Engle, Operation UNITE  
DATE: Saturday, September 2, 2006  
TIME: 7:15-7:30 pm  
TOPIC: Operation UNITE has grabbed headlines by sending drug dealers to prison, educating communities about drugs and helping addicts seek treatment. It operates in the 29 counties that make up the Fifth Congressional District – an area that has had notorious problems with Meth labs, Oxycontin addiction and prescription drug abuse.

GUESTS: Major Alecia Webb-Edgington, Kentucky Homeland Security Director; and General Donald Storm, Kentucky Adjutant General  
DATE: Saturday, September 9, 2006  
TIME: 7:00-7:30 pm  
TOPIC: Are we safer now than five years ago? Are we better prepared if something does go wrong? It was a horrible attack on this country, exposing our vulnerabilities as a Nation on 9/11. But it also caused America to respond and resolve to do better. In Kentucky, the issue of homeland security has also been addressed and efforts are stepped up to make the Commonwealth's Citizens safer.

GUEST: Mike Gobb, Blue Grass Airport  
DATE: Saturday, September 16, 2006  
TIME: 7:00-7:15 pm  
TOPIC: Nearly three weeks after the tragedy of Comair Flight 5191 crash, how is Mike Gobb coping with what happened? It had already been a tough year for Lexington's Airport, passenger numbers were off and the competition fierce with others trying to lure travelers away. Then came the horror of August 27<sup>th</sup> when a Comair Jet crashed in the pre-dawn darkness. From the beginning there were indications the plane had tried to take off from the wrong runway which was too short. What factors were at play that led to that fatal mistake? How does Blue Grass Airport restore the confidence of travelers?

GUEST: Jim Newberry, Candidate for Lexington Mayor  
DATE: Saturday, September 16, 2006  
TIME: 7:15-7:30 pm  
TOPIC: He wants to lead Lexington and is running a strong challenge to the incumbent Mayor. Jim Newberry finished a strong second in the May primary, just behind incumbent Mayor Teresa Isaac. Now Newberry's race is underway in earnest. He also just returned from the World Equestrian games in Germany. Newberry has carefully laid out his plans in growth, development and public safety over this year. How will he finish his campaign?
