On 10-10-07, Officer Patrick Lambakis responded to a residential burglary at 7124 NW 19th St. (Case #07-12108). The victim of this burglary was David Mathis. Mr. Mathis had a video surveillance system in his home that recorded four suspects burglarizing his home. After a hard week of investigating and with no suspect leads as of yet, Officer Lambakis contacted Sana Syed of Fox 25 News to see if she could air the video of the suspects to see if anyone could identify them. On 10-21-07, Sana Syed and John Biebrich, also of Fox 25 News, went to the Mathis residence and did a news story on the Mathis burglary. Then, on 10-22-07 the story aired, and immediately the Bethany Police Department started receiving numerous telephone calls in reference to the identity of the suspects on the video.

On 10-24-07, the first suspect turned himself in to the police, and later that night a second suspect was apprehended. Two days later, the other two suspects involved in the burglary turned themselves in to the police department. This would not have been possible if not for the exceptional work done by Fox 25's Sana Syed and John Biebrich. The video work they did helped identify all the suspects involved and aided in their being brought to justice.

Therefore, on behalf of the Bethany Police Department, I would like to thank Sana Syed and John Biebrich for their hard work in assisting us with this case.




