

PRE-FILING AND POST-FILING RENEWAL ANNOUNCEMENT INSTRUCTIONS

The following three pages contain instructions for the broadcast of the pre-filing and post-filing renewal announcements for Sinclair's Kalamazoo station. Included with these instructions are the texts of the two types of announcements and a Statement Certifying Compliance that needs to be completed, dated, executed and **placed in the station's online public inspection file within seven (7) days** after the last post-filing renewal announcement has been aired or by **August 23, 2013**. If for any reason the station did not air the required announcement on the specified days and during the specified time periods, please contact the company's communications counsel before the Statement Certifying Compliance is finalized, dated and executed.

Pre-filing Renewal Announcements for WWMT(TV), Kalamazoo, MI, FAC ID 74195

The following pre-filing renewal announcement must be read over the air on each of the following days: April 1, April 16, May 1 and May 16, 2013. Of the four airings, at least two of these announcements must be broadcast between 5:00 P.M. and 10:00 P.M.

On December 20, 2011 WWMT(TV) was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until October 1, 2013. Our license will expire on October 1, 2013. We must file an application for license renewal with the FCC by June 3, 2013. When filed, a copy of this application will be available for inspection at www.fcc.gov. It contains information concerning the station's performance over the last eight years.

Individuals who wish to advise the FCC of facts relating to our renewal application, and to whether this station has operated in the public interest, should file comments and petitions with the FCC by September 2, 2013. In the case of unlinked logs:

Both parts of bookends and jigger tracks are combined.

Only the first member of a station group is shown, the rest differ from what essentially is sent.

In the case of linked logs both parts of bookends and jigger tracks are shown, each with their own ADL.

The counts for each group indicate the number of spots where it was possible to establish an equivalent ADL.

aaa indicates announcement is on locked log -> indicates announcement on unlocked log. Note that announcements placed on actual contracts will only show as such after media has been applied to the spots.


