Colleagues:

The balance of power in the US Senate is on the line on January 5, as the state of Georgia casts ballots in a special runoff election. Republican incumbents David Perdue and Kelly Loeffler face tough challenges from Democrats Jon Ossoff and Raphael Warnock.

NPR is making the NPR Special Events Coverage/Breaking News subscription (a.k.a. Breaking News Channel) in ContentDepot available to Member station WABE to facilitate station access to local coverage of this important story.

**TIMING AND PROGRAM DETAILS:**

From 8:00 PM to 10:00 PM Eastern Time, WABE will cover this story through its local broadcast service.

Host Rose Scott is joined by reporters Emma Hurt and Emil Moffatt of Member station WABE, NPR congressional reporter Claudia Grisales and NPR senior political editor and correspondent Domenico Montenaro. Confirmed live guests also include Georgia Secretary of State Brad Raffensperger, former Georgia Democratic Party Chair Nikema Williams. We'll also hear from former Georgia Democratic Gubernatorial Candidate and former GA House Minority Leader Stacey Abrams, who founded Fair Fight, a voting rights organization.

Again, this program is coming from WABE, but will be available on the NPR Special Events Coverage/Breaking News Subscription during that time.

For FCC purposes (47 CFR 73.1207(b)), WABE has granted consent to all NPR Member and other stations authorized to broadcast NPR programming to rebroadcast their signal until further notice. A copy of this consent notice should be retained in the files of all broadcasting stations in the event the FCC requests

it.
