Dear Mr. Bickel,

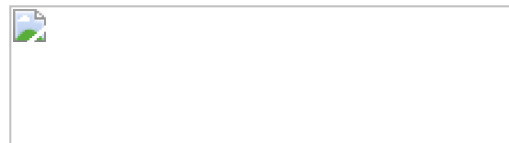
I am pleased to report that WMFL, licensed to Florida City, FL (FIN: 61088 ) for which the attached Engineering STA was issued has resumed normal operations.

The licensee remains solely and wholly responsible for maintaining compliance with such requirements.

Requests for extension of STA may be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation;

or

- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.
