Also discussed are the rights of people living with HIV in both living accommodations and the workplace. They also discussed whether younger people today are having conversations about HIV and AIDS.

BABY IT'S COLD OUTSIDE, January 21st, 12 noon

Mary Maguire of AAA Northeast told us about the work done by the Auto Club to help people bearing with the below-zero temperatures. She also offered suggestions for motorists to keep their vehicles running during the winter. The recommendations include testing the battery and if it doesn't work to replace it. Other recommendations include an emergency kit which includes flares, blankets, a shovel, de-icer; making sure there is a full tank of gas so the fuel line doesn't freeze; and checking that the tires are properly inflated and ready to handle any roads.

WHEN DISASTER STRIKES, January 21st, 12:30 pm

Kim Goulette, Executive Director of the American Red Cross of Central Massachusetts, shared with our listeners what to think about of in case their home is struck by a storm or a fire. She told about the teams of people who help those who are displaced by fire and the types of assistance that are offered to help people. This help includes assisting people to contact their insurance companies and others to help in the recovery process. She added that people affected by fires and other disasters should keep copies of important documents, extra keys, and other things like emergency funds if possible. She also talked about the need for blood donors all year round, especially donors who are Types AB and O, and the uses they have found for blood.

SUPER BOWL XXIII, January 28th, 12 noon

As the Patriots were making preparations for the Super Bowl, Victoria Lightfoot of the Atlanta Convention and Visitors Bureau talked about how the city has become a place that has welcomed millions of people. She talked about how this began after hosting the 1996 Summer Olympics, and how Atlanta has hosted the Super Bowl, the MLS Cup, and the Peach Bowl within the last 12 months and will be hosting the NCAA Men's Basketball Championships in 2020. She explains how the credit goes to the people of the city and Fulton County for making their city a place to visit or for some visitors, a place to eventually call home. Lightfoot outlined

the schedule of events for the city and surrounding area leading up to the Patriots and the Rams Super Bowl game.

WINTER -- AN UPDATE February 4th, 12 noon

For this program we began with a 15 minute conversation with Chris Besse of the Massachusetts Emergency Management Agency about how the commonwealth has held up during the Winter of 2019. We learned that residents have held their own during the season. Besse offered suggestions like the proper use of generators if your home loses power; the need for a Winter Emergency Kit which includes enough water, food, blankets and batteries for radios and flashlights; and how the state works with cities and towns during those times.

This show also includes a conversation with Larry Chretien, Executive Director of the Green Energy Consumers Alliance about making sure your home and vehicles are more energy efficient. Chretien explained how people take for granted that the heating system in their home is made to last for years; instead, homeowners need to do a better job of making sure heating systems are working properly. Among the recommendations are making sure heating systems, be they oil or gas, are inspected annually and tuned up. Chretian also explained how the fuels that are used in heating homes are burning more cleanly and efficiently, energy-wise. He explains that when the winter days where the temperatures reach 50 degrees or higher is a good time to get these accomplish these cahnges. Chretian finally discussed whether solar panels are right for your home, and the use and maintenance of wood stoves.

THE LITTLE ROCK NINE, February 11th, 12 noon

For this hour we re-aired a conversation from last year with Melba Patillo Beals, the author of "March Forward Girl." The book is about life growing up in Arkansas, and how she became one of the Little Rock Nine, the nine African-American students who integrated into Central High School in Little Rock, Arkansas back in 1957. She spoke about how then Arkansas Governor Orval Faubus fought to keep them out the school and how state authorities attempted to keep them out and cancel school for a year in response to the actions by the federal government. Beals also explains the decision by President Dwight Eisenhower to send federal troops to escort them to school.

SUMMER CAMPS, February 25th 12 noon

We devoted the program to looking at Summer Camps. Elizabeth Broughton, Day Camp Director at Mass Audubon Wachusett Meadow in Princeton, told our listeners about the opportunities and joys of outdoor summer camps in the area. She explains how at these

camps, kids as young as 3 years old can explore acres of land and trails, learn about habitats, look for frogs and salamanders, and have lunch at a picnic table with older kids. For the young kids, it's a chance to do things and enjoy new experiences without their parents. She also told us about programs they have for kids up to the age of 18.

And Mike from MassCamps.com told our listeners about a website that details the variety of summer camps that can be found in Massachusetts, the Northeast and Quebec, Canada. In addition to the types of camps - athletics, science, engineering, math, music, video games and more - there are listings for job openings at the camps. They also suggest that now is the best time to look for summer camps as a family can save money when it comes to finding and placing their kids in summer camps.

CLIMBING MOUNT KILIMANJARO, March 4th, 12 noon

Todd Spinney, an EDI Administrator at Stairlight Services, told our listeners about his plans to climb Mount Kilimanjaro in September to raise funds to benefit a walk for the American Foundation for Suicide Prevention. Spinney says his involvement in Spartan Races and competitions known as "Tough Mudders" has helped him to prepare for the challenge. He talked about the training that is involved in Tough Mudders, the materials he will need to help make the climb in September, the reasons for making the climb, and how this training has changed his life. Spinney explains that his goal is to climb more than 19,000 feet to reach the top of Mt. Kilimanjaro and his goal is raise over \$19,000 to benefit the foundation.

COURT APPOINTED SPECIAL ADVOCATES, March 11th, 12 noon

Robb Zarges, Executive Director of Court Appointed Special Advocates (CASA) for Worcester County, told our listeners how the first program began in 1981 with the goal of being the voice for children ages 12 and under who have no voice for them in court proceedings. Zarges says their organization has served as the advocate for 1,700 children in cases where their custody or the abuse of children are causes of concern. He discussed the worked done by volunteers, the training that is needed for volunteers who make the commitment and his appreciation of their willingness to look for the child's best interest in a Juvenile Court setting.

AMERICAN FOUNDATION FOR SUICIDE PREVENTION, March 11th, 12:30 pm

Michelle Lee, Associate Area Director for the foundation's Boston Chapter, spoke of how their organization learns about mental health and what can lead to suicide. She explained how there is no one cause that leads a person to take their life, but that the number of people taking their

lives continues to increase. She added how they are learning more about mental health, and the possible warning signs of someone dealing with depression could be suicidal. Lee explained how they are also looking at how to get people to discuss mental health, to support survivors of people who have committed suicide, to help people learn what to say if we know someone who is living with depression and how to listen to people who are struggling with life and keeping distance from others.

THE COST OF COLLEGE, March 18th, 12 noon

Bob Ballard, President and CEO of Scholarship America, told our listeners about their organization which began 60 years ago in Fall River, Massachusetts as one man set out to raise \$4,000 for a community scholarship program to send 25 people to college. Ballard explained that through their work they have become the great equalizer in helping people with money for college and helping elevate the hopes of families. Ballard said the first step in getting money for college is understanding the process for seeking financial aid which begins by filling out a federal form called a FASA (Free Application for Student Aid). He also talked about the types of scholarships and grants and when to start looking for funds. He added that the high school guidance counselor can play a critical role in helping students obtain financial aid.
