Discussion of issue: Councilman Chuck Grayeb was pleased to share the news of a major redesign of the two main arteries for traffic downtown, that being Adams and Jefferson streets. He mentioned that more people are moving to and living in downtown as Peoria is turning ever so slightly back to being an urban center. In total, the project will cost \$18.9 M over 2.5 years. Representative Grayeb mentioned the new restaurants springing up all over downtown. On the basis of the facts, Mr. Graber believes Trump to be ineligible, yet conceded that the Supreme Court could rule otherwise for various reasons.

Arguments were presented concerning the "self executing" nature of the Amendment. Also presented before the court was that Congress and the Courts have ceded over to the states immense authority over defining their ballots. Complexity of the state by state election process was discussed. Some states have direct election, while others use an elector/caucus method. Host Mitch Jeserich as well as guest John Nichols both sensed from the Supreme Court Justices that a ruling against the Colorado Court most likely and that it is Congress' role to decide who is an insurrectionist and who is not.
