
As you know, **NVT Hawaii Licensee, LLC or its predecessor in interest** and Oceanic Time Warner Cable entered into a retransmission consent agreement governing the carriage of the above-referenced television stations (the “Stations”) on your cable system(s) (the “Agreement”). Specifically, **NVT Hawaii Licensee, LLC or its predecessor in interest** granted Oceanic Time Warner Cable consent to retransmit the Stations on your cable system(s) within the **Honolulu, Hawaii DMA** and in significantly viewed counties outside of the **Honolulu, Hawaii DMA** through December 31, 2012 (unless earlier terminated).

In furtherance of the Agreement, please be advised that the undersigned licensee of the Stations licensed to the above-referenced communities, pursuant to Section 76.64(f) of the rules and regulations of the Federal Communications Commission (“FCC”), hereby confirms its election to invoke its retransmission consent rights under Section 325(b) of the Communications Act of 1934, as amended, and Section 76.64(a) of the FCC’s rules for the period beginning January 1, 2012 and ending December 31, 2014.

This notice is designed to serve as an election under applicable regulatory requirements and should not be construed as altering the Agreement’s terms and conditions.
