**Description:** WCKR REDUCED POWER OPERATION REQUESTED

WCKR'S EXISTING LICENSED ANTENNA SYSTEM HAS BEEN SEVERELY DAMAGED BY LIGHTNING AND CANNOT OPERATE AT MORE THAN 1.6KW. A NEW ANTENNA

SYSTEM IS BEING DESIGNED AND ORDERED TO ALLOW THE STATION TO RETURN TO FULL POWER AS SOON AS POSSIBLE. NORMALLY THIS COULD BE ACCOMPLISHED IN APPROXIMATELY 45 DAYS. IN AN ABUNDANCE OF CAUTION, GIVEN THE CURRENT DELAYS IN MATERIALS FOR MANUFACTURERS, WE RESPECTFULLY REQUEST A 6 MONTH STA AT 1.6KW HPOL AND VPOL WITH THE EXPECTATION THAT A NEW ANTENNA AND LINE CAN BE PROCURED SOONER THAN THAT.
