Over 100 migrants children were being held in the West Texas facility under poor health and hygiene conditions at multiple US Custom and Border Protection facilities in Texas. Unaccompanied children are intended to be transferred to the care of the Department of Health and Human Services, which is responsible for their care while placing them with a sponsor in the United States.

Guest: Lilian Paredes, with New Hope Immigration Services.

Ms Paredes talked about new rule. On Aug. 14, DHS published the final rule related to the public charge ground of inadmissibility. In summary, the new Public Charge rule dramatically expands the ability of the United States Government to deny residence cards to anyone who makes use of government benefits or who has used at least one public benefit in the past. In addition, it means that the residence card can be denied to anyone who presents the possibility of needing these benefits in the future based on factors such as age, family size, health and English proficiency.

Dallas County is one of the fastest growing economic regions in the country, yet the number of people living in poverty has increased 42% over the last 15 years. In Dallas County, only 37% of adults have a two- or four-year degree, yet 65% of living-wage jobs require an education beyond high school. The number of people in Dallas County who do not have the necessary skills and credentials is increasing and broadens the wage, talent, and opportunity gap in our region.

The Dallas County Promise scholarship will pay for the first two years of college or up to four years for eligible students within the Dallas County area.

Their main program that they spoke about its call: THE TYRO CHAMPION DAD PROGRAM. This program helps fathers and their kids with accepting their responsibilities for their decisions and encourages them to have a solid foundation in it. Offering series and class activities help participate to recognize bad choices and change the underlying assumptions, beliefs, attitudes and thinking patterns that have had negative consequences for themselves and families. This program provides: rigorous, integrated case management, mentoring for 1 year, on-going support services as needed. Mental help is also an essential part for the families to thrive.
