1/1	The State of the Church	Jim Schneider / Ben Everson	Ben Everson is an evangelist, a lyric vocalist, vocal coach and a clinician on a-Capella group techniques. He's a prolific songwriter as well as an accomplished recording engineer. He's been a guest lecturer at such places as Pensacola Christian College, Maranatha Baptist University, International Baptist College & Seminary and other locations. He's part of the teaching faculty of Majesty Music College Seminars.
			How does Ben classify the state of the church today? If he was presenting an address on the subject would he describe the church as awake or perhaps asleep and in need of being revived?
			While explaining he wasn't trying to dodge the question, Ben believes it's both. He sees some good things going on. For example, a lot of churches are embracing things on the technological side with the truth being transmitted through the airwaves, the Internet and the social media channels.
			On the negative side, Ben sees some churches giving in to the temptation to become so intellectual, especially within leadership, that the average church member, who doesn't know how to deal with sin in their life or fix their marriage, is being left behind.
			Ben also pointed to the needs in the political spectrum, such as defending freedom of religion, contrasted with the needs of individuals. While we stand against the political movements designed to take away our freedom, we must remember that there are souls within those movements that are in need of Christ.
			Jim then described how we are the salt of the earth as well as the light of the world. Do we get to choose between those two aspects? Ben responded once again by saying it's both.
			So does Ben believe the church is out of balance? Are we so concerned with things going on in Washington that we're neglecting the spiritual side of things? Or is it just the opposite? Are we so cloistered in our churches that we're neglecting what's happening in the world?
			Ben believes churches fall on either side of that. Part of his job going in is to discern where a particular church is on that spectrum. He mentioned how there's no impact without contact. So if we don't engage others around us, how can we imagine that we'll have any impact carrying the truth to them. On the other hand, we can get so caught up in the sphere of politics that we lose touch with spiritual reality.
			As this Crosstalk progressed, Ben presented his views on challenges that pastors face today, what people can do to encourage their pastors in the faith, his thoughts on prayer, details about his book on revival, a song from his family, where he feels the church is headed, and much more.

In fact, in this instance, certain faith leaders are 'coming out of the woodwork' in support of Islam.
			Two guests joined Jim to discuss this issue. One was Usama Dakdok. Usama is the president of the Straightway of Grace Ministry and speaker on the daily radio program, 'Revealing the Truth About Islam'. He's translated the Quran into English and has authored, 'Exposing the Truth About the Quran'.
			The second guest was Jeanette Ward. Jeanette is a school board member in district U-46 in the region of Elgin, Illinois. She's been serving since 2015 and has two children in this district.
			In 2016, the U-46 school board established a curriculum that Jeanette opposed. She described it as one that had a 'leftist' slant. The vote to approve was 6-1.
			On December 14th, her husband showed her what had been assigned to their elementary school daughter. Here are some quotes from the reading assignment (article) that required answering questions online:
			'Jesus, Mohammed and the Hebrew prophets all describe the same god.'
			'The god of the Old Testament can be both good and evil.'
			'Judaism, Christianity and Islam are three of the world's major religions. While they have many differences, they all believe in the same god.'
			Jeanette responded by taking screen shots of the article and then posted it on her board member page so that people would be aware of what was taking place.
			In the 'firestorm' that erupted, 18 faith leaders protested. According to Jeanette, they weren't bothered by the article itself but instead took issue with her Facebook posting of the article. No clergy came to speak on her behalf.
			Usama shared his thoughts on this situation, most notably how the God of the Bible and the god of Islam are not the same.
1/3	How Do We Handle the Immigration Issue?	Jim Schneider / Mark Krikorian	Mark Krikorian is the executive director of the Center for Immigration Studies. The center is an independent, non-partisan research organization in Washington D.C. that examines and critiques the impact of immigration (both legal and illegal) on the United States. He's provided frequent testimony before Congress.
			Immigration is a 'hot-button' issue that has many facets. Mark began by looking at Deferred Action for Childhood Arrivals (DACA).
			According to Mark, President Obama initiated DACA illegally when Congress wouldn't pass the 'Dream Act'. He decided to give work permits to about 700,000 illegal immigrants who came before they turned 16. President Trump has discontinued that program and it will disappear in March.
			So what do we do now? President Trump has indicated he's fine with proper amnesty for this narrow and unique group of individuals, but he wants Congress to handle it because it's not in his authority to make the laws. He insists that rather than giving this group amnesty, there must be some measures to balance this to limit the damage that DACA would cause.
			So for Mark, the issue comes down to what will end up in the deal that offsets the amnesty. Democrats want no offsets. They want a naked bill that does nothing but give amnesty. On the other side, President Trump and the Republicans admit that this special group of illegals constitutes a reasonable point of concern, but there has to be some special elements to any package that's worked out.

			One of the concerns for Republicans is that of 'chain migration'. Under 'chain migration', those that get 'legalized' are then able to sponsor their relatives who didn't come as children.
			Jim probed Mark more regarding 'chain migration' and asked if it leads to illegal immigration. For Mark, the problem is that 'chain migration' takes the decision over legal immigration away from the American people. So instead of having an immigration system based upon neutral or objective standards such as skills or education, yesterday's immigrants are the ones who get to decide who tomorrow's immigrants will be.
			Mark did point out that there are caps on various categories. For example, the adult brothers and sisters of American citizens category has a cap of 60,000 per year. That sounds like a lot, but there's about a million or more on a waiting list that want to come here under that category alone.
			The waiting list issue is a problem by itself because we tend to over-promise and under-deliver. For example, if we allowed everyone in who is a brother or sister, you'd have 2-5 million immigrants per year. So we limit the number, but that results in waiting lists.
			What Mark would like to see is a situation where we decide which groups of people we really want to let in, then let all of those who fit that narrow description in each year so you avoid the waiting list issue.
			As this program progressed, Jim and Mark looked at the connection between 'chain migration' and the visa lottery, e-verify, the border wall controversy, sanctuary cities, and more.
1/4	Deep State Sabotage	Jim Schneider / William Jasper	William F. Jasper is the senior editor of the New American. They focus on limited government, constitutional guarantees of freedom and personal responsibility. William has researched and written extensively on foreign and domestic politics, terrorism, national security, education, immigration, constitutional issues, the culture war and the United Nations. He's the author of 'The United Nations Exposed' and 'Global Tyranny-Step by Step: The United Nations and the Emerging New World Order'.
			Just before Christmas, C-SPAN aired an alarming interview that included Roger Stone, former advisor to President Trump, who indicated that members of his own cabinet are plotting to remove him.
			William admitted that Stone was very vague in the C-SPAN interview. On the other hand, William's colleague at The New American, Alex Newman, did a sit-down interview with Stone in Stone's studio in Florida. That interview (available at The New American website) is very alarming and confirms what some have seen develop over the past year.
			At this point, William defined the 'deep state'. This refers to individuals within the intelligence agencies and other various complexes within the U.S. government. He believes they've been moving behind the scenes to undermine the legitimate federal government. In fact, he sees the political operatives in control of much of the military, our intelligence, the bureaucracy, as well as within the media and political parties.
			Roger Stone admitted that there are those at high levels within the Trump administration, including his cabinet, his national security council, and his advisors in the White House, who've discussed how they plan to oust the president. They have a Plan-A, a Plan-B and a Plan-C.
			Plan-A involves using the 25th Amendment. In other words, it would be argued that President Trump is unfit to continue carrying out the functions of president. Normally this would include situations such as heart attack or stroke whereby the 25th Amendment would allow for continuity. However, advocates for this solution are claiming they don't have to prove that he's physically unfit, all they have to do is show that he's mentally and morally unfit, therefore he can be removed. That would require the vice president and a majority of the cabinet be in favor of removing him along with approval from Congress. If challenged by the president, the House and Senate would have to obtain a super-majority (two-thirds vote) in both houses to uphold the decision to remove him.

			Plan-B is being touted mainly by far-left individuals such as Maxine Waters. They've been calling for the impeachment of President Trump. William noted that top minds recognize that this is a long process. This is part of a 'death by a thousand cuts' scenario where Trump's opponents would continue attacking him with sex charges, Russia collusion charges, and anything else, hoping that this will cripple him.
			Plan-C is the extreme measure. That would be to assassinate the president. According to William, Stone actually said this.

			On January 1st, California opened the door for the recreational use of marijuana. Newsweek has reported that at least 12 states are poised to consider the legalization of marijuana.
			Dr. Stevens believes that part of the reason this is happening is because of big money. George Soros has poured 100 million dollars into the Drug Policy Alliance. That's a group that's pushing legalization across the nation. Also, in Colorado, they have 28 full-time lobbyists at the state legislature, more than on any issue.
			Marijuana back in the 60's had about 1% THC content. Today, the average across the U.S. is 12%. If you go to Colorado, it's about 30%. THC is a reference to the active substance in marijuana: Tetrohydrocannabinol. That's what gives the 'high', the hallucinations, the feeling of ease, the loss of contact with time and other bodily effects.
			Other effects to note include breathing problems, it increases the heart rate, gives an increased risk of heart attack, it's very bad for pregnant women, if used in high amounts it can actually be the cause, rather than the cure, for intense nausea and vomiting, it makes schizophrenia worse, causes lower satisfaction with life, relationship problems, less academic and career success, and the list goes on.
			THC doesn't give any medicinal effects. That comes from cannabinol. Cannabinol doesn't give a 'high' but does have some effect on glaucoma, nausea and other things. So the mantra being promoted is that if we just legalize it, that will cut down on the use of it.
			Dr. Stevens explained that an independent group estimated that out of 13-1/2 million pounds of marijuana produced in California, 80% of it was illegally shipped out of state, and of the remaining 20%, only 5% went into medicinal marijuana.
			So why are numerous states looking to jump aboard the marijuana bandwagon? Again, it all goes back to money. Marijuana is getting taxed. It had been estimated that by this year, marijuana would be a 3.5 billion dollar business in California and a 5 billion dollar business by next year, with the state making a billion dollars in taxes.
			So it's not the legalization of marijuana that's really the issue, it's the commercialization. Under commercialization you need to get more current

Obtaining that goal requires more marketing which is just what you'll see in Colorado as marijuana is promoted in TV, print, etc. This is resulting in huge profits for the state and those involved in it. Just to prove the point, Dr. Stevens noted that in one minority area of Denver, there's 1 marijuana shop for every 47 people.  Dr. Stevens has no problem with medical marijuana as long as it's handled like medicine. He gave the example of morphine which is an effective drug for pain relief. Morphine comes from heroin which in turn, comes from poppy plants. We don't allow people to grow poppy plants in their backyard and manufacture their own heroin, but that's what we're doing with marijuana. There's no manufacturer, there's no FDA approval, no standard chemical composition for potency and quality, no standard dosage, no safe delivery system, and no knowledge of interaction with other drugs you may be taking. Instead, in California, the legal system is basically saying that if you need marijuana for medicinal use, you can grow six plants in your backyard as long as people can't see them. Then you can consume that marijuana in whatever dosage you want. 1/10	Human Trafficking and Abortion	Jim Schneider / Brad Mattes	Brad Mattes is the president and CEO of Life Issues Institute headquartered in Cincinnati. Their mission is that of assuring, through education, equal protection under the law for all living humans from the beginning of their biological life at fertilization until natural death.  According to Brad, human trafficking is happening all over. The number of victims is hard to come by, but he's guessing millions are involved in this 'industry', one that is second only to the drug trade.

Monetarily speaking, one person who has a stable of girls (or boys) will generate over \$350,000 in a year. Replicate that in communities both large and small all across American and you have an idea of just how much total money is involved. Individuals recruiting these youngsters will sit at places such as malls. The target victims are young girls (and boys) who may be alone, estranged from their parents or dabbling in drugs. The average age for girls is between 12 and 14. For boys it's between 11 and 13 In fact, one out of every 3 kids who run away from home will be approached within 48 hours by a human trafficker. Is there any correlation between sex trafficking and prostitution? According to Brad, the two are basically the same. The difference is that where you have trafficking, it's against the will of the victims who are being marketed. Brad believes social media plays the major role in identifying, locating and either recruiting or stealing children into the trafficking industry. Those who use social media most effectively are monitoring what your children are doing online. It's so important that parents are aware of what their children are doing online because kids often share a lot of personal information through the Internet. This makes them an easy target for the pimps and dealers that engage in human trafficking. Those purchasing young girls and boys cross all lines of society: white collar, blue collar, politicians, doctors, attorneys, truck drivers, mechanics and sadly, even pastors. Brad described a situation in Toledo, Ohio, where 3 pastors were arrested for buying the services of trafficked victims. Brad believes it's absolutely essential to human trafficking to have abortion on demand. Life Issues Institute has observed from watching undercover videos of Planned Parenthood where the staff has participated with people posing as pimps involved in human trafficking. After all, when you have someone sold time and time again for sexual activity, pregnancies will occur. However, Planned Parenthood doesn't care what these individuals get treated for or if they get abortions. The traffickers know Planned Parenthood isn't going to report them despite the danger these young people are in. There's much more to learn on this Crosstalk including: --Traffickers posing as parents/legal guardians so that girls can get --The connection between major sporting events and human trafficking. -- Why it's difficult for girls to leave this industry. --Why gangs are now running girls. 1/11 LGBT and Jim Mat Staver is the founder and chairman of Liberty Counsel, an the Courts Schneider / international nonprofit litigation, education and policy organization dedicated to advancing religious freedom, the sanctity of human life, and Mat Staver the family. He has over 230 published legal opinions and has authored eight scholarly law review publications and 10 books. He has argued two landmark cases before the U.S. Supreme Court. He's the host and producer of Faith and Freedom and Freedom's Call. This week, the Supreme Court declined to hear 2 cases challenging the constitutionality of a Mississippi law. Mat noted that the Supreme Court decided not to hear such cases that allows religious organizations to refuse to hire individuals or provide services to LGBT people in certain situations in which that situation would conflict with someone's sincerely held religious beliefs. The court referenced a stigmatic injury to LGBT individuals. Mat explained that they aren't being physically injured or injured monetarily but that they're being singled out because of their same-sex lifestyle. Justice Kennedy has apparently put a lot of weight on this point to justify striking down marriage and other laws that would otherwise address this LGBT In Oregon, Aaron and Melissa Klein, owners of Sweet Cakes my Melissa, declined to provide a wedding cake for a same-sex couple. As 2017 was

coming to a close, 3 judges on the Oregon Court of Appeals affirmed a penalty of \$135,000 against the bakery. Aaron and Melissa didn't want to violate their Christian faith and promote lesbianism, yet the court gave \$75,000 in damages to one of the brides and \$60,000 in damages to the other bride. The damage amounts differed because the second bride didn't hear a quotation from the Bible directly but had it quoted to her later. Apparently Aaron had used the term, 'abomination' in the course of explaining his denial. Mat explained that the Klein's make a very specific kind of cake. This means that when the same-sex couple made their request to have a cake made with two women portrayed on top of the cake, this would celebrate and promote same-sex unions and that would conflict with the Klein's religious beliefs. Instead of going 'down the road' to get a cake made by someone who might want to participate in the union, they came after the Klein's. Mat believes that if the Supreme Court goes the right way by the end of June when they render their decision in the Masterpiece Cake Shop case (Masterpiece Cake Shop v. Colorado Civil Rights Commission) it would be good for the Klein's case. If they go the other way, not only will it be terrible for the Klein's, it will be bad news for other Christians in other professions around the nation. Our guest today calls gender confusion (whether one is male or female) 'large scale child abuse' at the hands of parents, teachers, therapists and physicians.  Many are claiming they were 'born this way' or are even 'trapped in the wrong body.' But Dr. Cretella says that all are born with a 'biological sex' and that 'From the moment of conception, we are either male or female (according to chromosomes)' and that these are 'imprinted in every cell of our body forever and do not change.' 1/23	Is Common Core Dead?	Jim Schneider / Duke Pesta	Dr. Duke Pesta is the academic director of Freedom Project Academy and a tenured professor of English at the University of Wisconsin-Oshkosh. He's taught at major research institutions and small liberal arts colleges at both the graduate and undergraduate levels and has garnered seven teaching awards at four universities. He is one of America's foremost authorities on the dangers of Common Core, having delivered more than 600 talks and has testified about Common Core and education reform before 20 state legislatures. He's author of the book, 'The Renaissance and the Postmodern: A Study in Comparative Critical Values'.
			Secretary of Education Betsy DeVoss, agrees with President Trump that Common Core is a disaster and that at the U.S. Department of Education Common Core is dead. Is it?
			In answering that question, Dr. Pesta wondered how you can spend 7 years spending billions of dollars to force this into schools, bribe states to take it, transform the textbook industry, to reduce public school education to an exercise in Common Core federal standardized tests, to retrain teachers across America to only know Common Core material, and then by fiat claim it's dead?
			The push-back was so hard against Common Core that every state simply renamed it. It's been rebranded and is now part of the 'DNA' in how our children are being educated, so according to Dr. Pesta, to say that Common Core has gone away simply isn't true.
			He believes that whether she likes it or not, Betsy DeVoss is 'Washington'. President Trump promised us that he would get rid of the Department of Education. He didn't and Dr. Pesta said he won't. In appointing DeVoss to her position, he appointed a woman who won't get rid of that department either. This means Washington remains the problem.
			Keep in mind that before Obama gave us Common Core, George Bush gave us 'No Child Left Behind'. Before that you had 'Goals 2000' from Bill Clinton, all of which takes us back to the formation of the Department of Education in 1979. Up to that time, we'd been educating kids quite well for 170 years. Then in the late '70's we created another federal bureaucracy and put that in charge of education. At that point, all of the money that went directly from Congress to the states now was funneled through the Department of Education. The department then used that money as a bribe. Those state boards of education that complied with federal mandates received more money and those that didn't received nothing.
			Overall, the Washington approach to education has failed. DeVoss acknowledges that, but then seems to think that by pretending it's gone away, she's fixed it. She has to go in and root out all of the legislation and reforms that go back 50 years that the feds have used to wrench control of the eduction of our kids away from local communities, states,

			teachers and parents and that solidify it at the federal level.
			Dr. Pesta noted that if DeVoss really believed what she says, she'd be working to undue the Every Student Succeeds Act (ESSA). He believes she should get rid of that first and then begin dismantling the Department of Education. He doesn't believe that will happen, but if it would, then she could honestly say she's trying to fix the problem in Washington.
			As you review this edition of Crosstalk, you'll hear Dr. Pesta explain the correlation between and the logic behind the forming of the previously mentioned education programs and the more recent ESSA. These programs are not about educating our kids well or poorly. They are delivery systems to force states, textbook companies, testing companies, teachers, and teacher training colleges to completely revamp the way they view and deliver education in America, with the federal government as the highest authority.
			More specifically, Dr. Pesta believes the ESSA takes all of the unconstitutional and illegal maneuvers of the Obama administration to get Common Core into the state schools, retroactively legalizes them, and for the first time in American history, centralizes control over public schools at the federal level.

			Jim began by playing a portion of President Trump's statement from last month when he announced the moving of the U.S. embassy to Jerusalem. According to David, people in Israel were very excited by this news. He went on to note that when you don't recognize Jerusalem as Israel's capital, and do what Mahmoud Abbas did and claim that there's no Jewish history in Jerusalem, it's like saying Abraham Lincoln never lived in the White House or that Washington, D.C. isn't named after George Washington.
			Vice President Mike Pence has been in Israel. David indicated that he was welcomed very warmly and his speech to the Israeli parliament was wonderful. He spoke of the commonality in regard to the biblical heritage our two nations share.
			Pence has indicated the move of the embassy will happen in 2019. David recognizes that President Trump knows how to get things done quickly when necessary and there's no reason why he shouldn't be able to do what Vice President Pence promised.
			The vice president's trip has been publicly boycotted by the Palestinians. Even Palestinian President Abbas shouted, 'May his house be destroyed!' To David, this sounded like an Arab curse, but if it was a threat, what was he threatening to do? In the end, for David this comment by Abbas was a clarification, letting us know what they really believe.
			Since the president's announcement concerning the moving of the embassy (which came with the blessing of Congress), the Palestinian Authority has stopped any formal communication with the Trump administration. That brings up this question: Did the president throw an opportunity for peace out the window?
			David asked, 'What kind of opportunity for peace are we talking about?' He believes peace has to be based upon realism. If that's not there, there will be no peace. It's like saying that President Trump should sit down and have a chat with Kim Jong Un and there will immediately be peace. It doesn't work that way.
			He believes that sometimes you have to look evil in the face and confront it. These are evil people. Abbas is an arch terrorist and successor to Yasser Arafat who was the father of modern terrorism. He's been giving thousands of dollars to every terrorist that wounds or kills an Israeli. On the other hand, if a terrorist is captured by Israel and put in jail, that

			funding goes to the family of that terrorist.
			As Vice President Pence began his speech, there was turmoil from the Arab members in the chamber. David comments on that along with the Iran nuclear deal, the turmoil within Iran, Abbas' visit to Brussels, Benjamin Netanyahu's trip to Switzerland, and more.
1/25	Delights and Disciplines of Bible Study	Jim Schneider / Dr. Warren Wiersby	Dr. Warren Wiersbe is an internationally known Bible teacher, former pastor of Moody Church in Chicago, and former general director and speaker on the Back to the Bible broadcast. Dr. Wiersbe has written over 175 books including the popular 'Be' series of expositional Bible studies. He's the author of the new book, 'Delights and Disciplines of Bible Study'.
			For some people, getting into the Bible means we only do it to check it off our list for the day. Dr. Wiersbe believes the Bible is the most delightful and dynamic book. But that's not how he always felt. He recalled how he went to confirmation class where he had to read straight through the Bible. He thought it was all rather boring. Then at about 16 years of age he went to a Youth for Christ rally where Billy Graham was preaching and trusted Christ as his Savior. He then began reading his Bible, found study guides, and he's been at it ever since.
			Discipline is also a critical component in this discussion. According to Dr. Wiersbe, discipline controls us. Since he became 'born again' he's been in the habit of being up early in the morning, studying the Word of God, praying and meditating. Then when he was in the pastorate he was constantly studying and getting ready to preach and teach others. The Bible transformed his life.
			Dr. Wiersbe differentiates between personal, daily devotional time, from serious Bible study. It's about getting into the Word in such a way that we can see where it relates. In other words, there's a difference between facts and truths. There are thousands of facts in the Bible and there are truths that are built out of those facts that change our lives. You have to have both.
			What about those of us who feel they just don't have time to study the Bible? Dr. Wiersbe believes we need to engage the Bible first of all because it's the Word of God and since we're the children of God, would we not want our Father to speak to us? Would we not want our Savior to teach us? Would we not want the Holy Spirit of God to open our eyes so that we can behold wonderful things in the Word?
			So for Dr. Wiersbe, studying the Word of God is not something painful. It's exciting. When he discovers a truth in one book that connects with a truth in another book, he described it as being handed a piece of birthday cake. If we don't get into the Word, the Word won't get into us.
			His latest book also points out that we need to study the Bible because the enemy knows the Bible. The Devil quoted the Bible when he tempted Jesus. The Bible is the sword that we use to fight Satan. It has to be 'practiced' day after day. It's nutrition and it's light in this very dark world.

They fight for the reforming of the current immigration system so we can end illegal immigration and have an immigration system that serves in the best interest of American workers and their wages.
			When we hear about a DACA 'fix' (Deferred Action on Childhood Arrivals), some refer to this as amnesty while others claim it isn't. NumbersUSA believes this is amnesty. They take the position that anything that rewards a class of illegal aliens, regardless of number, as amnesty. On the other hand, they've already endorsed legislation in the House that does include DACA amnesty because it does a lot of other things that NumbersUSA is pleased with.
			March 5th is said to be the deadline when the DACA program is to begin phasing out. If nothing is done and everything stays 'as is', what will happen on the 5th? Chris said the answer is 'nothing'. A couple weeks ago, a San Francisco federal judge ruled that the Trump administration illegally halted the DACA program in the way it was done on September 5th. The judge ordered the administration to reinstate renewals for the program. Since about mid-January the Trump administration has been processing renewals and will continue to do that until that case is appealed to the Supreme Court. Chris believes it will take a couple of months for things to get straightened out through the Supreme Court.
			Congressman Pete Sessions indicated there should be no pathway to citizenship. He favors what's known as 'guest worker status'. His concern is the message that would be sent to those who are legally going about becoming a citizen. Chris says NumbersUSA sees this as a matter of semantics. Since NumbersUSA is concerned about the effect of mass immigration on American workers and their wages, once you have someone in America who can stay and compete with other American workers, whether or not they have citizenship or whether or not they are here on a guest worker visa doesn't matter, they're here. So

NumbersUSA doesn't differentiate between the two. The House bill they've endorsed includes a renewable work visa so it doesn't offer a path to citizenship. However, if this was turned into a path to citizenship, Chris noted that they wouldn't be too concerned with it. The last time Congress evaluated the immigration system was in the '90's when they had a bipartisan congressional commission on immigration. They actually recommended ending chain migration. This is what spawned NumbersUSA. The commission was chaired by Barbara Jordan who recommended limiting family-based immigration to spouses and minor children. Most developed nations around the world do that very thing. Back in 2013, when the 'Gang of Eight' immigration bill passed the Senate, the House version of that bill (HR-15), which Nancy Pelosi co-sponsored, ended chain migration, as did the '06-'07 amnesty bills. This shows that there is a history where Congress has attempted to end chain migration over the last 15-20 years. Chain migration has a multiplying effect. When we hear about a DACA 'fix' (Deferred Action on Childhood Arrivals), some refer to this as amnesty while others claim it isn't. NumbersUSA believes this is amnesty. They take the position that anything that rewards a class of illegal aliens, regardless of number, as amnesty. On the other hand, they've already endorsed legislation in the House that does include DACA amnesty because it does a lot of other things that NumbersUSA is pleased with. March 5th is said to be the deadline when the DACA program is to begin phasing out. If nothing is done and everything stays 'as is', what will happen on the 5th? Chris said the answer is 'nothing'. A couple weeks ago, a San Francisco federal judge ruled that the Trump administration illegally halted the DACA program in the way it was done on September 5th. The judge ordered the administration to reinstate renewals for the program. Since about mid-January the Trump administration has been processing renewals and will continue to do that until that case is appealed to the Supreme Court. Chris believes it will take a couple of months for things to get straightened out through the Supreme Court. Congressman Pete Sessions indicated there should be no pathway to citizenship. He favors what's known as 'guest worker status'. His concern is the message that would be sent to those who are legally going about becoming a citizen. Chris says NumbersUSA sees this as a matter of semantics. Since NumbersUSA is concerned about the effect of mass immigration on American workers and their wages, once you have someone in America who can stay and compete with other American workers, whether or not they have citizenship or whether or not they are here on a guest worker visa doesn't matter, they're here. 			It was a year and a half into the Civil War that Lincoln issued the Emancipation Proclamation, changing the focus of the war from tariffs (which is how the federal government obtained taxes) and the states breaking away, to slavery.
			This was Lincoln's way of gaining the moral high ground because no one wanted to be seen as a defender of slavery, so all of the European support for the Confederacy dried up. In addition, the cotton crop became decimated which forced the South to pay tariffs with less money.
			Actually, Lincoln had no authority to free the slaves. When called on it, he had to back-track on this by passing the 13th Amendment.
			Lincoln is also responsible for instituting an annual day of Thanksgiving and twice during the Civil War he had days of fasting.
			George Washington was unanimously chosen as commander and chief of the U.S. Army, as the president of the constitutional convention, and as the first U.S. president.
			During his life, the two biggest world powers were the British and French empires. In 1755, Washington was a colonel under Edward Braddock the commander of the British forces in America. Washington survived an ambush and miraculously survived.
			Washington eventually became commander of the Continental Army. After the Declaration of Independence was read to his troops, he appointed chaplains for every regimen.

In states all over the nation, Muslims are running for office. State chapters of the Council on American-Islamic Relations (CAIR) are actively engaged in 'capital days', pursuing an Islamic agenda in state capitals and training in politics in Islamic centers.
			Joining Jim to discuss this issue was Shahram Hadian. Shahram is a former Muslim from Iran who came to the states in 1978 and committed his life to Jesus Christ. Shahram has begun the TIL Project (Truth in Love Project) which exposes the true goal of Islam and the threat of Sharia in America. He has served as a pastor, a police officer, and a former candidate for governor in Washington State.
			Shahram echoed Jim's thoughts regarding increased Muslim involvement in politics. He pointed out that evidence proves this at the federal, state and local levels. His concern is at the local level, the level where he feels we often don't pay attention. Muslims are not only running more often but are also getting elected. This shows how they are getting very confident and bold with their agenda here in America.

He made no mention of what specific actions he's calling for or what actions would have prevented Wednesday's tragedy from taking place. --A relative has indicated that Nikolas Cruze, who committed Wednesday's mass murder, was on psychiatric medications. --Erich Pratt from Gun Owners of America noted that it's disgusting how pundits in the media and politicians are calling for gun control as a 'knee jerk' reaction to Wednesday's tragedy. --Several schools nationwide bolstered security or shuttered their doors today following threats made in the wake of the Florida school shooting. --One Washington grandmother, who saw alarming signs this week that her grandson was about to conduct his own high school killing spree, acted quickly and likely saved many innocent lives. --The TV show, 'The View', is being blasted for an intolerant rant that criticized

	a list of over 400 Bible contradictions, the list that inspired his book is actually a list of over 400 errors that the critics make when they argue against the Christians worldview.  So what is a contradiction? Dr. Lisle began by noting that a difference is not necessarily a contradiction. Someone may witness a car accident and say the car was red. Another person may say the car was fast. This is a difference but it's not a contradiction. Each person reported different information, yet those two things are compatible. The car can be both fast and red.  A contradiction is where you have 'A' and 'Not A' at the same time and in the same sense or relationship. You can usually make a contradiction by adding 'It is not the case that' in front of it. So if you say that it's raining outside, the contradiction would be, 'It is not the case that it is raining outside.' Those two things cannot be both true at the same time and in the same sense.  Another way to look at this is the idea of marriage. A person could be married in one sense and not married in a different sense. So Dr. Lisle might say he's not married in the sense that he doesn't have a wife but he is married to his work. That's a different sense of the term.

	I		What this points to is that when it seems to see the Belline of the Control
			What this points to is that when it comes to contradictions, often times it's just a compatible difference. That accounts for many errors that critics make when they allege that the Bible has many contradictions. In fact, Dr. Lisle enjoyed researching the alleged contradictions in the gospels for that reason, because when you flesh them out you see that there's a reason why God presented that historical information from four different viewpoints. It gives readers a much richer and fuller picture than we would get if we just had one point of view.
			Another problem comes into play when our minds/imaginations fill in certain details that aren't part of the text. Then we read a different account and it doesn't contradict the text, it contradicts those details that our imagination has supplied. At that point we need to go back to that first account and find out what the text really said and figure out what we may have imported into it.
			This is a fascinating program that moves along to educate listeners regarding a number of factors that cause critics of the Bible to stumble. They include the bifurcation fallacy, the subset fallacy, quantitative differences, the argument from silence, the semantic anachronism fallacy, and more.

It's coming out of the United Nations, The United Nations Educational Scientific and Cultural Organization (UNESCO), UNAIDS, the United Nations Population Fund, UNICEF, U.N. Women, and the World Health Organization. The 135 page plan of these organizations calls for international implementation and international technical guidance on sexuality education.
			Joining Jim to discuss this issue was Alex Newman. Alex is an international freelance journalist, educator and consultant. His articles frequently appear in The New American. He also writes for Freedom Project Media.
			The 135 page document was released last month and is known as International Technical Guidance on Sexuality Education. It's part of the U.N.'s sustainable development goals and that's part of what's called 'The Global Education 2030 Agenda'. It starts with children at age 5 and goes through a child's entire education experience.
			The U.N.'s Sustainable Development Goals have also been called 'The Master Plan for Humanity'. Within that plan, sustainable development goal #4 talks about education and it openly reveals that every child in the world has to be made to understand things like human rights. That sounds good until you realize they mean the opposite of what the U.S. founders meant. They believe their education goals will create 'agents of change' to bring about the kind of world the U.N. wants.
			This program entails what the U.N. calls 'Comprehensive Sexuality Education'. According to Alex, in the document itself this means that they want sexuality education interwoven throughout many different subjects. It won't be some small segment where children would be taught about how different body parts function.
			As already noted, this would begin for children at age 5. It would include education regarding LGBT lifestyles and sexual pleasure. Along with this there would be attitudinal outcomes and learning goals. In other words, they want to see changes in attitude that can be measured and verified right up through age 18.
			This is called an 'Evidence Informed Approach'. What is the U.N.'s base of evidence? Alex noted that you can see that the U.N.'s 'evidence' comes from radical extremist groups like Planned Parenthood. He also mentioned the conflict of interest as Planned Parenthood makes massive sums of money from giving abortions, yet they're part of a plan to teach our children that pre-marital sex and abortions are fine.

			Joining Jim to look at these and other related matters was Twila Brase. Twila is the president and co-founder of Citizens Council for Health Freedom. She's a registered nurse and provides daily commentary on the Health Freedom Minute.
			If Americans are led to believe cost is the driving issue concerning Obamacare, why should politicians feel pressed to change it? The mandate hasn't gone away and the penalty has been simply zeroed out. So all the language of the mandate and the penalty are still in the law. This means another Congress could come along and simply say that the penalty is now \$1,500. No new law would have to be added.
			Twila doesn't believe the law is going away, but the attempt at what's called 'stabilization' (propping up) of the law, is designed to lower premiums. This is meant to take the pressure off our legislators although in reality you'll still pay for this 'stabilization' through higher taxes.
			Jim then asked Twila about the new White House budget that allows for 11.5 billion dollars in bailouts to health insurance companies that participate in the Obamacare insurance exchanges. It's known as 'Risk Corridors'.
			Twila responded by noting that the Affordable Care Act had 3 specific redistribution programs. 'Risk Corridors' means that health plans that can prove that they have expensive payments can take money from health plans that can't prove they have as many. They force all of the health plans to provide risk data on all enrollees. Those who do the best job at making their people look more expensive or risky will get more money. In other words, he who has the best data, or can make their data look the bestwins.
			Another move by the Trump administration is a proposed rule that would expand the availability of short term, limited duration plans to one year. This has the Trump administration simply restoring what was already in place prior to when the Affordable Care Act became law.
			What about the Independent Payment Advisory Board (known by some as 'Death Panels')? Congress had voted to repeal these. It would have been comprised of 15 people who would be making decisions regarding what would and would not be paid for in Medicare, but those decision move into health plans all across the nation. If Medicare came to a point of fiscal instability, this board would be able to make decisions that the president and Congress couldn't stop. The only way to stop this would be to have a two-thirds majority vote, which is rare.
			There were both Democrats and Republicans that didn't like this board idea and President Obama never staffed it. Interestingly, the Secretary of Health and Human Services would have had the same authority. So since this board wasn't staffed, the authority for determining care would have fallen on that person's shoulders. Twila noted that either way, it's good that this board is gone because she believes that nothing should be outside the authority of elected representatives.

2/22	The Gun Control Debate	Jim Schneider / Michael Hammond	On February 14th, a mass shooting occurred at the Stoneman Douglas high School in Parkland, Florida. 17 individuals were killed and others wounded. One response from this was, 'Thoughts and prayers are not enough!' Others have been calling for 'common sense gun control' although that phrase can mean different things depending upon the source.

Is gun control really a security issue or is it a heart issue? What culpability is there for organizations like the FBI as they were warned in advance that this young man allegedly boasted that he wanted to be a professional school shooter. What about the many police visits that occurred at the shooter's home? What laws could have been passed to stop this tragedy? After all, this happened in a gun-free zone. Appearing on Crosstalk to discuss this and related matters was Michael Hammond. Michael is the legislative counsel for Gun Owners of America. Is the U.S. the worst nation for mass shootings? According to Michael, Norway had a mass shooting and they have strict gun control. In 2015 France had more people killed in mass homicides than the entire Obama administration did in America. Every year there are about 10,000 gun homicides in our nation. They occur in places like Chicago, Baltimore, New York City and Los Angeles. So the places where homicides occur in America, in any number, are those areas that totally ban guns. Do stronger gun laws reduce gun violence? As part of his answer, Michael recalled a time when he was 14 years old and in the Junior ROTC program at an inner city high school in Kansas City. This means they were issuing semi-automatic M-1 rifles to 14 year olds. No one who saw these ROTC students had any idea that they were going to shoot up the school. Then in 1996 Congress passed a law to outlaw guns in schools. About 2 years later, Columbine happened and the press used that incident to achieve gun control. The only impact of the extensive press coverage was to convince 10 more shooters that they could shoot up their schools and obtain their 15 minutes of fame. So now we have a cycle of shootings, one after another. Jim then brought up a fact concerning CNN's 'town hall' meeting that dealt with the Florida shooting. A survivor of the shooting said that the network rejected his proposal to discuss armed guards in schools. Instead, they handed him a scripted question on gun rights to ask during the meeting. Michael believes CNN basically assembled a 'lynch mob' to create the illusion that youth in America want to ban guns. His example of proof was an NRA woman who had to be escorted by armed guards because the kids were shouting, 'burn her, burn her!' He also noted that these represented a carefully selected and scripted group of individuals who don't represent America. The Crime Prevention Resource Center indicates that 98% of U.S. public mass shootings occur in gun-free zones. Michael explained that when Congress passed the law banning guns in schools in 1996, it hadn't been a big problem prior to that. After that it was a huge and recurring problem. One of the reasons is because disillusioned young men knew that if they wanted their '15 minutes of fame', they could enter a school, kill many people, and they wouldn't have to worry because no one would fire back. Michael calls such zones, 'safety-free zones'. Michael asked what other institution in America takes the position to not defend itself with the idea that hopefully no one will attack it? He then noted how the nation's capital spends over a billion dollars a year for armed guards and the White House spends a large amount for Secret Service. Hollywood parties have armed guards. 2/26	The Heart of Addiction	Jim Schneider / Dr. Mark Shaw	According to the American Society of Addiction Medicine, drug overdose is the leading cause of accidental death in the U.S. with over 53,000 lethal drug overdoses in 2015. Opioid addiction is driving this epidemic. These numbers climbed to an excess of 59,000 deaths in 2016. The medical profession has been accused of over-prescribing opiates. One doctor in Michigan from January 1st into August of 2017 had prescribed more than 500,000 opioid pills. Investigators said roughly half of these pills ended up on the street. A Rassmussen poll reported that through a national telephone and online survey, 44% of American adults say abuse of opioid drugs is a major problem in the area where they live. That's just one of many addictions; there's also alcohol, pornography, gambling, food, and the list goes on. How do we deal with this matter? How should the church be addressing it? How about the family impacted by a member who has such an addiction?

Joining Jim to discuss this issue was Dr. Mark Shaw. Dr. Shaw currently serves as the founder of Truth in Love Ministries and is the executive director of Vision of Hope. He's also accepted a position starting in September as a vice president at the NewDay Center in Indianapolis. With 26 years of supervisory experience in a variety of clinical settings, he teaches the truth and hope found in God's work about addiction of all types, eating disorders, self-harm habits, and other enslaving issues. He has a Doctor of Ministry in Biblical Counseling while also maintaining certifications with three different counseling organizations: ACBC, IABC and AADAA. He's the author of 20 publications including the book discussed on this edition of Crosstalk, 'The Heart of Addiction: A Biblical Perspective'. The program began as Jim asked Dr. Shaw the following question: Whether the area of addiction is related to alcohol, opioids, gambling or any other addiction, is 'disease' a proper word for this? Dr. Shaw starts with Scripture and he noted that nowhere in Scripture is addiction called a disease. He described it as, '... an idolatry problem; a heart problem that people struggle with in their sin nature. And so disease is the worldly terminology that I think actually does violence to the Gospel and leads people away from Jesus Christ.' So how did we arrive at the common usage of the term 'disease'? Dr. Shaw went back to the 1930's as he mentioned 2 individuals he described as Bill W. (who never professed to be a Christian) and Dr. Bob. The thought was that alcoholism must be a disease so the 12-step treatment method was developed to help people suffering from it. Dr. Shaw noted an important point related to this issue that concerns idolatry. This is putting something other than God in His rightful place. We've all been guilty of that at one time or another. Our tendency is to put ourselves ahead of God because we want to please ourselves. Idolatry sounds like a harsh term when actually it's compassionate. It leads people to realize their sin nature and that they need Christ; that He speaks to addiction when you define it as a habitual heart problem. At that point there's hope and the Gospel makes sense. As this program moved along, Jim also had Dr. Shaw address the following: --Dr. Shaw uses 2 Timothy 3:16-17 as a pattern for his book. What is the correlation between these two verses of Scripture and the subject of -- Does he recommend self-help groups for people struggling with addictions? --How does he feel about the use of the word, 'recovering' when addicts? -- Does Proverbs 23:29 lay out the characteristics of those who are hurting and may be engulfed in addiction? --What are the spiritual consequences of addiction? -- The battle in the mind. --Ultimately, where is hope found for overcoming addiction? --What role does prayer have in this matter? -- In his book Dr. Shaw says, 'The end of the matter is just the beginning.' does he mean by that? Gone Ollila There are Christians who believe that if they are faithful to the Lord, faithful in church, having a daily guiet time and faithful in service, that somehow they're going to be immune from times of severe trial or tragedy. Is there Scripture that backs this up? Dr. Ollila noted that it's actually the opposite. From Scripture we see that anyone who abandoned themselves to the total will of God ended up in less than ideal circumstances. Satan then comes along and puts a

			question mark about the character of God and we forget that we were born to reflect the nature and character of God to glorify Him. So many times we glorify him through how we respond to sufferings.
			How do we know when the 'rug is pulled out from under our feet' whether this is the discipline of God or if this is a test of character/commitment?
			Dr. Ollila believes that someone indwelt by the Holy Spirit would know very quickly through conviction and would acknowledge chastisement. David did that in Psalm 32 and Psalm 51. This person will know if what's taking place is God's hand of conviction and correction to conform that person to the image of His Son.
			On the other hand, another person cannot presuppose that a person is going through what they are because they're hiding some kind of sin.  Most of the time an outside judge will miss the point of what's really going on.
			He also described how God uses sickness to drive people to himself and there is no biblical basis for saying that if someone is sick, it's a consequence of some sin in their life.
			When a call does come that delivers news of something earth-shattering and now 'normal' is gone, there are 4 action steps people can take:
			AcknowledgeWhatever is happening is true. You won't wake up tomorrow and discover this was only a dream. For some this happens guickly, while for
			others the effect hangs on for a long time.
			AcceptAccepting the scenario is the hardest because it means you completely trust God in the circumstances. Some never accept it and die bitter. They turn to blaming God and change their attitude regarding the church. We see this during the first use of language among Adam and Eve as they blamed God by believing he could have stopped what took place.
			AdaptNormal is God. So create a new normal and make a ministry out of it. Admit that you would not have chosen whatever took place to happen. However, you would not go back and have it not happen because of the result of your conformity to Christ in the midst of it all.
			AccelerateDr. Ollila believes the key to spiritual success is a bad memory and good vision. You can't change yesterday but you can allow God to use you for the rest of your life to accelerate. Paul didn't meditate on his previous behavior and actions. He said, 'forgetting those things which are behind, and reaching forth unto those things which are before, I press toward the mark for the prize of the high calling of God in Christ Jesus.' (Philippines 3:13(b)-14)

	Interfaith Dialogue	Shahram Hadian	Shahram was born in Iran and raised Muslim. More importantly, Shahram was born again after hearing the gospel of Jesus Christ and receiving Jesus as His Savior and Lord. Shahram is a pastor, a former police officer, a teacher, coach, and now as the founder of the Truth in Love (TIL) Project he travels extensively contending for the faith that saves, and exposes the dangers of blending Christianity with Islam. While time didn't allow Crosstalk to air the entire presentation, we encourage everyone to obtain the DVD which covers the entire evening and features all of the PowerPoint teachings.
			Shahram began by detailing his list of resources for the presentation, beginning with the holy Bible (also listing the Koran, and other named works). Shahram contends that the idea of 'Chrislam' (blending of Christianity and Islam) is sneaking into America's churches and many are not even batting an eye, regardless of what Scripture warns. He says that Muslims are attempting to 'convert us' (Christians). Shahram explained what he sees as the 'three false claims of the interfaith ecumenical movement'. Of these, he explained how Christians are being told there is a,'common word between the Bible and the Koran.' He also says more and more churches in America are being deceived by evangelical leaders

Shahram shared several more verses from the Bible and how implementing them will bring change. He also made a strong point that because Christians are so far away from the Scriptures today, if we will go back to teaching about our Creator God, the next generation would no longer have to be confused about their 'sexuality or orientation' saying it, 'would go away because we would understand who God is and how He created us.' He ends with testimony and proper ways to reach Muslims with the Gospel that saves, as well as an exhortation to pray for Israel and the Church; the Church that is determined to fulfill Jesus' great commission.  The rapture remains one of the most debated issues in Christian theology.
3/1	Can We Still Believe in the Rapture?	Jim Schneider / Ed Hindson	Virtually every Christian denomination affirms belief in the eventual return of Christ, however, there's a wide variety of opinion with regard to when and how Christ will return. Others question whether Jesus will rapture believers at all. Today the blessed hope that believers will be 'caught up' to heaven is being challenged with new waves of criticism. Is the rapture taught in the Bible? Can we really expect Jesus to gather up believers before the antichrist is revealed?
			Dr. Ed Hindson is the dean of the School of Divinity and Distinguished Professor of Religion at Liberty University. He's the speaker on The King is Coming and author and general editor of 40 books including the newly released, 'Can We Still Believe in the Rapture' which he co-authored with Mark Hitchcock.
			Dr. Hindson began by noting that the biblical term 'rapture' in English is generally translated as 'caught up'. In the original Greek New Testament it's the word, 'harpazo'. As he phrased it, 'and it basically means zap, you're out of here; caught way, snatched away, taken away.' Jesus will come quickly, instantaneously to take believers home to heaven. This term was used as early as the 1600's by various Puritan writers to describe this event.
			What about those who say the term is not in the English Bible? Just as the term 'Trinity' is not in the Bible, the concept is there. In like manner, just as the term, 'rapture' is not in our Bibles, the concept is there along with the word in the Greek New Testament.
			In light of that, the real question is not whether there is a rapture, but instead, when will it occur. There has to be a time when the dead are raised and those still living are caught up according to 1st Thessalonians 4. You can debate when you believe that's going to occur but it has to occur. So just as there has to be a second, promised coming when Jesus returns, there also has to be a rapture.
			As this Crosstalk moved along, Dr. Hindson dealt with so much more including:
			What is the proper way to interpret prophecy?Why is there such a large divide surrounding this topic in Christian circles?What are the various views concerning the timing of the rapture?

While working at CAIR he uncovered a fraud scheme. He was invited by Hamas/CAIR leaders to work at their headquarters office in Washington, DC. Why is there such hatred against Israel? Why do nations want to see Israel annihilated? Why does what happens in Israel have such global impact? Will the United States continue to stand by its long time ally?
			To answer these questions, Crosstalk contacted Ron Rhodes. Ron is the president of Reasoning from the Scriptures Ministries. He's a keynote speaker at conferences across the United States. He's the author of over 70 books with over 1 million copies sold. Crosstalk has interviewed him about his numerous writings concerning Bible prophecy, apologetics and other topics. He joined Jim to discuss his latest book, 'Israel on High Alert: What Can We Expect Next in the Middle East'.
			Why would Ron consider Israel to be on high alert? First of all, it's not exactly sitting on a very large chunk of real estate. As Ron pointed out, it's just 8,000 square miles which is quite small when you compare it to the more than 5 million square miles of hostile Arab real estate that surrounds them.
			Ron believes it's important that everyone, especially Christians, understand that this isn't merely a political or geopolitical issue. It's also a religious issue, a conflict between the Jewish people and Islam.
			He then mentioned Israel's neighbors. This includes Russia which has been working with Iran in overcoming Syria. This is important because the Bible does speak about a future invasion into Israel by Iran, Turkey, Sudan and a variety of other Muslim nations. This is to take place in conjunction with Russia, and what better route to take to get to Israel than through Syria, since they are right on the border with Israel.
			According to Ron, it appears that the stage is being set for this future invasion. The Russia/Syria, Russia/Sudan and Russia/Libya alliances have been coming together and in recent days, Turkey has been swinging away from the West and its commitment to NATO and instead appears to be looking to Russia.
			Why is there so much animosity toward Israel? Israel is considered to be the lesser 'Satan' while the U.S. is considered to be the 'Great Satan' because the U.S. has been the military and financial ally of Israel for so many years. When President Trump announced the relocation of the embassy from Tel Aviv to Jerusalem, Ron likened that to the pouring of gasoline on an already hot fire. 			Since February 23, two gender-confused recruits have signed contracts to enlist in the military. The allowance of this began under President Obama who issued an order saying that the military would have to recruit individuals who suffer from gender dysphoria. This is a psychological condition that is defined by confusion about gender identity and requires

compassion and competent medical care. Adding to the force of what President Obama issued, Elaine noted 4 district judges, one who basically stated that this has never been done before but he would issue a preliminary injunction that the military must accept individuals suffering from gender dysphoria or who claim to be transgender. She explained that if you look at Article I and Article II, you see that Congress has a certain authority over the military. The president and the executive branch also shares such authority. However, in Article III, where it outlines what judges do, there's no word about running the military. In other words, these judges have exceeded their authority. The Department of Justice has appealed to 2 appeals courts. One is in the District of Columbia and the other is in Baltimore, Maryland. Both of these courts rejected the requests for immediate stays. Elaine believes there should have been an immediate appeal to the U.S. Supreme Court. The case would have gone to the Chief Justice who has jurisdiction over the D.C. courts. The appeal for a stay has not been filed. Why? Elaine indicated that when the Department of Justice acts as an attorney for a branch of government, that branch must agree to have the appeal go forward. In this case, James Mattis, the Secretary of Defense, didn't authorize that appeal. Also, there apparently was a 'study' pending. That 'study' was assigned to a person who helped to implement the Obama policy. This person was put in charge of coming up with recommendations to present to Mattis and he would give them to President Trump. We don't know exactly what was given to the president, but it's been reported that Mattis said that we should have openly recruited and retained transgenders in the military. This is at odds with what President Trump has said. Now the question is: What will the president do? He's not bound by the recommendations of Mattis and has the legal power to undue what President Obama did. Other factors are worth considering. For example, people attempting to change genders are not deployable for long periods of time due to the need for medical care and time off for what's called, 'real life experience'. This latter point involves time off to experiment by living as a member of the opposite sex. How does all this help maintain or improve America's military readiness? Could some individuals see this as an opportunity to scam the system in order to have expensive operations and hormonal therapy paid for at military/taxpayer expense? For Dave, the common denominator among such individuals is that they want to restrict firearms as much as possible, ban other classes of firearms and ultimately, '...treat the 2nd Amendment as a government regulated privilege rather than a constitutionally protected, fundamental right.' Florida has passed legislation outlawing gun sales to people under the age

		of 21. Federal law, dating back to the Gun Control Act of 1968, allows young adults ages 18 to 20 to purchase rifles or shotguns. Handgun sales are restricted to people over age 21 and it's been that way for about 50 years. So what we have here is a situation where Florida has decided on its own to move that age up.
		In response, the NRA has filed a lawsuit to stop that law from taking effect and Dick's Sporting Goods along with Walmart have decided not to sell guns or ammunition to anyone under age 21.
		Does Dave believe that the Florida law would have prevented last month's shooting? Will hardening schools, strengthening background checks, mental health reform and reviewing funding proposals to prevent school violence make a difference? You decide after reviewing this edition of Crosstalk.

Tillerson also felt diplomacy was the way to go in regard to North Korea, whereas President Trump wanted to get tough, which he did, via sanctions. This has resulted in North Korea wanting to come to the negotiating table. Tillerson also wanted to preserve the Paris Climate Accord and the Trans Pacific Partnership.
		Senator Rand Paul has indicated he will do everything he can to block the nomination of Mike Pompeo because Pompeo doesn't believe that enhanced interrogation techniques are torture as well as lending support to the Iraq war.
		The activist LGBTQ organization known as the Human Rights Campaign claims that Mike Pompeo is anti-LGBTQ. They claim he opposes marriage equality and, as a member of Congress, co-sponsored efforts to allow states to not recognize same-sex marriage and to allow not-for-profit businesses and organizations using taxpayer dollars a license to discriminate against LGBTQ individuals.

		Just yesterday (March 14th) wnd.com ran the story about a teenage

			Muslim who was spending the night with friends. He stabbed 3 people, killed one, and according to Florida police it was, 'because of his Muslim faith.' According to an affidavit, the suspect read the Qur'an to give him courage to carry out his intentions.
			Usama responded by expressing that a simple reading of the Qur'an will show us that Islam is a savage cult. He followed this up with 3 important points:
			We are not telling the American public the full picture of what is happening in America.
			We need to understand what is coming to America. Look at what's happening in Sweden and other parts of Europe. Huge numbers of crimes are committed daily and not simply by the week.

3/23	Physician Assisted Suicide	Jim Schneider / Dr. David Stevens	Dr. David Stevens is the chief executive officer of the Christian Medical and Dental Association, a national organization of Christian health care professionals that seeks to change hearts in health care. Dr. Stevens is a medical doctor that has also spent multiple years as a missionary doctor.  Jim got right to the heart of the matter by asking the following question: Is physician assisted suicide actually death with dignity?  Dr. Stevens explained that it's neither death with dignity nor is it compassion. Compassion is coming alongside someone and helping them bear their burden. Doctor assisted suicide is actually an escape from compassion because after death the doctor doesn't have to be compassionate anymore. All it does is give enormous power to health care professionals, so for that and other reasons, Dr. Stevens believes this practice is very dangerous.
			Physician assisted suicide was taking place 2,000 years ago before Hippocrates. The trouble was, you didn't know what the doctors were going to do to you. Then Hippocrates came along and communicated that the foundation of health care is trust and from that came the Hippocratic oath. Doctors that followed this said they won't give a deadly drug, abort a baby, betray a confidence or take sexual advantage of a patient. These are things that made Western medicine prosper and it's guided us for over 2,000 years.  Is this oath still taken by those entering the medical profession? The CMDA did a survey on this point and found that some schools allow their 4th year students to get together and decide whether they want to follow the oath or not.

Some may remember Jack Kevorkian who was instrumental in putting this subject 'on the map' in the 1990's. Today we have groups such as Compassion in Choices out of Oregon that fosters legislation in favor of physician assisted suicide and they've been quite successful.  Physician assisted suicide is currently legal in the states of Washington, Oregon, California, Vermont, Colorado and it's tolerated in Montana.  So is Dr. Stevens concerned that we're entering a time when we may see our physician and not know whether we'll be receiving help or harm? Dr. Stevens believes that's true.  What, then, does the future hold for safeguards in the health care industry? Will the advancement of physician assisted suicide render such safeguards as mere suggestions? Dr. Stevens believes that safeguards are impossible to monitor. In fact, in the states where physician assisted suicide is legal, doctors are required to file a report. They take that report and enter it into a database and then it's destroyed. In other words, it's impossible to go back and find out if the patient was coerced. The patient is now dead and the doctor isn't talking.  Another problem related to physician assisted suicide involves the claims made as to how long a patient may have to live, when study after study has shown that doctors are notoriously inaccurate when making such prognostications.  This program offers much more on this subject from Dr. Stevens, as well as input from Crosstalk callers.  Jeffrey D. In fact, he discovered that the more feminine he acted, the more attention he received.
			Unfortunately the attention he received came in the form of molestation at the hands of certain men. He associated that negative attention with the male affirmation/confirmation/love that he was seeking. In fact, by age 8 or 9, he found himself going out and looking for boys/men to engage in sinful activity with, even if it meant being molested.
			Around age 12 or 13, David had discovered drugs and alcohol. By the age of 14 he was a confused, HIV positive transgender and homeless runaway, involved in prostitution. If he wasn't selling or giving himself away on the streets of Philadelphia, he was trading his body either for drugs or simply a place to stay.
			Throughout his teen years, David was in and out of juvenile detention, and as an adult he was in and out of county jails which eventually led to prison. It was during his second stay in prison that he met a correctional officer who challenged him, and kept consistently reminding him, that God did not create him to be this way. As much as that hurt his feelings, within a few weeks David was seeking that officer out because he knew there was something different about him. The officer's impact upon David was so profound, that upon leaving prison, change was in the works as he no longer felt comfortable dressing as a woman.
			Sadly, David still followed after the lusts of the flesh to such a degree that by his mid-30's, osteoporosis, AIDS, boils and fevers began to take their toll. Although sent home to die by doctors, God wasn't through with him. In his desperation, he picked up the Word of God.
