Consolidated Response of L4 Media Group, LLC

Dear Ms. Bernstein:

L4 Media Group, LLC, by and through its attorneys, hereby provides this Consolidated Response to your letters relating to the Class A Television Stations licensed to L4 Media Group. LLC ("L4"), as listed on Exhibit A (the "Stations"). In separate letters, you sought information from L4 regarding the Station's compliance with the requirement of the submission of quarterly Children's Television Programming Reports (FCC Form 398)(the "Report") during 2009 and 2010 (the "Period").

In particular, you requested that L4 provide the dates that the Report was prepared for the each of the Stations, the date on which they were prepared and placed in the respective Stations' public file, and the location of the respective Stations' local public inspection file. Also requested was a declaration of a person with personal knowledge of the facts detailed in this response.

Initially, it should be noted that the Stations have been silent for a majority of the time during the Period. Specifically, the Stations:

- Operated from January 1, 2009 until May 1, 2009;
- Were silent from May 1, 2009 until April 23, 2010;
- Operated from April 23 to April 29, 2010;
- Were silent from April 29, 2010, until October 25, 2010; and
- Operated from October 25, 2010 to December 31, 2010

Thus, during the Period, the Stations were only operational from:

- January 1, 2009 to May 1, 2009;
- April 23, 2010 to April 29, 2010; and
- October 25, 2010 to December 31, 2010

As provided in the respective requests to remain silent filed for the Stations during the Period, L4 has been attempting to sell the Stations, or to obtain financing to operate the Stations. Due to financial considerations, the Stations have been kept silent during the Period so to conserve L4's limited financial reserves while it undertook these efforts.

Because the Stations were largely silent during the period, L4 was under the mistaken belief that it was not required to submit the Report for the Stations. Once L4 received copies of your letter, and consulted with undersigned counsel, it set immediately upon preparing the missing Reports.

As of the date of this Letter, L4 has prepared a Report for each of the Stations, for each of the quarters in the Period, and submitted the Reports utilizing the Commission's electronic filing system. Additionally, as of the date of this letter, copies of the Reports have been sent to the respective Stations' local public inspection file, which are maintained at the addresses provided on Exhibit A.

L4 Media Group, LLC, regrets that it has not fully complied with the Commission's rules and polices relating to the preparation and filing of the Children's Television Programming Report during 2009 and 2010. Due to the severe financial situation it has experienced, L4 has attempted to remain in compliance with the Commission's rules to maintain the licenses of the Stations while actively searching for alternate sources of operating capital.
