## Ventura County man arrested for attempted murder in Santa Barbara --- 5/6/2024

A man from Ventura County was arrested for connection with a drive-by shooting in Santa Barbara. According to the Santa Barbara Police Department, the shooting happened at about 10:50 p.m. last Wednesday. Officers responded to a shots-fired call in the area of 200 South Voluntario Street. There were several people there but they were all uninjured. Police say someone in a vehicle had fired several rounds at them before fleeing the area. Investigators later identified the shooter as 25 year old Jack Flores Edgerton of Ventura County. He was taken into custody on Thursday and booked into the Santa Barbara County Jail on charges of attempted murder, possession of a loaded firearm, committing a felony with a firearm, and a gang enhancement.

# Driver ejected during rollover crash on Hwy 166 near Cuyama --- 5/6/2024

A woman was ejected from her vehicle following a rollover crash in Cuyama. The Santa Barbara County Fire Department says it happened around 7 o'clock last night on Highway 166 near Schoolhouse Canyon.

Fire officials say the Toyota RAV4 was headed westbound when it rolled 150 feet off the highway. The driver was flown to Marian Regional Medical Center. Her injuries were described as serious. No one else was in the vehicle.

### One driver arrested during DUI checkpoint in Santa Maria --- 5/6/2024

The Santa Maria Police Department arrested 1 driver on suspicion of DUI while conducting a DUI Checkpoint in the 900 block of West Betteravia Rd. The checkpoint took place from 6:00 p.m. Friday to 3:00 a.m. on Saturday.. 5 drivers were cited for operating a vehicle unlicensed or with a suspended/revoked license, 661 vehicle came through the checkpoint, 137 drivers were screened, and no drivers were arrested for other criminal charges. Drivers charged with a first-time DUI face an average of \$13,500 in fines and penalties, as well as a suspended license. The Santa Maria Police Department will hold additional DUI/Driver's License checkpoints in the upcoming months.

## CHP responds to fatal crash on Highway 101 in Pismo Beach --- 5/6/2024

A man died in a solo vehicle crash late in Pismo Beach. It happened Thursday just after 1130pm on southbound Highway 101 south of Mattie Road. According to the California Highway Patrol, an officer spotted the crashed vehicle as he was headed northbound. The vehicle, a 2007 Mazda, was engulfed in flames, and a 19-year-old man was found lying on the western embankment. The officer reported that the man had a pulse and was breathing. Despite life-saving attempts, the 19-year-old, whose identity has not been released at this time, ultimately died at the scene. The CHP says the collision was confirmed to be a solo vehicle collision and it is unclear at this time whether alcohol or drugs were a factor in the collision.
