

The undersigned, acting as incorporators of a corporation under the Arkansas Business Corporation Act (Act 958 of 1987), adopt the following articles of incorporation of such Corporation:

First: The Name of the Corporation is:

ARKLATEX RADIO Inc.

Must contain the word "Corporation", "Incorporated", "Company" or "Limited", or the abbreviation "Corp.", "Inc.", "Co." or "Ltd." or words or abbreviations of like import in another language.

Second: The aggregate number of shares which the corporation shall have the authority to issue is 5,000,000 shares.
