Dear Barry:

With respect to each of the television stations listed on Attachment 1 attached hereto and incorporated herein by this reference (each a "Station" and collectively the "Stations"), Fox Broadcasting Company ("Fox") and the FCC Licensee for the Station (such FCC Licensee is: (i) for all Stations other than WTTE, WRGT, WVAH, WTAT and KFXA, a subsidiary of the Sinclair Broadcast Group, Inc. ("Sinclair"), (ii) for Stations WTTE, WRGT, WVAH, WTAT (which are being programmed by Sinclair), a subsidiary of Cunningham Broadcasting Corporation ("Cunningham") and (iii) for Station KFXA (which is being managed by Sinclair), Second Generation of Iowa, Ltd. ("Second Generation")), have previously entered into a Station Affiliation Agreement, as it may be amended and supplemented (the "Affiliation Agreement"), an NFL Supplemental Agreement, as it may be amended and extended ("NFL"), a Prime-Time-Inventory-Purchase Supplemental Agreement, as it may be amended and extended ("PTISA"), for each Station, Fox and Licensee agree as follows:

1. The Affiliation Agreement is hereby amended and extended and shall end on December 31, 2012.
