License Renewal Instructions: Post-filing Instructions and Text

Post-Filing Announcement Instructions

Notice of a station's license renewal application filing must be broadcast a total of <u>six</u> times: once a day on June 1, June 16, July 1, July 16, August 1, and August 16.

At least three of the six announcements must be broadcast between 6:00 p.m. and 11:00 p.m. Of the three remaining post-filing announcements, one should be broadcast between 9:00 a.m. and 1:00 p.m., one between 1:00 p.m. and 5:00 p.m., and one between 5:00 p.m. and 7:00 p.m.

In addition, when presenting post-filing announcements, you must broadcast visuals with the station's and the FCC's addresses when this information is being presented orally by the announcer.

Text of the Post-Filing Announcement

On June 10, 2014, WSAZ-TV was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until October 1, 2020.

Our license will expire on October 1, 2020. We have filed an application for renewal with the FCC. A copy of this application is available for public inspection at www.fcc.gov. It contains information concerning this station's performance during the last eight years.

Individuals who wish to advise the FCC of facts relating to our renewal application and to whether this station has operated in the public interest should file comments and petitions with the FCC by September 1, 2020.
