
Pursuant to Section 76.64 of the Rules and Regulations of the Federal Communications Commission, 47 C.F.R. § 76.64, and on behalf of its broadcast television stations (the "Stations"), including those listed in Exhibit A hereto, Entravision Communications Corporation ("EVC") hereby elects retransmission consent status for the Stations on the cable systems of Time Warner Cable, Inc. ("Time Warner") for the period beginning on January 1, 2006, and ending on December 31, 2008. It is our intention that this election be effective as to all of Time Warner's cable systems, including those specified on Schedule 1 to this letter (the "Systems"). Such retransmission of the Stations will be governed by the terms of the existing EVC Retransmission Consent Agreement dated as of January 19, 2005 between Time Warner and the Station Group, and this election is not intended to alter the rights and obligations of the parties under that agreement.
