JIB is in receipt of your December 15, 2022 letter, which requests certifications of compliance regarding (i) the Children's Television Act of 1990; (ii) the Closed Captioning requirements set out in Part 79 of the FCC Rules; (iii) the video description rules set forth in 47 CFR 79.3; (iv) the Commercial Advertisement Loudness Mitigation Act ("CALM Act"); and, (v) the Twenty-first Century Communications and Video Accessibility Act of 2010 ("CVAA").

JIB hereby certifies:

- (1) There are no commercial advertisements embedded in NHK WORLD-JAPAN to which 76.607 of Title 47 applies. Accordingly, JIB is in compliance with the CALM Act.
- (2) It is exempt from closed captioning NHK WORLD-JAPAN pursuant to 47 CFR Section 79.1(d)(12).
- (3) It is in compliance with the video description rules.
- (4) It is in compliance with the Children's Television Act of 1990.
- (5) It is in compliance with the CVAA.
