**Re: Music Choice Certifications - Children's Television Act of 1990, Closed Captioning Regulations, Video Description Regulations, Calm Regulations and the Twenty-first Century Communications and Video Accessibility Act (CVAA)**

Ladies and Gentlemen:

This letter is provided in furtherance of Section 1.4.7(b) of the Affiliation Agreement made as of February 1, 2018, as amended ("Agreement") by and between Music Choice on one hand and AT&T Services, Inc. and DIRECTV, LLC on the other (collectively, "Affiliate"). Subsequently, AT&T Services, Inc.'s interest in the Agreement was assigned to DIRECTV. All initially capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Agreement.

Accordingly, with regard to the Children's Television Act of 1990 (the "Act"), the Closed Captioning Regulations, the Video Description Regulations, the Calm Regulations, and the CVAA, solely for the programming currently distributed by Music Choice to Affiliate per the Agreement, Music Choice hereby advises you for the period October 1, 2022 through December 31, 2022 as follows:

- (A) Music Choice's digital audio music programming (i) complies with the Calm Regulations, and (ii) is not subject to the Act, the Closed Captioning Regulations, the Video Description Regulations, nor the CVAA;
- (B) Music Choice's "TV Everywhere" programming (i) complies with the Closed Captioning Regulations and the CVAA (to the extent applicable), and (ii) is not subject to the Act, the Video Description Regulations nor the Calm Regulations; and
- (C) Music Choice's video programming (i) complies with the Act, the Closed Captioning Regulations, the Calm Regulations, and the CVAA (to the extent applicable), and (ii) is not subject to the Video Description Regulations.
