The following statement, to be considered aggregately as PGN’s single certification of compliance, shall be in reference only to such programming produced and directly distributed by PGN. The following certifications do not apply to any programming integrated or distributed by any third party.

## FCC CALM ACT CERTIFICATION

This is to certify that:

1. As required by Section 76.607 of Title 47 of the Code of Federal Regulations, 47 C.F.R. § 76.607, all commercial advertisements embedded in programming distributed by PGN are materially in compliance with the loudness control practices contained in Advanced Televisions Systems Committee (ATSC) A/85: Recommended Practice: Techniques for Establishing and Maintaining Audio Loudness for Digital Television (“ATSC A/85 Recommended Practice”) at the point of distribution by PGN to authorized reception equipment of downstream multichannel video programming distributors.

## **CLOSED CAPTIONING, VIDEO DESCRIPTION AND CVAA CERTIFICATION**

This is to certify that:

1. PGN's programming is in Philippine language (Filipino) and its related dialect, and not strictly in English or Spanish.
2. The programming has less than 50,000 subscribers and does not have the necessary equipment or infrastructure in place that can be acquired at minimal cost to provide for substantial video description in accordance with the video description rules set forth in 47 C.F.R. § 79.3, as amended on July 1, 2018, and increase access of persons with disabilities as required under the 21<sup>st</sup> Century Communications and Video Accessibility Act of 2010 (CVAA).
3. Pursuant to Sections 79.1(d)(11) and 79.1(d)(12) of Title 47 of the Code of Federal Regulations, PGN is exempt from closed captioning requirements as its programming produced less than \$3,000,000 in annual gross revenue during the previous calendar year [47 C.F.R. § 79.1(d)(12)], and such captioning expenditure would exceed 2 percent of the gross revenues received from the programming during the previous calendar year [47 C.F.R. § 79.1(d)(11)].
4. PGN's programming nevertheless has the capability to provide crawlers and insert emergency information in its broadcast as may be necessary.
