National Blood Pressure Awareness Week

High blood pressure, also called hypertension, is a significant risk factor for heart disease and stroke. Blood pressure is the force that blood exerts against the walls of the arteries when the heart beats. If this force is too high, it can damage your arteries.

High blood pressure usually has no symptoms. Regularly checking and monitoring your blood pressure helps you know when it is elevated and what is affecting your blood pressure. Check your blood pressure to find out your numbers:

The systolic (the top number) is the pressure when the heart beats or pumps blood to the arteries.

Diastolic (the bottom number) is the pressure when your heart is at rest.

To lower your risk of heart disease and stroke, try to keep your blood pressure below 120 systolic / 80 diastolic.

1. D-CalFresh provides a month's worth of benefits on an Electronic Benefit Transfer (EBT) card that can be used to purchase food at authorized retail stores, including most grocery stores and farmers markets, as well as online through Amazon and Walmart.
2. You may be eligible for D-CalFresh if you lived or worked in the affected counties between August 14 and September 12 and:
 - a. Spent money because of the wildfire, including paying for a hotel, gas, or other evacuation expenses
 - b. Lost food because of the wildfire or a related power outage
 - c. Lost money from work because of the wildfire
 - d. Spent money because of damage to your home or business
3. Benefits and income eligibility are determined based on household size. Households that already receive CalFresh benefits are NOT eligible for D-CalFresh.
4. To apply, call 1-877-847-3663 (FOOD) to reach your local county social services department. You'll conduct an interview by phone with your county to complete the application process. If you are approved for benefits, your county will tell you where and when to pick up the EBT card.

HOLLISTER, CALIFORNIA – November 2, 2020 – The Hollister Police Department has made an arrest of a 21-year-old suspect in connection to the downtown fires and vehicle vandalisms.

On November 2, 2020, Police and Fire personnel responded to several reports of fires in the downtown area during the early morning hours. The fires were suspicious and several calls of vehicle vandalisms involving slashed tires began to be reported.

Officers from the nightshift reviewed the downtown cameras and were able to see what looked like the same vehicle at two of the fire locations. Other officers from day shift recognized the vehicle as possibly being associated with someone they had recently come in contact with and developed possible suspect leads.

At around noon, Hollister Detective Melgoza and Torres were able to locate the possible suspect vehicle near the 200 block of San Benito Street. Surveillance of the vehicle was conducted with the assistance of
