Dear Tracey and Sharon -

As you may have heard, the FCC released its February 2013 Radio & Television EEO Audit List yesterday. Station KBGG(AM), Des Moines, Iowa, was included on the this list, however, there is some good news. The FCC pointed out in its audit announcement that certain stations may be excused if their recent license renewal application was granted, by final order, within the past 18 months. Since the KBGG renewal was granted on January 25, 2013, and the grant is final, we are preparing a formal request that asks the FCC to exclude KBGG from this

audit. We will let you know as soon as we receive a response from FCC staff, so, please stand by. Once you receive a copy of the FCC audit letter, kindly make sure to place it in your public inspection files. Thanks!
