On January 21, 2005 KTXY was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until February 1, 2013.

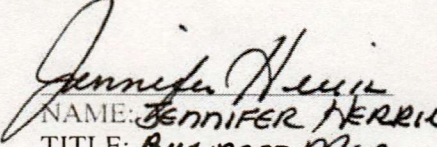
Our license will expire on February 1, 2013. We have filed an application for renewal with the FCC.
