

## Multichannel Video Program Distributors (MVPD) Notification Report KMCT-TV - WEST MONROE, LA, US

Per the Incentive Auction Task Force and Media Bureau Procedures for the Post-Incentive Auction Broadcast Transition, released on January 27, 2017, stations moving to a post auction channel must provide notice to MVPDs that carry the station and will continue to be obligated to carry the station.

Widelity was engaged to make the required notification to the relevant MVPDs that met the criteria of the rules.

MVPDs meeting the criteria were identified through the station relationships, and the FCC COALS Database. Letters were mailed to the appropriate addresses and contacts. In addition, some MVPDs who have indicated a preference for email communications were also contacted at their designated email addresses.

The letters were mailed via the US Post Office.

Letters that were returned from the US Post Office were researched individually and, where possible, addresses were corrected and the letters were resent and/or the MVPD was contacted directly.
