**ARTICLES OF INCORPORATION**  
(Domestic Nonprofit Corporation)

The undersigned natural person(s) of the age of 19 years or more, acting as incorporator(s) of a corporation under the Alaska Nonprofit Corporation Act (AS 10.20), adopt the following Articles of Incorporation:

ARTICLE I (see part 2 on instructions)

The name of the corporation is:

Talkeetna Community Radio, Inc.

ARTICLE II

The period of duration is: perpetual

ARTICLE III (see part 3 of instructions)

The purpose(s) for which this organization is organized are:

to construct and operate a nonprofit educational community radio repeater station with local access, and perhaps in the future, to operate a full service station; to provide a broad base of educational cultural and informative programming to challenge, broaden and enrich the people of Talkeetna, Trapper Creek and surrounding bush communities.

ARTICLE IV (see part 4 of instructions)

The internal affairs of the corporation shall be regulated by:

the Board of Directors as directed by current approved bylaws. In the event of termination, dissolution or winding up of this corporation in any manner or for any reason whatsoever, its remaining assets, if any, shall be distributed for one or more of the purposes set forth in section 501(c)(3) of the Internal Revenue Code, and any amendments thereto, and the rules and regulations promulgated thereunder.
