ASSIGNMENT OF LICENSE PUBLIC NOTICE INSTRUCTIONS

Hartford Stations

Applicants for assignment of license of broadcast stations must provide public notice of the filing of the application. Since WDRC(AM/FM) are NOT the only AM/FM stations licensed to Hartford, Connecticut, you have to publish in a newspaper and broadcast over the station. WMMW(AM), Meriden, CT and WSNG(AM), Torrington, CT are the only AM stations in their community of license, you will only need to broadcast over the station.

I. Notice Over-the-Air

A. Timing of Broadcast Notice

The public notice must be aired once a day on any four days between <u>January 28</u> and February 2, 2018.

These announcements must be made between 7 a.m. and 9 a.m. and/or between 4 p.m. and 6 p.m. If the station does not operate between 7 a.m. and 9 a.m. or between 4 p.m. and 6 p.m., these announcements must be made during the first two hours of broadcast operation.

B. Certificate of Compliance Confirming Broadcast

Within seven days of the last broadcast, the station should execute the attached certificate of compliance confirming that the required broadcast of the local notice has been completed. The station should specify the dates and times that the notice was given, and should attach a copy of the text of the Notice as broadcast over the station. These documents do not need to be filed with the FCC; however, they should be placed in the station's files and sent to FCC counsel.

II. Publication in a Newspaper

A. Timing of Newspaper Publication

Newspaper public notices should be run at least twice a week for two consecutive weeks in a three-week period. In this case, publication should occur twice a week for two consecutive weeks between January 28, 2018 and February 19, 2018.

B. Certificate of Compliance Confirming Newspaper Publication

Within seven days of the last newspaper publication date, the station should execute the attached certificate of compliance confirming that the required newspaper publication of the local notice has been completed. These documents do not need to be filed with the FCC; however, they should be placed in the Station's files and sent to FCC counsel.
