The Station did not insert any local advertisements or promotional matter during any of the Applicable Children's Programs that did not comply with the commercial requirements of Sections 73.670(b)-(d) of the FCC rules (e.g., commercial advertisements including characters from the Children's Program, or promoting websites using characters from the Children's Program to sell products, run during or adjacent to the program.)

**CHILDRENS' PROGRAMMING CERTIFICATION**

In addition, UniMás hereby amends the Children's Television Commercial Limits Certifications provided to its affiliates for the First and Second Quarters of 2018 to report the following information:

From November 15, 2017 through February 15, 2018, the UniMás Network aired two consecutive half-hour episodes of the animated television program *Pokémon* between 4 pm and 5 pm EST, Monday through Friday, for a total of five hours per week.

From November 15, 2017 through January 24, 2018, each one-hour block of the *Pokémon* program contained a total of 15 minutes and 45 seconds of commercial time, *i.e.*, 3 minutes and 45 seconds over the 12 minutes per hour limit on commercial time during children's television programming. The cumulative overage during these 47 days was 2 hours, 56 minutes and 15 seconds.

Commencing on January 25, 2018, and continuing through February 15, 2018, the program was reformatted to limit the total amount of non-program time to no more than 12 minutes per hour.

This certification pertains to the immediately preceding calendar quarter (October 1, 2018 – December 31, 2018).

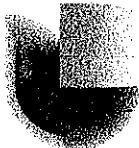

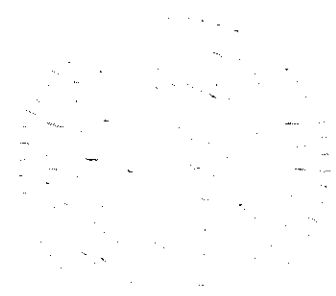
