Immigration Civic Engagement	News Brief	3-Oct-15	9:48AM	:30	A PEW center study reveals that in the past 50 years the number of immigrants and descendants of immigrants has increased dramatically in the U.S. Since the approval of the naturalization law in 1965, 59 million immigrants have entered the U.S.; that is 14% percent of the current population. The number is projected to increase from 45 million to 78 million in the year 2065, or an 88% increase of the immigrant U.S. population. Currently, 47% of the U.S. immigrant population is Hispanic, but by the year 2065 that percentage is expected to drop to 31%. In the year 2065 Asian immigrants will increase by 38% in the land of uncle Sam.

Under the Grocery Worker Retention Act, which was introduced in January by Councilman I. Daneek Miller (D-St. Albans), employees are to be kept by the new owner for 90 days. After the transition period, the new employer must evaluate each employee and consider keeping them as employees.
Immigration Quality of Life	News Brief	6-Oct-15	1:31PM	:30	The U.S. Customs and Border Protection on Monday issued a sweeping new set of standards for handling immigrant detainees, following a year of heightened criticism over agency practices. The 31-page document--the first of its kind of the parent agency of the Border Patrol--describes acceptable procedures for nearly 100 situations, and addresses the biggest pegs for recent controversy: adequate feeding, tolerable air temperature and cleanliness in detention facilities. The handling of immigrant detainees came to public attention especially through heavy media coverage of the summer 2014 surge of unaccompanied children seeking asylum in the United States. Most traveled from Central America to the Texas border, fleeing violence and poverty at home. This summer saw increased immigrant traffic at the Texas border, Gov. Greg Abbott said in September, with nearly 10,000 families or unaccompanied children caught crossing the Texas border in August.

Health	News Brief	7-Oct-15	1:31PM	:30	<p>U.S. dietary guidelines have long recommended that people steer clear of whole milk, and for decades, Americans have obeyed. Whole milk sales shrunk. It was banned from school lunch programs. Purchases of low-fat dairy climbed. Whether this massive shift in eating habits has made anyone healthier is an open question among scientists, however. In fact, research published in recent years indicates that the opposite might be true: millions might have been better off had they stuck with whole milk. Scientists who tallied diet and health records for several thousand patients over ten years found, for example, that contrary to the government advice, people who consumed more milk fat had lower incidence of heart disease. After all the decades of research, it is possible that the key lesson on fats is two-fold. Cutting saturated fat from diets, and replacing them with carbohydrates, as is often done, likely will not reduce heart disease risk. But cutting saturated fats and replacing them with unsaturated fats - the type of fats characteristic of fish, nuts, and vegetable oils - might.</p>
Health Quality of Life	News Brief	8-Oct-15	3:34AM	:30	<p>The Protecting Affordable Coverage for Employees Act seems like an unlikely Washington success story: A bipartisan health care bill passed by both chambers without a single no vote and signed by the president with no controversy or fanfare. For all the raucous debate over repealing Obamacare, such technical fixes can happen. Since the Affordable Care Act was first passed along party lines in 2010, President Obama has signed at least 14 bills making substantive changes in his signature legislation of his presidency, according to an analysis by the Congressional Research Service. Eight of those have been Republican bills. Among the most significant changes made to Obamacare thus far: The 2011 repeal of a provision requiring businesses to report to the IRS any time they made a purchase of more than \$600 to a single vendor, and the 2013 repeal of a voluntary long-term care insurance plan that the Obama administration found unworkable.</p>

Police say 3-more people were injured at Northern Arizona University in Flagstaff. They've been taken to the hospital, but their condition is unclear at this point. Police say they have the shooter in custody. The school's police chief says the suspect is an 18-year-old freshman at Northern Arizona. Delta Chi fraternity says all four victims were members of its Northern Arizona University chapter. The shooting, the fraternity said, "was not a chapter-related incident." Delta Chi says the alleged shooter was a pledge. It has suspended the chapter at Northern Arizona University as the incident is under investigation. The shooting took place just 8-days after the massacre at Umpqua Community College in Oregon that left 9-people dead.</p>

Jerry Brown (D) on Saturday signed a bill that will automatically register voters, which was sent to him by the Democratic-controlled state legislature in September. Since there are between 6 and 7 million Californians who remain unregistered to vote, voting rights advocates see the measure as a way to save money, boost security and reduce barriers to participation in elections. The state experienced record low turnout for a regularly scheduled general election last November, in which just 42 percent of Californians who were registered voted. Brown had until Oct. 11 to either sign or reject the California New Motor Voter Act.</p>

Jerry Brown. The measure by Senate leader Kevin de León (D-Los Angeles) requires law enforcement officials to certify in writing that an immigrant crime victim has been helpful in an investigation of crimes including sexual assault and domestic violence. The certifications are needed for an application for a "U-Visa" issued to prevent deportation of immigrant crime victim. The new law will help eliminate discriminatory and inconsistent law enforcement policies that prevent immigrant victims of crime from receiving the federal protections they need.</p>

Last year, a group of funders launched TheDream.US, a \$32 million project that helps children who were brought to the U.S. without immigration documents pursue college and community college degrees. Over the next decade, they hope to help 2,000 students graduate with degrees tailored to today's job market. Today, when undocumented students apply to college, they often confront seemingly insurmountable barriers. They don't qualify for federal financial aid, and college and a stable career seem out of reach.</p>

Its consumption could be highly responsible for the high levels of obesity in children and adults. Sugar consumption is very dangerous because it causes chronic diseases such as diabetes, high blood pressure and at the same time it brings a series of effects. To put it in perspective, the Worldwide Organization of Health recommends that a person consumes a maximum of 25 grams of sugar per day. An energy drink could contain up to 38 grams of sugar. This is the reason why Los Angeles county created a campaign known as "Water, the best option." Habits are developed at an early age, therefore it is important that children drink water instead of other beverages. On top of the beverages that we consume, if we add other products that contain sugar such as Ketchup, unconsciously we are adding an extra 4 grams and we are already consuming too much sugar. Miriam wishes that her children do not inherit her obesity problem. "I have a problem, so I would like to make sure that they do not go through the same obesity problem" Miriam said. Jessica has four children and says that they like how she prepares their water. "I use fruits so that water has that fruit flavor, and that is a way for them to drink water, instead of just plain water." This is something approved by doctors. "...It may be oranges, cucumbers, melon, something different from what aguas frescas are..." In other words, we do not have to add sugar. Remember that for your children, instead of sodas, water is the best option.</p>

Immigration Quality of Life	News Brief	17-Oct-15	2:38AM	:30	Texas can - for now - continue to deny issuing birth certificates to the U.S.-born children of illegal immigrants, a federal judge decided on Friday. A group of undocumented immigrants sued the state because it refused to issue birth certificates saying certain types of identification cards issued by foreign governments could not be used. The parents of the American children argued that Vital Statistics offices were refusing to accept a "matrícula", an ID card issued by Mexican consulates across the country, and a foreign passport without a U.S. visa as valid forms of IDs. Those identifications, the parents argued, are the most commonly available to illegal immigrants living in the U.S. District Judge Robert Pitman in Austin was considering whether to force the state to accept those types of IDs while the case moved through the courts. The judge said that without a doubt, Texas-born children of undocumented immigrants are being hurt by the Texas decision. Their constitutional right to travel and free exercise of religion by way of baptism are being curbed.

From 2006 to 2014, 334 bystanders were injured - one for every 10 LAPD pursuits, according to The Times' review of pursuit data reported to the California Highway Patrol. More than 300 bystanders were injured by speed chases between the years 2006 to 2014, according to an L. A. Times report. ACLU requested several years ago that LAPD discontinue the car chases and adopt other tactics, as the use of helicopters in the pursuits. LAPD officials say officers take measures to keep the public safe during chases and that many of the injuries are minor. Much of the blame, they argue, falls on the city's sprawling web of multilane thoroughfares and highways, which they say allow suspects to move at greater speeds and make wild turns through traffic, greatly increasing the likelihood that someone may be hurt. But experts who study police pursuits say the LAPD needs to do more to minimize dangers to bystanders. Unlike other departments, they say, the LAPD increases the risk of those injuries by allowing officers to chase motorists suspected of relatively minor offenses, including intoxicated or reckless driving, who are more likely to drive faster and erratically while trying to escape police.</p>

The updated guidelines recommend annual breast cancer screenings at age 45 instead of 40 and switching to every other year at age 55. The update also drops a recommendation for routine physical breast exams by doctors. However, it's not a one-size-fits-all recommendation. The advice is for women at average risk of breast cancer. Doctors generally recommend more intensive screening for higher-risk women.</p>

The aim of the guide is to help educators and school staff supports the academic success of undocumented youth, to debunk misconceptions by clarifying the legal rights of undocumented students as well as sharing helpful information about financial aid options open to undocumented students, and to support youth in applying for DACA consideration or renewal.</p>

All women should have an annual mammography screening by the age of 45. According to the new recommendations published Tuesday at the Journal of the American Medical Association (JAMA), by age 55 a mammogram every other year should be enough for women that are in good health conditions and have at least a ten year life expectancy. The ACS estimates that it is no longer necessary that all women without considering their age, should be examined to detect any lumps if there does not exist any specific risks. "In October I was sent to get a mammography and I felt something different but this decision has woken discontent and worry between breast cancer survivors that say that are still alive thanks to the early detection through a mammogram. I know several women between the ages 20 and 25. I know one that was detected with breast cancer and is very young." Arteaga is asking the American Cancer Association to require that women get these examinations at an earlier age rather than at an older age. "I would like for them to pay more attention because there are lots of women with 30 years of age."</p>

The USGS took the rare step of issuing a statement raising questions about the study, recently published in the journal Earth and Space Science and coauthored by a research scientist at NASA's Jet Propulsion Laboratory in La Cañada Flintridge. The study calculated a 99.9% probability for a magnitude 5 or larger earthquake to strike the greater Los Angeles area between April 1, 2015, and April 1, 2018. Specifically, the study's authors were looking at the chance of another significant temblor within a 60-mile radius of the 5.1 magnitude quake centered in La Habra last year.</p>

Officials from the Obama administration say that these detention centers are being used by places of short term processing; having more families in the last couple of months but for a shorter period of time. Immigrant advocates, say that the current conditions at these centers are still similar to a jail environment, with inappropriate legal and medical services even after orders made by a federal judge.</p>

Health	News Brief	26-Oct-15	12:25PM	:30	<p>A new World Health Organization study found that processed meat like bacon and hot dogs cause cancer. It is the most prominent group to declare it a cause of the disease, and the U.S. beef industry isn't happy about it. A research division of the World Health Organization announced Monday that bacon, sausage and other processed meats cause cancer and that red meat probably does, too. The report by the influential group stakes out one of the most aggressive stances against meat taken by a major health organization, and it is expected to face stiff criticism in the United States. The WHO findings were drafted by a panel of 22 international experts who reviewed decades of research on the link between red meat, processed meats and cancer. The panel reviewed animal experiments, studies of human diet and health, and cell processes that could explain how red meat might cause cancer. But the panel's decision was not unanimous, and by raising lethal concerns about a food that anchors countless American meals, it will be controversial. The \$95 billion U.S. beef industry has been preparing for months to mount a response, and some scientists, including some unaffiliated with the meat industry, have questioned whether the evidence is substantial enough to draw the strong conclusions that the WHO panel did.</p>
Safety Quality of Life	News Brief	27-Oct-15	1:30PM 5:10PM 10:30PM	:30	<p>A video going viral today shows a school resource officer at Spring Valley High School in Richland County, South Carolina aggressively pulling a student out of her desk and then dragging the student across the classroom. The video shows the uniformed deputy, identified by the Richland Co. Sheriff's Department as Ben Fields, grabbing a female student as she sits in her desk, eventually wrestling her out of the seat and throwing her across the classroom. The various videos do not show what precipitated the event, but authorities say she had been asked to leave the classroom, but refused, so the school resource officer was called in. The school district has now banned the sheriff's deputy from school grounds. ABC News can confirm that the FBI has now opened an investigation into the incident. FBI Director Comey has been outspoken that videos like the one in this case have had a chilling effect on policing, leading to an increase in crime rates.</p>
Health	News Brief	27-Oct-15	2:30PM	:30	<p>According to a study from Clear Labs, a food analytics startup, 10% of vegetarian hot dog products contain meat. Perhaps worse, the company found hygiene issues in four of its 21 vegetarian samples. It also found human DNA in 2% of its hot dog samples -- and two-thirds of the vegetarian samples. Experts say that processed meat causes cancer and that overall 14.4% of the hot dogs and sausages tested were problematic. Clear Foods is a company that translates quantifiable molecular tests into actionable food data insights, according to its website. It uses genetic sequencing to figure out just what's in your lunch; its results on hot dogs aren't always comforting. Overall, the company found nutritional label inaccuracies, pork substitution and some unexpected ingredients, including chicken and lamb.</p>

Education	News Brief	28-Oct-15	2:30PM	:30	<p>For 25 years, through four presidential administrations, U.S. schools could rely on one small truth: Math scores on the National Assessment of Educational Progress, or NAEP test, always went up. Not this year. The latest results of the biennial tests, given to thousands of students and nicknamed "The Nation's Report Card," show a first-ever drop in math scores for the randomly selected students in both fourth- and eighth-grade who took them earlier this year. U.S. Education Secretary Arne Duncan acknowledged that the news "isn't great," but said the dip "doesn't come as a big surprise." Authorities cautioned against reading too much into the development, saying that one downturn does not a trend make. The new scores, released Wednesday by the National Center for Education Statistics, show the average fourth- and eighth-grade math scores declined two and three points, respectively, between 2013 and 2015. The average eighth-grade reading score dropped three points. Fourth-grade reading scores were essentially unchanged.</p>
Immigration	News Brief	28-Oct-15	10:30PM	:30	<p>A Federal Appeals Court in California ruled that more immigration detainees should receive bail hearings and those who have been held more than a year should have additional hearings. A panel of three judges expanded the number of immigrants who can receive bond hearings after six months in detention. The panel, which covers nine states in the western United States, also said immigrants held more than a year should receive such hearings every six months in which the government will have to demonstrate why they should remain prisoners. The ruling comes after years of litigation.</p>

It is Friday afternoon, a day where downtown stores in Laredo Texas are supposed to be full of people, but reality is different. Those businesses that are still open are semi empty in contrast to those that couldn't continue and saw themselves forced to close their doors. Through this international bridge that connects the cities of Laredo and Nuevo Laredo, 2,500 vehicles and 10 thousand people cross by walking on a daily basis which helps maintain the economy of these businesses. "Without Mexico we die of hunger" said Les Norton. Les Norton, President of Laredo Merchants Association started his business 45 years ago located downtown and assures that he has never lived a crisis like this one. During 2015 Mexican peso fell in historic levels being quoted for more than 17 pesos per dollar. One of the greatest devaluations in the last 15 years. "The City Administration of Laredo recognizes that the number of visitors decreases each month in comparison to previous years and estimate that future visitors will look after their money" said the economist Alejandro Velez. "Tomorrow we will present stories of employees that are about to lose their jobs and Mexicans that little by little are no longer crossing the border for shopping" said the Tourism Director of Laredo Texas, Blacita Lopez.</p>

The border patrol explains how the new rules will be implemented when dealing with the more than 500,000 undocumented immigrants detained at the U.S. border. This manual comes as a result of complaints by former detainees who speak about extremely cold cells, lax medication, food, and long hours in transports. The new manual will be given to more than 23,000 agents along the Mexico/U.S. border.</p>
Safety Quality of Life	News Brief	29-Oct-15	10:23PM	:30	<p>About 6,000 drug offenders will be released from federal custody over the next few days, but some legal experts warn that the government has done too little to help many of them successfully reintegrate into society. The prisoners will be released from federal Bureau of Prisons custody on Friday and Monday as a result of a U.S. Sentencing Commission decision last year to cut sentences of drug offenders by an average of two years. The vast majority have spent only a short time in a halfway house -- not the six months to a year normally required for drug offenses -- before being transferred to the much looser restrictions of home confinement. Of the prisoners being released, 1,764 are not U.S. citizens. They will be turned over to Immigration and Customs Enforcement, and most of them will be deported. Nearly 80% of the rest -- or about 3,400 -- already have moved to the Bureau of Prisons' halfway houses or were confined at home, but will be released from custody by Tuesday, according to the Justice Department. The remaining 850 or so will be released directly from prison to a probation officer.</p>

Specifically, Liévanos' work indicates that, in metropolitan areas from Los Angeles to New York City, economically disadvantaged, Latino immigrant neighborhoods have a one-in-three chance of being located in areas with high levels of harmful air pollution. Hazardous air pollutants can cause cancer or other serious reproductive and birth defects. Most originate from automobiles and industrial sources like factories, refineries and power plants. Liévanos used geographic information system and spatial analyses to create a nationwide map of toxic air hotspots, areas where harmful emissions from stationary and mobile sources of pollution are the strongest. His results show the vast majority of hotspots are located in the Northeast and California. The closest hotspot to Pullman is in the Portland, Ore.-Vancouver, Wash., area. In many ways the study illuminates the consequences of segregated housing developments in the United States. In the 1930s, '40 and '50s, many communities across the country were developed in such a way that environmental hazards were located near non-white, foreign born, low-income neighborhoods.

The legislation called for the NSA to cease collection of bulk phone records, which includes metadata like phone numbers and the duration of calls. Congress provided six months for the surveillance agency to transition its systems, and now the deadline is up. Phone companies like Verizon and AT&T will now hold onto that data, and the NSA will have to apply for permission from a special court to obtain those records on a case-by-case basis. The law also increases transparency - the government will need to provide annual records revealing how many requests for data it makes. Agency will now need to petition a special court for phone records. The end of bulk phone metadata collection by the NSA comes two and a half years after security contractor Edward Snowden revealed the agency's massive surveillance programs. While many, including President Obama, hailed passage of the USA Freedom Act as the first major step towards limiting surveillance powers since the attacks of September 11th, 2001, others noted that the law did not go far enough. The bill passed in the Senate by a 67 to 32 vote, with at least four opponents voting against the legislation specifically because it did not do enough to limit the NSA. In the aftermath of the attacks in Paris earlier this month, some proponents of the NSA's surveillance programs have sought to give the agency back its power to collect metadata from Americans' phone records. Those supporters include Republican presidential candidates Marco Rubio, Donald Trump, and Chris Christie. No change is likely in the short term, though the NSA has requested to hold on to its existing metadata through the winter to help it ensure that the new program is performing adequately.

If a door has a mechanical arm, use a belt to secure it and keep it from being opened. Turn off computers, television sets, lamps, and limit cell phone use to a minimum so the screen cannot aid in locating you. Finally, hide behind doors, walls or furniture that can also serve as protection from bullets. Should one have to confront a shooter, be aggressive to protect your life, use a fire extinguisher to neutralize the aggressor; find scissors, paper weights and hard items that can help you injure an assailant. The San Jose Mercury News reports Santa Clara County officials are trying to track down 350 babies and their parents who may have been exposed to a nurse with tuberculosis at Valley Medical Center's mother and infant care center. The medical center's head of pediatrics Dr. Stephen Harris said Friday that those who came into contact with the nurse will have to undergo testing for the potentially deadly disease. He says that as a precaution all 350 infants born between August and November will have to undergo antibiotic treatment even if they don't test positive for the disease. Tuberculosis is a bacterial infection that usually strikes the lungs, spreading through coughs and sneezes.

If you miss the Jan. 31 deadline too, you won't be able to get insurance at all in 2016, unless you have a big life change like losing your job, getting married or having a baby. And the Obama administration says the deadline will not be extended this year, as it has in the past. Go without health insurance in 2016, and you'll pay a huge tax in 2017. The average tax penalty is expected to reach almost \$1,000 next year. The penalty could be even higher depending on your income and family size.

Fed officials feel a tad more optimistic about the U.S. economy in 2016, a vote of confidence that the rate hike won't disrupt growth. They increased their median projection for economic growth next year to 2.4 percent, up from 2.3 percent in their prior September projections. Fed officials also anticipate slightly less inflation and slightly lower unemployment in 2016 compared to their prior estimates. The agency said under the proposal sunbed users would be required to sign a form saying they are aware of and that they understand the risks of using the devices before their first visit, and again every six months afterward. Tanning bed injuries account for more than 3,000 emergency room visits each year in the US, and the agency said it estimated that around 1.6 million minors use the indoor tanning facilities per year.</p>

The nationwide campaign, to be carried out by U.S. Immigration and Customs Enforcement (ICE) agents as soon as early January, would be the first large-scale effort to deport families who have fled violence in Central America, those familiar with the plan said. More than 100,000 families with both adults and children have made the journey across the southwest border since last year, though this migration has largely been overshadowed by a related surge of unaccompanied minors. The ICE operation would target only adults and children who have already been ordered removed from the United States by an immigration judge, according to officials familiar with the undertaking, who spoke on the condition of anonymity because planning is ongoing and the operation has not been given final approval by DHS. The adults and children would be detained wherever they can be found and immediately deported. The number targeted is expected to be in the hundreds and possibly greater. The proposed deportations have been controversial inside the Obama administration, which has been discussing them for several months. DHS Secretary Jeh Johnson has been pushing for the moves, according to those with knowledge of the debate, in part because of a new spike in the number of illegal immigrants in recent months. Experts say that the violence that was a key factor in driving people to flee Central America last year has surged again, with the homicide rate in El Salvador reaching its highest level in a generation. A drought in the region has also prompted departures. Advocates have not been briefed on the plans and on Wednesday expressed concern. They cited what they called flaws and abuses in the government's treatment and legal processing of the families, many of whom are fleeing danger or persecution in El Salvador, Guatemala and Honduras.</p>

The issue of migrant families crossing the border since last year has been particularly tricky. Though the former secretary of state has endorsed liberal immigration policies, Hillary Clinton drew criticism in 2014 when she said unaccompanied migrant children - coming here primarily from El Salvador, Guatemala and Honduras - "should be sent back" to their home countries. According to gun industry insiders and others familiar with the proposals, the changes include requiring an expanded number of small-scale gun sellers to be licensed - and therefore conduct background checks - whenever selling a weapon. This wouldn't close the so-called gun show loophole, though it has the potential to narrow it. The administration is also expected to impose tighter rules for reporting guns that get lost or stolen on their way to a buyer. Neither comes close to the stronger gun control measures Obama sought in the wake of the 2012 mass shooting of schoolchildren in Sandy Hook and that he has said he still wants. But with Congress unlikely to approve any new gun curbs before the 2016 election, the measures are in line with what gun-control advocates were hoping would be adopted before Obama leaves office.</p>
