Governor Mike Parson issued an Executive Order today pushing pack the date of the elections from April 7 to June 2 due to concerns with the CoronaVirus Outbreak.

The order states that any person who is registered and turning 18 prior to April 7 will be allowed to cast a ballot in the June Election. The order also states that Ballots already printed for the April Election will be allowed to be used in June.

Taney County Clerk Donna Neely states in an e-mail to area media that Absentee Ballots that have already been cast for the election will be kept the Vault in the Clerk's Office until the new Election Day.

Branson Board of Alderman Vote to Restrict All Non-Essential Business

Branson's Board of Aldermen met in emergency session Monday night and passed a bill restricting non-essential business operations in the city to help reduce the spread of the Coronavirus. Officials deliberated for over three hours, hearing public comments and making numerous revisions to the order. The new rules take effect at 8:00 a.m. this morning.

Some of the provisions in the bill include limiting public gatherings to no more than 10 people, requiring social distancing of 6 feet, and limiting visitation at nursing homes and long-term care facilities. It also prohibits on premises eating and drinking at any restaurant or business open to the public.
