

Attached are the aired broadcast affidavits for the post-filing announcements as required under 47 CFR Section 73.3580 by the FCC for KQSE-FM (Facility ID: 86173).

As of December 1st, 2020, the FCC License Renewal web page (<https://www.fcc.gov/media/radio/broadcast-radio-license-renewal>) indicated that announcements were to be made the 1st and 16th of each month following the submission of the renewal of licence application with these specifications:

**Make Post-Filing On-Air Announcements on the 1st and 16th Day of December, January, & February**

- a. At least three of the required announcements between 7 AM to 9 AM and/or 4 PM to 6 PM.**
- b. At least one announcement between 9 AM to noon.**
- c. At least one announcement between noon to 4 PM.**
- d. At least one announcement between 7 PM to midnight.**

We noticed upon visiting the FCC Renewal web page that it was updated on Wednesday, February 10, 2021 with the removal of the above specifications and replaced with:

- a. A total of six (6) announcements in the four weeks following acceptance of the renewal application for filing.**
- b. No more than two announcements per week.**
- c. No more than one announcement per day.**
- d. Announcements to be made at any time between 7 AM and 11 PM local time, Monday through Friday.**
